Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of Sentinel Real Estate 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering eligible employees of Sentinel Real Estate Corporation (the “Company”). Employees are not eligible to participate in the Plan if they are a nonresident alien or employees covered by a collective bargaining agreement, unless the agreement requires the employees to be included in the Plan. Employees of the employer are immediately eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 25% of their annual compensation, as defined in the Plan document, subject to certain Internal Revenue Code (“IRC”) limitations, and may designate such contributions as pre-tax or after-tax (Roth) contributions. Also, participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company contributes the lesser of 25% or \$1,000 of a participant’s annual contribution to the Plan. Additional qualified non-elective contributions may be made at the Company’s discretion. Contributions are subject to certain limitations as described in the Plan document. Certain plan participants may elect to make “catch-up contributions” as defined under the IRC. The Plan is required to return excess contributions received during the Plan year in excess of IRC limits.

Effective March 15, 2023, the Plan includes an auto enrollment provision whereby all employees are automatically enrolled in the Plan 35 days from their hire date, unless they affirmatively elect not to participate, with a default rate set at 3% of their eligible compensation. The amount will be contributed on a pre-tax basis.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings (losses). Allocations are based on a participant’s earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of the Plan (*continued*)

Vesting

Participants are immediately vested in their contributions, including rollovers, plus earnings thereon. Vesting in the Company's contributions are based on years of continuing service as follows:

2 years	20%
3 years	40%
4 years	60%
5 or more years	100%

Notes Receivable from Participants

The Plan allows participants to borrow money from their account balances and repay the loans through payroll deductions. Only one loan may be outstanding at any given time. The minimum loan amount is \$1,000 and the maximum loan amount may not exceed the lesser of (a) one half of the participant's vested interest in the Plan or (b) \$50,000 reduced by the excess, if any, of the highest outstanding loan balance from the Plan during the one-year period ending on the day before the new loan is to be made over the current outstanding balance of loans as of the date of the new loan. The loans are secured by the balance in the participant's account and bear interest at a rate that is one percentage point above the prime rate. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest or installment payments either monthly, quarterly, semi-annually, or annually. Participants whose account balances are \$5,000 or less may receive a lump sum payment or have their account balance rolled over to an Individual Retirement Account. Participants may withdraw funds from their accounts who have demonstrated hardship (as defined under Internal Revenue Service Regulations).

Forfeitures

Forfeitures of the non-vested portion of terminated participants' accounts are maintained in a separate account and may be used to pay administrative expenses or to reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$45,088 and \$28,357. During the year ended December 31, 2024, employer contributions were reduced by \$15,224 and \$6,000 of Plan expenses were paid from forfeiture accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, the Plan's investments excluding Common/Collective Trust, were valued using level 1 inputs.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. The self-directed brokerage accounts are invested in cash, common stocks and mutual funds, and are deemed to be actively traded. The common/collective trusts are valued at the NAV, as provided by the custodian, which is used as a practical expedient for fair value based on the fund's underlying investments. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Administrative expenses of the Plan are paid by the Plan as provided in the Plan document. Expenses relating to specific participant transactions (i.e. loan set up, distributions, etc.) are charged directly against the appropriate participant's account.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 13, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

5. Common/Collective Trust

Participants have the option to invest in the Managed Income Portfolio Class 2 (the "Fund"), which is a common/collective trust. The Fund invests all or some of its assets in fixed income securities, enters into wrap contracts issued by third parties and invests in cash equivalents represented by shares in money market funds. Managed Income Portfolio is a collective trust fund, sponsored by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee and manager of the Fund.

The investment objectives of the Fund is to seek the preservation of capital and provide a level of income over time that is consistent with the preservation of capital. The Fund records security transactions on a trade date basis. Investment income is accrued as earned. Redemptions by participating plans occur at net asset value following the 12-month notice period.

Fund units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the Fund. There are no unfunded commitments as of December 31, 2024 and 2023 for the Fund.

6. Tax Status

The prototype plan document preparer received an IRS Opinion Letter dated June 30, 2020. The Internal Revenue Service has determined and informed the prototype document that the Plan is designed in accordance with applicable sections of the Code. The Plan has been amended since the letter was issued by the IRS, however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Company may at any time terminate the Plan and discontinue all contributions, subject to the applicable provisions of ERISA. In the event the Plan is terminated, all participants shall become fully vested in their account balances.

8. Party-in-Interest Transactions

Certain investments of the Plan are managed by Fidelity Investments Institutional Operations Company, Inc., an affiliate of the Plan's trustee and therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
