December 31, 2024 and 2023

1. Plan Description

The following description of the Oxford Construction Company 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on September 1, 1998, as a defined contribution plan covering substantially all employees of Oxford Construction Company (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by an administrative committee appointed by the Company's management board. The Company absorbs all significant costs of administering the Plan. J. Bruce Melton serves as trustee of the Plan.

Eligibility

An employee becomes eligible to participate in the Plan on January 1 or July 1 following completion of the age and service requirements. To become a participant, an employee must complete one year of service and attain age 21.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts as investment options for participants.

For participants who are 21 years old and have completed one year of service, the Plan provides a safe harbor matching contribution equal to 100% of each participant's deferrals up to 4%. The Company may also make an additional discretionary profit sharing contribution to the Plan which shall be determined each Plan year by the Board of Directors. No discretionary contribution was made for 2024 or 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and participant earnings, as well as allocations of the Company's profit sharing contributions and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Plan Description, Continued

Vesting

Participants are vested immediately in all contributions plus actual earnings (losses) thereon.

Payment of Benefits

Upon termination of employment, death, disability or normal retirement, a participant becomes entitled to receive the vested portion of his account balance in accordance with the provisions of the Plan. Hardship withdrawals are permitted under certain circumstances and are subject to the 10% early withdrawal penalty required by the Internal Revenue Service.

Participants entitled to benefits greater than or equal to \$1,000 may elect to receive payment of their benefits in the form of a lump-sum payment or by any other payment option provided for in the Plan. Distributions of accounts less than \$1,000 are paid out in lump sum.

Forfeitures

If a participant forfeits from his Profit Sharing Contribution Account, the Administrative Committee will treat the forfeited amount as an additional profit sharing contribution otherwise made for the Plan year. If a participant forfeits from his Matching Contribution Account, the Administrative Committee will treat the forfeited amount as a reduction of the matching contributions otherwise made for the Plan year.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Plan Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain other expenses are charged directly to the participant's account and included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated events through October 6, 2025, the date the financial statements were available to be issued.

3. Information Certified by Custodian

For 2024 and 2023, the Plan administrator elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the amounts certified by John Hancock Life Insurance Company (John Hancock) for investments as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, except for agreeing or deriving such information certified as complete and accurate by John Hancock, to information included in the Plan's financial statements and supplemental schedule.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- *Pooled separate account.* Valued at unit value calculated based on the observable net asset value (NAV) of the underlying investments. See Note 5 for additional information for assets valued at NAV.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The pooled separate account (PSA) is a segregated investment account, meaning that its assets may not be charged with liabilities resulting from any other business that may be conducted. Income, gains and losses, whether realized or not, from assets allocated to the PSA are, in accordance with the applicable annuity contracts, credited to or charged against the PSA. It is credited or charged without regard to any other income, gains or losses of the issuing entity. The PSA satisfies the definition of a separate account under the federal securities laws. The participants determine the allocation of their funds in various subaccounts, which offer a wide array of investment strategies.

5. Investments at Net Asset Value, Continued

The equity fund subaccounts include mutual funds that invest in small-sized, mid-sized, and large company stocks, the objective of which is to achieve long-term growth of capital.

The fixed income fund subaccounts include mutual funds that invest in bonds and other debt instruments and global securities with the objective of providing long-term growth of capital while providing current income.

The index fund subaccounts include mutual funds that seek to achieve the approximate aggregate total return of U.S. domestic equity market indexes.

The stable value fund seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

The target date subaccounts are composed of passively managed funds that seek to retain potential for growth and aim to preserve the value of assets at and after retirement.

6. Related Party Transactions and Party-In-Interest Transactions

CBIZ Benefits & Insurance Services, Inc. provides to the Plan certain accounting and administrative services for which fees are paid by the Plan sponsor.

Plan investments are managed by John Hancock. John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. In its role as custodian, John Hancock, among other responsibilities, provides all administrative services necessary to support the investments held by the Plan.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to third-party administrators which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

8. Tax Status

The IRS has determined and informed the Plan by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the relevant taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to possible examinations by the taxing authorities. For federal income tax purposes, the tax returns essentially remain open for possible examination for a period of three years after the respective filing deadlines of those returns.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Reconciliation of Financial Statements to Form 5500

The Plan holds investments through PSAs, as classified in the financial statements included herein. The PSAs do not file a Form 5500, therefore, the underlying assets have been reported on the Form 5500, Schedule H.
