NOTE 1: DESCRIPTION OF PLAN

The following description of the Southern New Jersey Perinatal Cooperative (SNJPC) 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A) General

The Plan is a participant-directed, defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan currently offers participants a diverse group of investment fund options from Cuna Mutual Group, the Plan's custodian. The investment selections are made by the participants.

B) Eligibility

In order to be eligible for employer contributions, employees must have completed 1 year of service. One year of service is completed on the last day of the Eligibility Computation Period in which the employee is credited with 1,000 hours of Service. The Eligibility Computation Period is the 12-month period that begins with the date the employee was hired. Thereafter the Eligibility Computation Period becomes the Plan Year and begins the first day of the Plan Year that began in the initial Eligibility Computation Period. Each subsequent period is the Plan Year.

Plan employees are eligible to enroll in the salary reduction portion of the Plan as soon as they begin employment at SNJPC.

C) Entry Dates

For the purposes of the employer contribution, an employee's first entry date will be the first day of the month coincident with or next following the date on which the employee has satisfied the Plan's Minimum Eligibility Requirements.

For the purpose of salary deferral contributions an employee will enter the Plan immediately following employment with SNJPC.

D) Contributions – Employee

The amount participants can contribute to the plan is subject to an annual limit of the lesser of 60% of eligible compensation or \$22,500 and \$20,500 in 2024 and 2023, respectively, for participants under age 50 or \$30,000 and \$28,000 in 2024 and 2023, respectively, for participants age 50 or older.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. These distributions are classified as rollover contributions in the financial statements.

E) Contributions – Employer

For the 2024 and 2023 plan years, SNJPC made contributions to all eligible participants equal to 4% of compensation. The amounts contributed to eligible employee accounts in 2024 and 2023 were \$390,268 and \$287,963, respectively.

F) Funding

Employee contributions are funded through bi-weekly payroll deductions. Employer contributions are made on a bi-weekly basis.

G) Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) SNJPC's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

H) Vesting

Participants are fully vested in their contributions, employer contributions and earnings or losses thereon.

I) Payment of Benefits

Distributions of vested benefits normally are made upon a participant's retirement, death or permanent disability. Distribution of vested benefits may be made to terminated employees prior to the date such amounts would normally be distributed (retirement, death or permanent disability); however, such earlier distribution is at the election of the terminated employee. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payments are made as a lump sum distribution.

J) Termination

Although it has not expressed any intent to do so, SNJPC has reserved the right to terminate the Plan subject to ERISA, to reduce or cease contributions at the discretion of the SNJPC Board of Directors, or to amend the Plan at any time and in any respect. Upon termination of the Plan, all participants would become fully vested in their SNJPC employer contributions. However, no such action may deprive any participant or beneficiary under the Plan of any vested right or cause any part of the Plan's assets to be reverted to SNJPC.

K) Notes Receivable from Participants

Participants in the Plan are eligible to borrow monies from their vested Plan account if they are currently employees of SNJPC and have a vested benefit under the Plan.

The maximum amount of any loan to a participant is the lesser of:

- a. \$50,000, reduced in accordance with the Plan provisions; or
- b. 50% of the vested interest of the participant in the Plan.

The minimum principal amount is \$1,000 and the repayment period cannot be more than five years.

The interest rate for participant loans is the prime rate plus one percent at the time of granting of the loan.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A) Basis of Presentation

The accompanying financial statements of Southern New Jersey Perinatal Cooperative 401(k) Profit Sharing Plan (the Plan) have been prepared on an accrual basis and present the net assets available for benefits and changes in those net assets.

B) Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C) Administrative Expenses

Substantially all expenses of maintaining the Plan are paid by the plan sponsor, Southern New Jersey Perinatal Cooperative (SNJPC). All trustee, transaction and investment fund fees are paid by the Plan. For the years ended December 31, 2024 and 2023, administrative expenses paid by the Plan were \$34,751 and \$29,495, respectively.

D) Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

D) Valuation of Investments and Income Recognition (Continued)

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

E) Payment of Benefits

Benefits are recorded when paid.

F) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

G) Risks and Uncertainties

The assets of the Plan are primarily financial instruments, which are monetary in nature. As a result, interest rates have a more significant impact on the Plan's performance than the effects of general levels of inflation. Interest rates do not necessarily move in the same direction or in the same magnitude as the prices of goods and services as measured by the consumer price index. Investments are subject to risk conditions of the individual fund objectives, stock markets and bond markets, interest rates, credit risk, economic conditions and world affairs. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net asset available for benefits.

H) Related-Party Transactions

All Plan investments are managed by Matrix Trust Company and CMFG Life Insurance Company. They both are custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Other related parties include Southern New Jersey Perinatal Cooperative, the plan sponsor, and Zelenkofske Axelrod, LLC, the plan auditor.

NOTE 3: TAX STATUS

The Plan has adopted the provisions of the TruStage – Volume Submitter Profit Sharing Plan with CODA. The Prototype Plan has received an IRS determination letter dated March 31, 2008, indicating acceptance of the prototype document. The Plan administrator believes that the Plan has been designed and is currently being operated in compliance with the applicable sections of the Internal Revenue Code (IRC), and there under exempt from payment of federal income taxes under provisions of Section 401(a) of the IRC. The Plan has only elected options that are permitted under the terms of the approved Plan Document.

U.S. GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4: CERTIFIED FINANCIAL INFORMATION

Certain information related to investments disclosed in the accompanying financial statements, including investments and dividends at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company and CMFG Life Insurance Company (the trustee/custodian) of the Plan.

The following information certified by Matrix Trust Company and CMFG Life Insurance Company was relied upon in the preparation of the 2024 and 2023 financial statements:

- Investment amounts included in the Statement of Net Assets Available for Benefits at December 31, 2024 and 2023.
- Interest and dividend income and net appreciation/(depreciation) in fair value of investments included in the Statement of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.

NOTE 5: INVESTMENTS

During 2024 and 2023 the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year (depreciated)/appreciated in value by \$920,473 and \$1,100,824 in 2024 and 2023, respectively.

NOTE 6: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Transfers between the levels of the fair value hierarchy are deemed to have occurred and timely recognized by the end of the reporting period.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value of shares held by the plan at year end. The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7: GUARANTEED INVESTMENT CONTRACT WITH CMFG LIFE INSURANCE COMPANY

The Plan entered into a benefit-responsive guaranteed investment contract with CMFG Life Insurance Company totaling \$191,969 for 2024 and \$60,601 for 2023. CMFG maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value which for the Plan approximates fair value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by CMFG, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 8: SUBSEQUENT EVENTS

The Plan has evaluated all subsequent events for the year ended December 31, 2024 to the date of the report issue date of October 13, 2025. No events have taken place that effect the financial statement or require disclosure. The report is available to be issued as of October 13, 2025.
