## **Report of Independent Auditors'**

**To the Board of Trustees

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The Kokosing Construction Company, Inc. Union 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets as of December 31, 2024 and 2023, and the related statements of changes in net assets for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Kokosing Construction Company, Inc. Union 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Notes to Financial Statements**

**Note 1. Description of Plan**

The following description of the Kokosing Construction Company, Inc. (Company) Union 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, available at the office of the Company, for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering union employees of the Company who have completed one thousand hours of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants are able to contribute to the Plan during each plan year a percentage of their compensation, not to exceed \$23,000 and \$22,500 (\$30,500 and \$30,000 for employees age 50 or older) for the years ended December 31, 2024 and 2023, respectively. Each year, the Company may make discretionary contributions to the plan uniformly applied to all participants. The plan may also make discretionary matching contributions based upon each employees pay and elective deferral contributions. The annual compensation taken into account for each participant shall not exceed \$345,000 with a maximum allowable total contribution of the lesser of \$69,000 or 100% of participants' compensation. These amounts are scheduled to be adjusted annually to reflect changes in the cost of living.

**Participant Accounts**

Any earnings or losses of the Trust Fund are allocated in the same proportion that each participant's and former participant's nonsegregated accounts bear to the total of all participants' nonsegregated accounts as of such date.

**Vesting**

Participants are immediately vested in their elective contributions plus actual earnings thereon.

**Payment of Benefits**

Upon termination of service due to death, disability, or retirement of a participant, all amounts credited to that participant's account become distributable. Participants may elect to receive either a lump-sum amount or installments for a specified period of time. For termination of service due to other reasons, a participant may receive the value of the vested portion of his or her account as a lump-sum distribution.

**Participant Loans**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the vested portion of their account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%, which are reasonable rates commensurate with current interest rates charged for loans under similar circumstances. Principal and interest is paid ratably through payroll deductions. Loans are accounted for at cost, which approximates market value.

**Investments**

The Plan investments are held in a trust fund by Charles Schwab Bank. The Plan provides for participant directed investments up to the extent of allocated account balances. Fair market values of investments as determined by the Custodian are presented in Note 3.

**Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accounting records of the Plan are maintained on the accrual basis.

**Benefit Payments**

Benefits related to terminations are recorded when paid. Corrective distributions, if required, are accrued as of the end of the plan year.

**Transfers**

As participants move from union status to non-union within the plan sponsor, funds are transferred between the Plan and the 401(k) plan established for the benefit of non-union employees.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

Administrative expenses charged by Charles Schwab Bank for providing certain accounting and investment services are paid by the Plan. The Company also provides administrative services related to the operation of the Plan.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities; disclosure of contingent assets and liabilities at the date of the financial statements; and, the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Note 4. Fair Value Measurements**

**Mutual funds:** Valued at quoted market prices of shares held by the plan at year end.

**Collective trusts:** Valued at the new asset value ("NAV") of shares held by the plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 6. Tax Status**

The IRS has determined and informed the Company by a letter dated June 19, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Investment Contract with Insurance Company**

The plan participates in a fully benefit-responsive guaranteed investment contract with The Bank of New York Mellon ("Mellon"). Mellon maintains the contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan, which may not be less than 0%. Contract value, as reported to the Plan by Mellon, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The Plan sponsor does not believe that any events may limit the ability of the plan to transact at contract value that are probable as of December 31, 2024, or the date of these financials are issued.

**Note 8. Funds of the Plan**

The allocation of participant funds among the investment options is made at the election of the participants. Investments held in the various funds are reflected at fair value, approximate the net assets available for benefits of those funds.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 10. Subsequent Events**

Events subsequent to December 31, 2024 have been evaluated through October 2, 2024, the date these financial statements were available to be issued, to determine whether additional disclosures should be made to keep the financial statements from being misleading. Management found no subsequent events that should be disclosed.

Union 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

**Notes to Financial Statements**

**Note 1. Description of Plan**

The following description of the Kokosing Construction Company, Inc. (Company) Union 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, available at the office of the Company, for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering union employees of the Company who have completed one thousand hours of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants are able to contribute to the Plan during each plan year a percentage of their compensation, not to exceed \$23,000 and \$22,500 (\$30,500 and \$30,000 for employees age 50 or older) for the years ended December 31, 2024 and 2023, respectively. Each year, the Company may make discretionary contributions to the plan uniformly applied to all participants. The plan may also make discretionary matching contributions based upon each employees pay and elective deferral contributions. The annual compensation taken into account for each participant shall not exceed \$345,000 with a maximum allowable total contribution of the lesser of \$69,000 or 100% of participants' compensation. These amounts are scheduled to be adjusted annually to reflect changes in the cost of living.

**Participant Accounts**

Any earnings or losses of the Trust Fund are allocated in the same proportion that each participant's and former participant's nonsegregated accounts bear to the total of all participants' nonsegregated accounts as of such date.

**Vesting**

Participants are immediately vested in their elective contributions plus actual earnings thereon.

**Payment of Benefits**

Upon termination of service due to death, disability, or retirement of a participant, all amounts credited to that participant's account become distributable. Participants may elect to receive either a lump-sum amount or installments for a specified period of time. For termination of service due to other reasons, a participant may receive the value of the vested portion of his or her account as a lump-sum distribution.

**Participant Loans**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the vested portion of their account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%, which are reasonable rates commensurate with current interest rates charged for loans under similar circumstances. Principal and interest is paid ratably through payroll deductions. Loans are accounted for at cost, which approximates market value.

**Investments**

The Plan investments are held in a trust fund by Charles Schwab Bank. The Plan provides for participant directed investments up to the extent of allocated account balances. Fair market values of investments as determined by the Custodian are presented in Note 3.

**Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accounting records of the Plan are maintained on the accrual basis.

**Benefit Payments**

Benefits related to terminations are recorded when paid. Corrective distributions, if required, are accrued as of the end of the plan year.

**Transfers**

As participants move from union status to non-union within the plan sponsor, funds are transferred between the Plan and the 401(k) plan established for the benefit of non-union employees.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

Administrative expenses charged by Charles Schwab Bank for providing certain accounting and investment services are paid by the Plan. The Company also provides administrative services related to the operation of the Plan.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities; disclosure of contingent assets and liabilities at the date of the financial statements; and, the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Note 3. Information Certified By Trustee**

The following table is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements, which was prepared by the Custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certification from the Custodian that such information is complete and accurate:

**Note 4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

<b>Level 1</b>	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
<b>Level 2</b>	Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
<b>Level 3</b>	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at quoted market prices of shares held by the plan at year end.

**Collective trusts:** Valued at the new asset value ("NAV") of shares held by the plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 6. Tax Status**

The IRS has determined and informed the Company by a letter dated June 19, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Investment Contract with Insurance Company**

The plan participates in a fully benefit-responsive guaranteed investment contract with The Bank of New York Mellon ("Mellon"). Mellon maintains the contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan, which may not be less than 0%. Contract value, as reported to the Plan by Mellon, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The Plan sponsor does not believe that any events may limit the ability of the plan to transact at contract value that are probable as of December 31, 2024, or the date of these financials are issued.

**Note 8. Funds of the Plan**

The allocation of participant funds among the investment options is made at the election of the participants. Investments held in the various funds are reflected at fair value, approximate the net assets available for benefits of those funds.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 10. Subsequent Events**

Events subsequent to December 31, 2024 have been evaluated through October 2, 2024, the date these financial statements were available to be issued, to determine whether additional disclosures should be made to keep the financial statements from being misleading. Management found no subsequent events that should be disclosed.
