Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audit of the accompanying financial statements of the 403(b) Thrift Plan for Employees of the Jewish Home of Eastern Pennsylvania, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 403(b) Thrift Plan for Employees of the Jewish Home of Eastern Pennsylvania's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3, 4 and 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Opinion (Continued)

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified insurance carrier agrees to, or is derived from, in all material respects, the information prepared and certified by an insurance carrier that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the 403(b) Thrift Plan for Employees of the Jewish Home of Eastern Pennsylvania and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the 403(b) Thrift Plan for Employees of the Jewish Home of Eastern Pennsylvania's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

Note 1 Description of the Plan

Effective January 1, 1976, The Jewish Home of Eastern Pennsylvania ("Sponsor"), a non-profit corporation organized and existing under the laws of the Commonwealth of Pennsylvania, adopted a retirement plan known as the Tax Deferred Annuity Plan for Employees of Jewish Home of Eastern Pennsylvania ("Plan"). The Sponsor is the administrator of the Plan and determines the appropriateness of its Plan's investment offering, monitors investment performance and reviews with the Plan's insurance company. The Plan was amended and restated effective January 1, 2009 to comply with new IRS regulations pertaining to Code Section 403(b) Tax Deferred Annuity Plans. On January 1, 2017, the Plan as amended was renamed 403(b) Thrift Plan for Employees of the Jewish Home of Eastern Pennsylvania. The Plan is a defined contribution plan under section 403(b) of the Internal Revenue Code which covers substantially all employees and provides for retirement, disability, and death benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2020, the Plan was amended and restated to adopt a new "prototype" Plan document. This new plan document incorporates all prior amendments and changes required by prior legislation, including the Final 403(b) Regulations and the Pension Protection Act of 2006 (including the final Internal Revenue Code (IRC) Section 415 regulations), as well as changes required by legislation relating to the Heroes Earnings Assistance and Relief Tax Act of 2008 and the Worker, Retiree, and Employer Recovery Act of 2008.

In December 2022, Securing a Strong Retirement Act (Secure 2.0) was passed into law. For Plan years beginning January 1, 2023, the Plan is operating in accordance with the provision. Secure 2.0 included both mandatory and optional provisions; the Plan Administrator will determine the optional provisions to elect.

The Plan provides that a participant may elect to defer a specific percentage of their annual compensation not to exceed \$23,000; \$30,500 for participants ages 50 or older, adjusted annually for cost-of-living changes. In addition, participants under a 403(b) Plan are eligible for a special catch-up contribution. To be eligible the participant must have completed 15 years of service with the Sponsor. Special catch-up contributions are calculated upon request. Participants may also contribute amounts representing distribution from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The sponsor contributes a match equal to 25% of the participants deferred contribution that does not exceed 4% of the participant's compensation. Each participant's account is credited with the participant's contribution, employer matching contribution, Plan earnings (losses), and charged with an allocation of applicable administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as applicable and defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 Description of the Plan (Continued)

Participants may borrow amounts from Mutual of America Life Insurance Company (MALIC) using assets of the Plan as collateral for the loans. General guidelines are that the minimum loan amount be \$1,000, while the maximum is equal to the lesser of \$50,000 or 50% of their vested account balance. The loans do not reduce the balance of participants' accounts unless the loan is in default at the time when the benefits are distributable. The Plan requires the participant to maintain at least 120% of the loan as collateral within the Interest Accumulation Account. The loans bear interest equal to the greater of the credited interest account rate plus 1% or the Moody's Corporate yield average published by Moody's Investor Service, for the month ending two months prior to the date on which the rate is determined. Principal and interest is paid directly to MALIC.

As of December 31, 2024 and 2023, outstanding group annuity loans totaled \$6,839 and \$10,231, respectively. The funds are not deducted from the participant's account balance and, therefore, are not reported in the Statement of Net Assets Available for Plan Benefits.

Forfeitures of a non-vested accounts was \$648 and \$425 for years ended December 31, 2024 and 2023, respectively. These forfeitures are used to reduce Plan expenses and reduce Employer's Contributions to the Plan. \$0 and \$425 was used in 2024 and 2023, respectively, to reduce Employer Contributions. At December 31, 2024 and 2023, forfeited non-vested account balances were \$648 and \$0, respectively.

A more detailed explanation of the Plan, including but not limited to eligibility, vesting, loan, and benefit provisions, is provided in the 403(b) Thrift Plan for Employees of the Jewish Home of Eastern Pennsylvania, formerly the Tax Deferred Annuity Plan for Employees of Jewish Home of Eastern PA Summary Plan Description.

Note 2 Summary of Significant Accounting Policies

Date of Management Review: Pursuant to FASB ASC 855 Subsequent Events were evaluated through October 9, 2025 which is the date the financial statements were available for issue.

Basis of Accounting: The financial statements of the plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are administrated under an investment contract agreement with MALIC. The Plan's investments are reported at fair value. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by MALIC. See Note 5 for discussion of Fair Value Measurements.

Interest Income: Interest Income is recorded in the Interest Accumulation Account on the accrual basis.

Net Appreciation in Fair Value of Investments: Includes dividends, as well as the Plan's gains and losses on investments bought and sold, as well as, held during the year.

Employer's Contributions: Matching contributions are made and are based upon amounts actually computed throughout the year.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent asset and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Excess Contributions Payable: Amounts payable to participants for excess contributions are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions for the years ended December 31, 2024 and 2023.

Payment of Benefits: Benefits are recorded when paid.

Note 3 ERISA 103 (a)(3)(C) – Certification of Investments

Certain information related to the Interest Accumulation Account and Investments at Fair Value disclosed in the accompanying financial statements and supplemental schedules, including the Interest Accumulation Account and Investments at Fair Value held at December 31, 2024 and December 31, 2023 and net appreciation in fair value of investments and interest for the years ended December 31, 2024 and December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by MALIC (the insurance carrier of the Plan).

Note 4 Investment Contract with Insurance Company

The Plan has entered into an investment contract with MALIC. MALIC maintains the contributions in a General Account (Interest Accumulation Account) and separate accounts (pooled separate accounts of which all underlying assets are shares in Registered Investment Companies). The separate accounts are credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The General Account (Interest Accumulation Account) for the Tax Deferred Group Annuity Contract, which is an unallocated deposit administration contract, has a guaranteed interest rate of 3% for years ending December 31, 2024 and 2023. The guaranteed interest rate applies until December 31. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from the financial statements.

Note 4 Investment Contract with Insurance Company (Continued)

A redetermination of the guaranteed interest rate is made annually during November and is applicable for the following calendar year. The effective annual yield of the guaranteed interest rate cannot be less than one percent (1%) nor greater than three percent (3%) per year. The General Account (Interest Accumulation Account) for the 403(b) Thrift Contracts, which is an unallocated deposit administration contract, has a current rate of interest of 2.85% and 1.6% for the years ending December 31, 2024 and 2023, respectively. The current rate of interest is declared from time to time by MALIC. The balance in the General Account (Interest Accumulation Account) was \$770,435 and \$1,606,561 at December 31, 2024 and 2023, respectively.

Participants may ordinarily direct the withdrawal or transfer to all or a portion of their investments.

A more detailed explanation of the contracts including but not limited to Account Valuation and Annuity Benefits, are provided in the 403(b) Thrift and Tax Deferred Group Annuity Contracts, #005-288-G.

Note 5 Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or 3 inputs were available to the Plan.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of Mutual of America's Separate Account No. 2 is based on the value of the shares of Registered Investment Companies (Mutual Funds) and are published and the basis for current transactions. Mutual of America's Separate Account No. 2 consist solely of investments in mutual funds registered with the Securities and Exchange Commission and are carried at the net asset value at which the mutual fund shares are actively traded.

Note 6 Related Party Transactions

The Plan's investments are maintained under an investment contract agreement with MALIC. MALIC is considered a party-in-interest; therefore, these transactions qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 7 Risks and Uncertainties

The Plan invests in various investments through MALIC. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 Income Tax Status

The Plan Sponsor has adopted MALIC's Prototype Non-Standardized 403(b) Plan document that has received a favorable opinion letter from the Internal Revenue Service dated

March 31, 2017, stating that their Prototype Non-Standardized 403(b) Plan is acceptable under their applicable requirements of the Internal Revenue Service Code (IRC). Although the Plan had been amended since adopting the Prototype Non-Standardized 403(b) Plan document, the Plan Administrator believes that the Plan is designed, and is currently operating, in compliance with the applicable requirements of the IRC. The Plan Administrator intends to correct a limited number of isolated operational errors related to participant's elective deferrals under the IRS Employee Plan Compliance Resolution System (EPCRS) using the Self-Correction Program. Upon correction, the Plan Administrator believes the Plan will be in compliance with the applicable requirements of the IRC code and therefore believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 9 Plan Benefits and Termination

Although not under obligation to make contributions to the fund, the Plan's Sponsor has not expressed any intent to discontinue contributions thereto or terminate the Plan subject to the provision of ERISA. In the event of termination of the Plan all amounts credited to employee accounts will remain fully vested and paid as soon as administratively practicable after termination.

Note 10 Delinquent Contributions

The Sponsor made delinquent contributions as reported on the attached Schedule H Line 4a – Schedule of Delinquent Participant Contributions totaling \$12,684.02. As of December 31, 2023, the plan sponsor has remitted the \$12,684.02 of Delinquent Participant Contributions. The plan sponsor made contributions to the affected participants' accounts for the lost earnings in the amount of \$20.08 on December 17, 2024. The Plan Sponsor received a letter dated March 14, 2025, from the Employee Benefits Security Administration (EBSA), indicating EBSA's decision to take no further action based on the completeness and accuracy of the representations made in the Plan Sponsor's Voluntary Fiduciary Correction Program (VFCP) application. Accordingly, the delinquency is not treated as a non-exempt party-in-interest.
