Basis for Opinion

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1: DESCRIPTION OF THE PLAN

The Shawnee Mission Tree Service, Inc. Profit Sharing Plan was established effective as of January 1, 1984, and amended most recently, effective October 4, 2024, to allow hardship distributions and loans. The Summary Plan Description was rewritten, effective October 4, 2024. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Shawnee Mission Tree Service, Inc. who are age twenty-one or older and have completed two months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan participation is voluntary. There are no excluded employees.

Contributions

Each year, participants may elect to defer up to 90% of eligible compensation, not to exceed the maximum established by law, \$23,000 for 2024, \$30,500 for employees age 50 or older. The catch-up contributions for employees age 50 or older are not limited to 90% of compensation. Participants are permitted to designate a portion or all of the deferral election as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes matching contributions of 50% of employees' salary deferral amounts on the first 4% of eligible employees' compensation. The Company may make annual discretionary profit sharing contributions in an amount to be determined at Plan year end by the Board of Directors. Employees must complete one year of service during the Plan year and be employed as of the last day of the Plan year to be eligible for profit sharing contributions for that Plan year. No discretionary profit sharing contribution was made for the Plan years ended December 31, 2024 and 2023.

The Plan contains an automatic enrollment feature which will automatically defer 2% of each participant's compensation upon meeting the eligibility requirements unless a greater or lesser (including zero) percentage is elected by the participant.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, the employee match calculation and compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct Plan assets to any or all 28 investment options offered. Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of the participant's vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear a reasonable interest rate determined by the Plan Administrator. All loans are considered a directed investment of the participant's account under the Plan, and all payments of principal and interest by the participant on a loan will be credited to the participant's account. There are no loans outstanding as of December 31, 2024.

Vesting

Participants are immediately vested in their contributions and their rollover contributions plus actual earnings thereon. Through October 3, 2024, participants were vested in their employer match and profit sharing contributions and any earnings thereon in accordance with the following schedule:

Participants will always, however, be 100% vested in their employer match and profit sharing contributions if they are employed on or after their Normal Retirement Age or if they die or become disabled.

Payment of Benefits

A participant is eligible to request a distribution of their vested account balance based upon any of the following events: death, disability, normal retirement, minimum required distributions, in service withdrawal after age 59½, and termination of employment. The payment may be a lump sum cash payment, or an installment cash payment over no longer than the participants' assumed life expectancy, and/or a direct cash rollover distribution. Upon termination of service, if a participant's vested balance is less than \$7,000, the participant will receive a single lump sum amount automatically.

Plan Termination

The employer has the right to amend or terminate the Plan at any time. Each participant in the Plan upon Plan termination will automatically become 100% vested in their account balance.

Forfeited Accounts

At December 31, 2024 and 2023, nonvested forfeited accounts totaled \$0 and \$3,156, respectively. These accounts are used to pay administrative expenses and to reduce employer contributions. If nonvested forfeiture balances are insufficient, the Plan Sponsor will pay certain administrative expenses. For the years ended December 31, 2024 and 2023, administrative expenses of \$0 and \$0 and employer contributions of \$13,825 and \$0, were paid by nonvested forfeited accounts, respectfully.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Administrative expenses, if paid from plan assets, are included in the statement of changes in net assets available for benefits. If the administrative expenses are paid by the Plan sponsor, they are not included in the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments. Expenses paid by the Plan are allocated to the participant's accounts.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Income Tax Status

The IRS has determined and informed the plan sponsor by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the Determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 3: INVESTMENTS - UNAUDITED INFORMATION CERTIFIED BY THE PLAN TRUSTEE

The December 31, 2024 and 2023, Statement of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the trustees in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Reliance Trust Company and Matrix Trust Company, the trustees of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to the investments:

- Investments at fair value and contract value
- Net appreciation (depreciation) in fair value of investments
- Interest and dividends
- Schedule of assets (held at end of year)

NOTE 4: FAIR VALUE MEASUREMENTS

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology that are unobservable inputs for the asset or liability.

A financial instrument's level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Valued at net asset value of shares held by the Plan. The assets are valued at published closing price in active markets.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective trust fund: Valued at the net asset value (NAV) of units of the investment company collective trust. The NAV, as provided by the trustee, is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. For years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

NOTE 5: RELATED PARTY TRANSACTIONS

Certain record-keeper service providers are paid fees from Plan assets, while also managing the underlying Plan investments. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are absorbed by the mutual funds and reflected in the funds fair value. Certain other expenses are paid from the Plan's forfeiture account and/or participants' accounts or absorbed by the Plan sponsor.

NOTE 6: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 7: SUBSEQUENT EVENTS

The Plan management has evaluated subsequent events through the date of the attached auditor's report, the date the financial statements were available to be issued. There have been no significant events which require disclosure in the financial statements.
