NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The Trancy Logistics America Corporation 401(k) Savings Plan (the "Plan") is a defined contribution plan adopted by Trancy Logistics America Corporation. The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Trancy Logistics America Corporation (the "Company") with one year of service who are not subject to collective bargaining agreements, nonresident aliens with no U.S. source income, or employees assigned from Trancy Logistics America Corporation's parent company. Eligible employees may participate in the Plan on the first quarterly entry date following completion of a valid salary reduction agreement. Participation is voluntary. The Plan provides for retirement benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Contributions

Each year, participants may contribute up to the maximum amount allowable by the Internal Revenue Code of their pre-tax annual compensation as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. The Company matches 50% of eligible contributions up to a certain percentage of eligible compensation as discretionarily determined by the Company. The Company may also contribute discretionary profit-sharing contributions and qualified nonelective contributions. Company contributions to the Plan are subject to certain limitations in accordance with Federal income tax regulations. Participants direct the investments of their contributions and the Company's contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, and the Company's matching and other contributions, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are vested in their Company contribution portions of their accounts, plus actual earnings based on a 6-year graded vesting schedule.

Forfeiture Accounts

Forfeited balances of terminated participant's non-vested accounts are used to reduce future Company contributions or used to pay Plan expenses. During the years ended December 31, 2024 and 2023, no forfeitures were used to reduce Company contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$18,821 and \$14,896, respectively.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum, annuity, or installment amount equal to the value of the participant's vested account balance.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies followed by the Plan are summarized below:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Valuation of Investments

Investments in pooled separate accounts are credited with earnings and gains or losses on the pooled investments. The separate accounts are stated at fair value as reported to the Plan by the Custodian, based on the quoted prices of the underlying mutual funds. The unit value of the separate account is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. Investment transactions are recorded as of the settlement date, which does not differ materially from the trade date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company and, accordingly, are not reflected in the Plan's financial statements. Investment-related expenses are included in net change in fair value of investments.

Subsequent Events

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFP 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Talcott Resolution Life Insurance Company (TRLIC), through its administrative service provider Empower Trust Company, LLC, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and investment related activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

However, in accordance with Subtopic 820-10, the pooled separate account investments that are measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

5. TAX STATUS

The Plan is based on a Non-Standardized Pre-Approved Profit-Sharing Plan with Cash or Deferred Arrangement which has received a favorable opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan is granted favorable treatment as being in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan sponsor believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, no income taxes have been provided.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan, and upon resolution by the Company's Board of Directors, to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, all amounts will be paid as directed in the plan document and regulations.

7. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. Professional fees and the majority of other administration expenses of the Plan were paid by the Company.

Investment management fees are paid to the custodian, TRLIC, as well as Kestra Investment Services, LLC., the investment manager. Third party administrator fees are paid to Empower Annuity Insurance Company, the administrative service provider for the plan custodian. Blue & Co., LLC is the independent auditor for the Plan. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

The Company provides certain accounting, recordkeeping and administrative services to the Plan, for which it is not compensated.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
