## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the accompanying financial statements of the Skyline Furniture 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Skyline Furniture 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in the *Information Prepared and Certified by the Custodian* note to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America and
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. ### DESCRIPTION OF PLAN

The following description of the Skyline Furniture (the "Company") 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General - The Plan is a defined contribution plan covering all full-time employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan.
2. Contributions - Participants are eligible to participate in the Plan after completing one month of employment. Participants may elect to defer both before tax and after tax (Roth) contributions to the Plan through payroll deductions. The Company contributes a matching percentage of 50% of participants' contributions up to a maximum of \$1,000. Additional amounts may be contributed by the Company to the Plan at its discretion. Contributions are subject to certain maximum limitations imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.
3. Participants' Accounts - Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. Vesting - Participants are immediately vested in their contributions account and the Company's matching contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service.
5. Investment Options - Upon enrollment in the Plan, each participant directs the investment of all amounts allocated to their account based on the list of investment alternatives available under the Plan.
6. Notes Receivable from Participants - Each participant is allowed to borrow from their account a minimum of \$1,000 up to a maximum of the lesser of \$50,000 reduced by the participant's highest outstanding loan balance over the previous twelve months or 50% of their vested account balance. Loans provide for periodic repayment over a period of five years or less unless the loan is in connection with the participant's principal residence. The interest rates and types of collateral required are contained in

the Plan document. Principal and interest are paid ratably through payroll deductions, unless otherwise approved by the Plan Administrator. All interest paid with respect to these loans is credited to the participant's individual account. Any loss or expense associated with the loan is borne by the participant.

7. Payment of Benefits – Upon eligibility for benefits, the participant may elect one of several methods to distribute the value of the participant's vested account balance, as defined by the Plan. Benefits are recorded when paid. As of December 31, 2024 and 2023, the vested but unpaid balances of terminated participants amounted to \$590,468 and \$433,666, respectively. Excess contributions returned to Plan participants in 2025 from the 2024 Plan year amounted to \$38,154.
8. Forfeited Accounts – On December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$651 and \$1,610, respectively. At the Plan Administrator's discretion, forfeitures may be used to reduce employer contributions. During 2024, \$1,387 of forfeitures was used to reduce the employer's contribution.
9. Administrative Expenses – Investment management services and expenses related to the administration of the Plan are substantially paid by the Plan. The Company absorbs a portion of these expenses.

#### SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting:

The financial statements of the Plan are prepared on the accrual method of accounting.

##### Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates and assumptions.

##### Investment Valuation and Income Recognition:

Shares of mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The collective trust fund is measured using the NAV practical expedient of the fund as reported by the fund's manager. The NAV practical expedient is based on the fair value of the underlying

assets owned by the collective trust fund, less the liabilities, and divided by the number of units outstanding.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on an accrual basis, and dividends are recorded on the ex-dividend date. Investment related expenses are included in net appreciation of fair value of investments.

The Plan presents, in the Statements of Changes in Net Assets Available for Benefits, the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized gains or losses of those investments.

Notes Receivable from Participants:

Notes receivable from participants represents participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

### INVESTMENT IN COLLECTIVE TRUST

The Plan holds an investment in a collective trust, specifically the JPMorgan Stable Asset Income Fund (SAIF). The SAIF invests primarily in a portfolio of fixed income instruments with companion book value contracts issued by insurance companies, banks and other financial institutions. The SAIF is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

### FAIR VALUE MEASUREMENTS

Generally accepted accounting principles in the United States of America have established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

- If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. See *Summary of Significant Accounting Policies* for a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The valuation methods described in *Summary of Significant Accounting Policies* may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Since JPMorgan is the third-party administrator, the investments in JPMorgan funds constitute party-in-interest investments as defined by ERISA.

Certain employees of the Company provide accounting and administrative services to the Plan. These employees did not receive any compensation from the Plan for their services. Also certain administrative expenses were paid by the Company on behalf of the Plan and were excluded from these financial statements.

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Generally accepted accounting principles in the United States of America requires that Plan management evaluate each tax position taken by the Plan and recognize a liability (or asset) if the Plan has taken an uncertain tax position that more-likely-than-not (i.e., a likelihood of more than 50%), based on the technical merits, would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken. Accordingly, the Plan has recognized no interest and penalties associated with any liability for unrecognized tax benefits. The Plan's policy is to record such amounts, if any, as income tax expense. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.
