DECEMBER 31, 2024 AND 2023

NOTE 1 PLAN DESCRIPTION

The following description of the Curry Supply Company, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document as well as the Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan in accordance with Section 401(k) of the Internal Revenue Code covering substantially all employees of Curry Supply Company, Inc., and related participating employers including Curry Supply Holdings, Inc., Curflo, Inc., CS Trucking LLC, Central Hydraulics, Inc. d/b/a Curry Fluid Power, Inc., Curry Rail Services, Inc., and Curry Designs, Inc. (collectively the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees who are at least nineteen (19) years of age become eligible to participate in the deferral and match features of the Plan upon completion of five hundred (500) hours of service within six (6) consecutive months from the employee’s commencement date. If an employee does not complete the stated Hours of Service during the specified time period, the employee must complete one (1) year of service before eligibility requirements are met. Employees are credited with a Year of Service at the end of the twelve (12) month period beginning on the employee’s date of hire if the employee has attained at least one thousand (1,000) Hours of Service during such period. The entry date for newly eligible employees is the first day of the Plan Year quarter coinciding with or next following the date eligibility requirements are met.

To become eligible to share in the Company’s non-elective profit sharing contribution, employees must be at least twenty-one (21) years of age and must have completed a Year of Service during the plan year and be employed on the last day of the Plan Year. Participants are able to share in the profit sharing contribution regardless of whether the participant met the service requirement in the event of death, permanent disability, or early or normal retirement.

Contributions

Each year, participants may contribute up to the maximum amount of annual compensation, as defined in the Plan, not to exceed certain IRS limits. Participants may also designate all or a portion of their elective deferrals as after-tax Roth elective deferrals. The Plan has adopted a Qualified Automatic Contribution Arrangement and Safe Harbor Contribution design for the Plan, which means that the Plan automatically complies with the nondiscrimination requirements of Internal Revenue Code Section 401. Therefore, the Company will withhold six percent (6%) of compensation in the form of employee deferral contributions, except for those participants who have a salary deferral agreement in effect for each payroll period and contribute that amount to the Plan as a Pre-Tax 401(k) deferral. The Company will also make a safe harbor matching contribution equal to one hundred percent (100%) of the participant’s elective deferrals that do not exceed one percent (1%) of compensation plus fifty percent (50%) of participant’s elective deferrals between one percent (1%) and six percent (6%) of participant compensation.

Participants who have attained age fifty (50) by the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Contributions to the Plan are recorded in the period that payroll deductions are made from participants. Company contributions are accrued based upon the period those contributions relate to.

Participant Accounts

Each participant's account is credited with (a) the participant's contribution and related employer matching contribution, (b) an allocation of the Company's discretionary matching and profit sharing contribution, if any, and (d) an allocation of investment earnings and administrative fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always fully vested in their voluntary contributions, rollover contributions, and any earnings thereon. Vesting in the remainder of their account (including employer matching and employer profit sharing contributions) is earned in accordance with the following schedule:

Regardless of the number of years of service, a participant's account balance becomes fully vested when the participant retires, becomes permanently disabled, or dies.

This safe harbor matching contribution is subject to the following vesting schedule:

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump sum amount or an annuity equal to the value of the participant's vested interest in his or her account. For balances less than \$5,000, the Company may distribute amounts to participants in the form of a lump sum without consent. In-service withdrawals are also permitted for participants who have attained the age of fifty-nine and a half (59 ½) and can only be made from accounts which are fully vested. The Plan also maintains a provision for hardship withdrawals which can only be made from a participant's pre-tax deferral account and only if the participant is still employed by the Company at the time of the hardship request.

Forfeitures

Forfeitures may first be used to reduce plan administrative expenses. Any remaining forfeitures may be used to reduce employer contributions to the Plan. Forfeited non-vested balances amounted to \$7,396 and \$2,370 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeitures amounting to \$70,193 were used to reduce employer matching contributions.

Reclassifications

Certain prior year amounts have been reclassified to conform to the current year presentation. These reclassifications had no effect on the net assets available for benefits or changes in net assets available for benefits as previously reported.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a description of fair value measurements.

Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Participant loans are not permitted according to the terms of the plan document.

Administrative Expenses

Administrative expenses are paid by the Plan through the use of forfeitures or by the Company.

Payment of Benefits

Benefit payments to participants are recorded when paid.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted market prices in active markets for similar assets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

Level 3 – Inputs to the valuation methodology are unobservable inputs and significant to the fair value measurement.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Registered Investment Companies: Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

Common/Collective Trust: Valued at the NAV of shares held by the Plan at year end adjusted for any cash held for liquidity purposes and any fees imposed by the fund. The net asset value per unit is determined by dividing the net assets by the number of units outstanding on the day of valuation. The net asset value of the fund is determined daily. Units are issued and redeemed daily, at the daily net asset value. Also, the net investment income and realized and unrealized gains on investments are not distributed.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, qualified institution, have certified that the following investment information included in the accompanying financial statements and ERISA – required supplemental schedule is complete and accurate:

- Investments as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA required supplemental schedule.

NOTE 5 TAX STATUS

The Plan adopted a non-standardized form of a prototype 401(k) profit sharing plan sponsored by Keystone 401(k). The prototype plan has received an opinion letter from the Internal Revenue Service dated October 6, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The prototype plan has been amended since receiving the determination letter. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become one hundred percent (100%) vested in their accounts.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities held by the Plan, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by Reliance Trust Company, the custodian as defined by the Plan and, therefore, these transactions qualify as party-in interest.

NOTE 9 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.



