### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Delta Star, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Opinion

### 1. Description of the Plan

The following description of the Delta Star, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement, as amended and restated, for a more complete description of the Plan's provisions.

*General* – The Plan is a defined contribution plan established effective July 1, 1997, as restated February 1, 2022. The Plan was most recently amended, effective April 1, 2024, to change the required distribution threshold from \$5,000 to \$7,000. The Plan covers substantially all employees of Delta Star, Inc. (the "Company"), excluding non-resident aliens, leased and temporary employees, and residents of Puerto Rico, who have completed 2 months of service. Entry into the Plan occurs on the first day of each calendar month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

*Plan Administration* – The Company is the Plan sponsor and Plan administrator and is responsible for oversight of the Plan. Certain administrative functions are performed by employees of the Company, who receive no compensation from the Plan.

*Participant Contributions* – Each year, participants may contribute a percentage of pre-tax eligible compensation, as defined in the Plan document, up to maximum limits of \$23,000 of the Internal Revenue Code ("IRC"). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions upto \$7,500. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

*Plan Sponsor Safe Harbor Matching Contribution* – The Company contributes a safe harbor matching contribution each payroll period equal to 100% of the participant's elective deferral, up to 4% of the participant's compensation. Participants who have reached the age of 21 and completed 1 year (1,000 hours) of service are eligible for safe harbor matching employer contributions. Hourly employees in the Company's San Carlos, California location covered by a collective bargaining agreement are not eligible to receive Plan sponsor matching contributions.

*Investment Options* – Participant's may direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers multiple investment options for participants as of December 31, 2024.

*Participant Accounts* – Individual accounts are maintained for each participant and include participants' salary deferral contributions, rollover contributions, Company contributions, an allocation of Plan earnings (losses), benefit payments, and administrative expenses, if not paid by the Plan sponsor. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

*Vesting* – Participants 100% vested immediately in their own elective deferral and rollover contributions, Plan sponsor safe harbor matching contributions, and any earnings thereon.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at a time and all loans must be repaid within five years unless the loan qualifies as a home loan for the purchase of a primary residence, in which case the repayment period may not exceed ten years. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1% above the prime rate, as defined. As of December 31, 2024, the interest rate on all outstanding loans ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

*Benefits and Payments* – Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, disability, attainment of age 59½, or hardship withdrawal, as defined in the Plan. A participant may elect to receive a lump sum payment or installment payments, roll over the value of their account into another qualified plan, or a combination. If the vested account balance payable to an individual is less than or equal to \$7,000, excluding rollover contributions, the Plan sponsor may require a distribution of the entire account balance in a lump-sum, unless otherwise directed. In addition, the Plan allows for hardship distributions if certain criteria are met. Hardship withdrawals are subject to IRC restrictions and penalties. At December 31, 2024 and 2023, there were no benefit payments that had been requested but not yet paid.

*Forfeitures* – Forfeitures arise from overfunding of Company contributions which the Company elects to hold in the Plan accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,723 and \$3,074, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. For the year ended December 31, 2024, no forfeited accounts were used to reduce employer contributions or to reduce Plan administrative expenses.

### 2. Summary of Significant Accounting Policies

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan payments and the Plan administrator deems the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Payment of Benefits* – Benefits are recorded when paid.

*Administrative Expenses* – Certain administrative expenses, which include custodial, investment management, and professional fees for services, are paid by the Plan sponsor, as provided in the Plan agreement. Fees related to the administration of notes receivable from participants and certain other administrative fees are charged directly to the participant's account and are included in administrative expenses. Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

A plan expense account is maintained to hold revenue sharing funds the Plan receives from the qualified institutions pursuant to an agreement between the qualified institutions and the Plan. Revenue share funds are reported as other income in the statement of changes in net assets available for benefits. These revenue sharing funds are available to reduce employer contributions and pay qualified Plan administrative expenses. As of December 31, 2024 and 2023, the account balance of the plan expense account was \$27,777 and \$246,974, respectively. For the year ended December 31, 2024, \$-0- was used to reduce employer contributions, \$44,785 was used to reduce Plan administrative expenses, and \$401,716 was allocated to participant accounts.

*Excess Contributions Payable* – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

*Prepaid Contributions Liability* – Amounts paid to the Plan but not yet withheld from or earned by employees are recorded as a liability with an corresponding reduction to participant and employer contributions.

*Subsequent Events* – Subsequent events were evaluated through October 9, 2025, the date the financial statements were available to be issued.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

*Level 1* – Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation technique include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation technique used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

The Plan believes its valuation method is appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Fully Benefit-Responsive Investment Contracts

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with a qualified institution. The contract meets the fully benefit-responsive contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully-benefit responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

With traditional investment contracts, the Plan owns the contract. Traditional investment contracts are designed to accrue interest based on credit rates established by the contract issuers. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for the benefit-responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average yield for 2024 and 2023 was 1.41% and 1.23%, respectively, with the minimum guaranteed interest rate ranging between 1.45% and 1.15%.

#### **4. Fully Benefit-Responsive Investment Contracts (continued)**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Such events include:

1. Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or,
5. Premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; or,
4. A material amendment to the agreement without the consent of the issuer.

#### **5. Information Certified by the Qualified Institution**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the qualified institutions of the Plan, have certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

#### **6. Party-in-interest Transactions**

Certain Plan assets on December 31, 2024 and 2023 are invested in funds sponsored by the qualified institutions of the Plan. Transactions involving these investments are considered party-in-interest transactions for which a statutory exemption exists under DOL rules and regulations. Fees incurred by the Plan for investment advisory and investment management services are paid directly by the Plan and, therefore, also qualify as party in interests transactions which a statutory exemption exists. For the year ended December 31, 2024, fees paid to these parties in-interest totaled \$68,810, which were offset by \$44,785 of revenue sharing funds in the Plan expense account.

Notes receivable from participants also qualify as parties-in-interest.

#### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

#### **8. Tax Status**

The Plan adopted a volume submitter profit sharing plan which received a favorable opinion letter from the IRS on November 14, 2022, which stated that the prototype Plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the volume submitter plan has been amended since receiving the opinion letter. However, the Plan sponsor believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 10. Delinquent Participant Contributions

For the year ended December 31, 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances of \$215 were identified on the Schedule of Delinquent Participant Contributions in a prior year and were not corrected prior to January 1, 2024. The prior year untimely remittances were corrected outside of the Department of Labor Voluntary Fiduciary Correction Program in 2024. Additionally, the Company will be compensating participants for lost earnings resulting from the delay in contributions.
