Note 1 - Description of Plan

The following description of The Thrasher Group, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General - The Plan is sponsored by The Thrasher Group, Inc. (the Company), and was established on January 1, 1987. The Plan is a defined contribution plan with the option to participate in self-directed brokerage accounts, covering all employees who are at least 18 years of age on the first day of the month following 30 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performances and reports to the Plan's Board of Trustees.

Contributions - Each year, participants may contribute up to the maximum allowed under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan or into self-directed brokerage accounts. The Plan provides various mutual funds as investment options for participants or other broker-managed securities in individual accounts. Employer contributions consist of a safe harbor employer match of up to 100% of participant elective deferrals not in excess of 4% of participant's compensation, and a discretionary profit-sharing contribution allocated to participants based on compensation. The employer makes deferral and matching contributions as the year progresses and, if applicable, annual profit-sharing contributions. Total safe harbor matching contributions was \$837,868 in 2024.

An employee must be actively employed on the last day of the year or, if terminated, have completed at least 500 hours during the year in order to be eligible for the discretionary profit-sharing contribution. There was no discretionary profit-sharing contribution for the year ended December 31, 2024.

Participant Accounts - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions and employer safe harbor matching contributions, plus actual earnings thereon. The employer's discretionary profit-sharing contributions are vested based on years of service with 0% the first year of participation and 20% each year thereafter until fully vested after five years of service:

Forfeitures - Forfeitures represent participant account balances that are not vested upon the termination of an employee. All forfeited amounts are used toward the employer's obligation to make contributions. Total forfeitures were not material at December 31, 2024 and 2023 and forfeitures used in 2024 was not material.

Note 1 - Description of Plan (Continued)

Payment of Benefits - Upon termination of service due to death, disability, retirement at normal age of 65 or other reasons, a participant or his or her beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or may elect partial payments.

Notes Receivable from Participants - A participant may incur a note to the Plan in an amount as defined by the Plan document (not greater than \$50,000 or 50% of the participant's vested account balance) from the balance of the participant's account. Notes receivable from participants are presented at principal amounts outstanding, which approximate fair value. Interest is charged at a rate that is comparable to rates charged by commercial lending institutions. The notes receivable from participants can be repaid through payroll deductions over periods not generally exceeding 60 months and are secured by participant accounts. If the purpose of the notes receivable from participants is to acquire or construct the primary residence of a participant, the period of repayment may exceed five years, but in no event shall it exceed the usual repayment period required by commercial lenders for similar loans.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Contributions - Employee contributions and Company contributions are recognized as additions to Plan assets in the year designated by the employee and Company, respectively.

Investment Valuation and Income Recognition - Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. (See Note 4.) Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan valuation policies utilizing information provided by the investment advisers, custodians and insurance companies. See Note 3 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Note 2 - Summary of Significant Accounting Policies (Continued)

Other Employer Contributions - During 2024, it was determined that the definition of compensation used in the calculation of employee and employer contributions was not in accordance with the Plan document. As a result, an other employer contribution receivable was recorded at December 31, 2024 to correct the error, which also included the calculation of lost earnings for missed deferrals dating back to 2020. The Plan funded the receivable in 2025.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Newly Adopted Accounting Standard - In June 2016, the Financial Accounting Standards Board (FASB) issued ASU 2016-13, Measurement of Credit Losses on Financial Instruments, which amends guidance on the impairment of financial instruments. The new guidance estimates credit losses based on expected losses, modifies the impairment model for available-for-sale debt securities and provides a simplified accounting model for purchased financial assets with credit deterioration. In 2024, the Plan adopted the standard on a retrospective basis. The adoption of this standard had no material impact on the Plan's financial statements

Subsequent Events - The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Note 3 - Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 3 - Fair Value Measurement (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Group Annuity Contract

The Plan has a fully benefit-responsive guaranteed interest account provided through a group annuity contract with Massachusetts Mutual Life Insurance Company (Mass Mutual) totaling \$383,510 and \$304,153 for 2024 and 2023, respectively. Empower Trust Company, LLC (Empower) maintains the contributions in a general account. The guaranteed interest account issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. Under terms of the group annuity contract, a crediting rate is established for amounts invested in the guaranteed interest account, but may not be less than 1%. The crediting rate is reviewed on a semiannual basis for resetting. The guaranteed interest account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 4 - Group Annuity Contract (Continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial Plan termination or merger with another Plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has reserved the right to terminate the Plan or reduce or cease contributions at the discretion of the Board or Directors, or to amend the Plan at any time and in any respect, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balance.

Note 6 - Related-Party Transactions

Certain Plan investments are managed by Empower, Massachusetts Mutual Life Insurance Company (Mass Mutual), Fidelity Investments (Fidelity), Morgan Stanley, and Charles Schwab, the custodians for the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, since they are paid through revenue sharing rather than direct payment. Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Tax Status

The Plan is a prototype nonstandardized profit-sharing Plan that received an opinion letter from the IRS dated June 30, 2020 classifying it as a qualified employee benefit Plan under Section 401(a) of the IRC, and thus exempt from federal income tax under Section 501(a). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 9 - Information Certified by the Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, a qualified institution, has certified that certain of the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends and capital gains, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets held at end of year as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule

Self-directed brokerage accounts totaling \$4,225,590 at December 31, 2024 and \$3,087,920 at December 31, 2023 are held at other custodians. These investments and the related net appreciation in fair value of investments totaling \$460,754 have not been certified by the respective custodians.
