Eligibility for Participation: Each Employee in the service of the Employer will be eligible to participate in the Plan as of the January 1st or July 1st coincident with or next following the completion of one Year of Service and attainment of age 21. Group A participants shall be all licensed attorneys with an equity interest in the firm. Group B participants shall be all licensed attorneys without an equity interest in the firm. Group C participants shall be all other participants.

Normal Retirement Date: The Normal Retirement Date is the first day of the month coincident with or immediately following the later of the Participant's 65th birthday or the 1st anniversary of Plan participation.

Early Retirement Date: Not Applicable.

Normal Retirement Benefit: A Participant who retires on his Normal Retirement Date will be entitled to a monthly retirement income commencing on his Normal Retirement Date and payable for his lifetime. The benefit formula for Group A and Group C participants shall be a retirement income equal to the sum of 0.655% of the Participant's "Average Monthly Compensation" multiplied by Years of Service up to a maximum of 15 Years, plus 0.873% of the Participant's "Average Monthly Compensation" multiplied by Years of Service in excess of 15, up to a maximum of 20 Years. The benefit formula for Group B participants shall be a retirement income equal to 0.250% of the Participant's "Average Monthly Compensation" multiplied by Years of Service up to a maximum of 15 Years.

The minimum top-heavy benefit will be equal to 2.00% of the Participant's "Average Monthly Compensation" multiplied by Years of Plan Participation up to a maximum of 10 years, reduced by the actuarial equivalent of any employer contribution to the 401(k) Profit Sharing Plan. "Average Monthly Compensation" is defined as the average monthly compensation received during the highest three consecutive Plan Years prior to termination of service.

Death Benefit: In the event of a Participant's death, his beneficiary will be entitled to receive the greater of the actuarial equivalent of the Participant's Accrued Benefit at date of death or the qualified pre-retirement survivor's annuity benefit.

Disability Benefit: In the event of a Participant's disablement prior to his eligibility for Normal Retirement Benefits, he will be entitled to the actuarial equivalent of his Accrued Benefit at date of disability.

Termination Benefit: A Participant who terminates his service with the Employer will have a vested interest equal to a percentage of the actuarial equivalent of his Accrued Benefit earned at date of termination of service in accordance with the following schedule:

<u>Years of Service</u>	<u>Percentage Vested</u>
Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 or more years	100%

Accrued Benefit: A Participant's Accrued Benefit is the retirement benefit using current "Average Monthly Compensation" and Years of Service.

Actuarial Equivalence: Actuarial Equivalence is defined as an interest rate of 5.50% pre-retirement, and the 1994 Group Annuity Reserving Mortality Table (unisex basis) with an interest rate of 5.50% post-retirement.
