Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**NOTE 1. PLAN DESCRIPTION**

The following description of the Southeastern Pneumatic, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General:**

The Plan is a defined contribution plan covering all full-time employees of Southeastern Pneumatic, Inc.; Southwestern Pneumatic, Inc.; and Pneumatic Exports, Inc., collectively doing business as Bulk Equipment Companies (the “Company” or “Plan Sponsor”) who have completed three months of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Eligibility:**

Employees of the Company are generally eligible to participate in the Plan after the completion of three months of service and attaining the age of 21. Entrance dates are January 1 or July 1 depending on when eligibility is met.

**Contributions:**

Each year, participants may contribute a certain percentage of their compensation as defined in the Plan. The Plan allows participants to contribute between 2% to 15% of eligible compensation up to the maximum allowed by the Internal Revenue Service (“IRS”). The Plan provides for a discretionary match which is determined by management of the Plan Sponsor. All contributions are subject to the limitations provided in ERISA and the Internal Revenue Code (“IRC”). The Plan Sponsor made no discretionary contributions for the year ended December 31, 2024.

**Participant Accounts:**

Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s contribution, if any; (b) Plan earnings or losses; and (c) forfeitures of terminated participants’ nonvested accounts, as applicable. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, if not paid from forfeited nonvested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## NOTES TO FINANCIAL STATEMENTS

---

### NOTE 1. PLAN DESCRIPTION (CONTINUED)

#### **Participants' Investment Options:**

Participants must direct their salary deferral contributions and any discretionary contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year and have direct access to American Funds through internet or telephone.

#### **Vesting:**

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts, plus earnings thereon, is based on years of service. A participant is 100% vested after six years of credited service for discretionary contributions.

#### **Benefit Payments:**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum distribution. A participant may also elect to make an in-service withdrawal upon reaching the age of 59½ years. If death occurs prior to retirement, the participant's account becomes vested and is paid to the designated beneficiary.

#### **Notes Receivable from Participants:**

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate published in The Wall Street Journal on the first business day of each month, plus 1%. Once the loan rate is established, that rate is fixed for the life of the loan.

#### **Forfeitures:**

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$41,600 and \$34,816, respectively. These forfeited amounts are reallocated to Plan participants who have met allocation requirements for profit sharing contributions or used to pay Plan expenses. For the year ended December 31, 2024, no forfeitures were allocated to Plan participants.

#### **Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## NOTES TO FINANCIAL STATEMENTS

---

### NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting:**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates:**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Valuation of Investments and Income Recognition:**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Contributions income:**

The Plan records employer and employee contributions receivable when compensation is paid and deferrals are withheld. The Plan adopted ASC 326, Financial Instruments - Credit Losses, effective January 1, 2023, using the modified retrospective method. In accordance with ASC 326, no allowance for credit losses has been recorded at December 31, 2024 or 2023, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

#### **Payment of Benefits:**

Benefits are recorded when paid.

#### **Expenses:**

Fund specific brokerage fees related to the Plan were paid by the Plan Sponsor. The Plan Sponsor also pays certain administrative expenses such as legal and audit costs.

## NOTES TO FINANCIAL STATEMENTS

### NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### Subsequent Events:

The Plan Administrator has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

### NOTE 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, Fair Value Measurement (“ASC 820”), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this guidance are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets,
- quoted prices for identical or similar assets or liabilities in inactive markets,
- inputs other than quoted prices that are observable for the asset or liability, and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## NOTES TO FINANCIAL STATEMENTS

---

### NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 4. INFORMATION CERTIFIED BY PLAN TRUSTEE

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Capital Bank and Trust Company, the trustee of the Plan, except for comparing such information to information included in the Plan's financial statements and supplemental schedule.

The Plan Administrator has obtained certifications from the trustee that the following information is complete and accurate.

### NOTE 5. INCOME TAX STATUS

Effective August 2021, the Plan adopted a non-standardized form of prototype plan sponsored by Capital Group Retirement Services. The prototype plan has received an opinion letter from the IRS, dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## NOTES TO FINANCIAL STATEMENTS

---

### **NOTE 6. ADMINISTRATIVE EXPENSES**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The majority of all administrative expenses are paid directly by the Company. However, forfeitures, when available, are also used to pay for Plan expenses. Plan expenses are included in administrative expenses. Fees incurred by the Plan for investment management services are included in net appreciation, or depreciation, in fair value of investments.

### **NOTE 7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Capital Bank and Trust Company or its subsidiary. Capital Bank and Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

### **NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
