## REPORT OF INDEPENDENT AUDITORS

To the Plan Administrator of the  
U.S. Renal Care, Inc. Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed audits of the financial statements of U.S. Renal Care, Inc. Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024, and 2023

### A. Description of the Plan

#### General

The following brief description of the U.S. Renal Care, Inc. Profit Sharing Plan (the “Plan”) is provided for general information purposes only. The Plan is sponsored by U.S. Renal Care, Inc. (the “Company”). The Company is also the Plan Administrator. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

The Plan was established effective January 1, 2001, most recently restated effective September 1, 2022, and is a defined contribution plan available to substantially all employees of the Company who have attained age 18. Eligible employees of the Company may enter the Plan immediately following the date aforementioned requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The purpose of the Plan is to encourage the Company’s employees to save and invest, systematically, a portion of their current compensation so that they and their families may have a source of additional income upon their retirement, or in the event of death.

#### Contributions

Participants may contribute a specific percentage or dollar amount of pre-tax annual compensation up to the maximum amount allowable. Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (the “Code”) as defined in the plan document. Eligible participants may make a rollover contribution to the Plan.

Participants who are eligible to make salary deferral contributions under the Plan and who have attained age 50 before the close of the year may make catch-up contributions in accordance with, and subject to the limitations imposed by the Code.

The Company may, at its sole discretion, make matching contributions to the Plan for any plan year. The amount of the matching contribution for each eligible participant shall be 50% of the participant’s elective deferral for the plan year; not to exceed 6% of the participant’s compensation for the plan year. Participants are eligible to receive matching contributions once they are eligible to participate in the Plan. Each year, the Company may make a discretionary, non-elective contribution to the Plan. In order to share in the non-elective contribution, participants must be enrolled on the last day of the plan year or must be credited with at least 501 hours of service during the plan year if not employed on the last day of the plan year. No such contributions were made in 2024.

**NOTES TO FINANCIAL STATEMENTS (continued)**

**A. Description of the Plan – continued**

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions and allocations of: (a) the Company’s contribution; and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contribution portion of accounts, plus actual earnings thereon is as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1 year	20%
2 years	40%
3 years	60%
4 years	80%
5 years	100%

In the event of disability, early retirement, or death, the participant will become fully vested.

**Participant Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates. Principal and interest is paid ratably through periodic payroll deductions with the term not to exceed five years unless it is used to purchase a principal residence. The maximum number of loans which a participant may have outstanding at any one time is one. As of December 31, 2024, and 2023, interest rates ranged from 3.25% to 8.50%. Participant loans are classified as notes receivable from participants in the Plan’s financial statements.

**Benefit Payments**

Participants withdrawing during the year for reasons of service or disability, retirement, death, or termination are entitled to their vested account balance. Benefits are distributed in the form of rollovers or lump sum payments. If withdrawing participants are not entitled to their entire account balance, the amounts not received are forfeited.

### NOTES TO FINANCIAL STATEMENTS *(continued)*

#### A. Description of the Plan – continued

##### Benefit Payments – continued

A participant may receive a hardship distribution from salary reduction contributions if the distribution is: (1) on account of uninsured medical expenses incurred by the participant, their spouse, or dependents; (2) to purchase (excluding mortgage payments) a principal residence of the participant; (3) for the payment of post-secondary tuition expenses; (4) needed to prevent eviction of the participant from their principal residence or foreclosure upon the mortgage of the participant's principal residence; (5) payment for burial or funeral expenses; (6) expenses for the repair or damage to the participant's principal residence; or (7) expenses for disasters arising from federally declared disasters, provided the principal residence or place of employment was in an area FEMA designates as qualifying for individual assistance.

##### Forfeitures

Forfeited balances of terminated participants' non-vested accounts may be used to pay any administrative expenses. Any remaining forfeitures attributable to non-elective and matching contributions can be allocated as additional discretionary non-elective or discretionary matching contributions. Effective January 1, 2020, the Plan was also amended to allow for forfeitures to be used to reduce employer matching contributions. The Plan used \$38,719 of forfeitures to pay for employer matching contributions funded each pay date and \$38,672 for administrative expenses during the year ended December 31, 2024. Unallocated forfeitures outstanding at December 31, 2024, and 2023 totaled \$1,381,010 and \$1,101,783, respectively, which were utilized to fund the annual employer true up contribution of \$542,927 and \$431,335, respectively, subsequent to year end.

##### Investment Options

Upon enrollment in the Plan, participants may direct the investment of all contributions into various investment options offered by the Plan. Participants may change their investment elections at any time.

#### B. Summary of Significant Accounting Policies

##### Plan Expenses

The Plan permits the payment of plan related expenses to be made from the Plan's assets. If the Company does not pay these expenses from its own assets, then the expenses paid using the Plan's assets will generally be allocated among the accounts of all participants in the Plan. However, certain expenses specifically incurred by or attributable to participants will be paid from participant's accounts.

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in United States of America ("GAAP").

#### **B. Summary of Significant Accounting Policies – continued**

##### **Use of Estimates**

The preparation of the financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

##### **Contributions**

Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan's administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

##### **Investment Valuation and Income**

The investments are reported at fair value as of the end of the year and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note C for information related to the Plan's valuation methodologies.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in the market value of investments held at year end. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024, and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

##### **Payment of Benefits**

Benefits are recorded when paid.

#### C. Fair Value Measurements

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined are as follows:

- Level 1 — observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 — observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3 — inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

GAAP requires that management describe the methodologies used to measure the fair value of assets and liabilities. The methodologies used to measure the fair value of the Plan's investments are as follows:

- Mutual funds are valued at the published per share net asset value ("NAV") of shares held by the Plan and are classified within Level 1 of the valuation hierarchy. There are no significant restrictions on redeeming these investments at net asset value.
- The common collective trust funds are public and private investment vehicles valued using the NAV provided by the administrator of the fund. The NAV is based on the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is calculated based upon inputs other than quoted prices that are directly or indirectly observable. Financial reporting reviewed the annual report for the common collective trusts, noting that 99.9% of the investments contained within the Invesco Stable Asset Fund and the Putnam Stable Value Fund are classified as a Level 1 and Level 2 in the fund's financial statements, which approximates fair value. The common collective trust funds have a daily NAV of \$1.00 per unit which is considered readily determinable, and therefore, classified within Level 2 of the valuation hierarchy. The common collective trust funds have no redemption restrictions, and no unfunded commitments.

**D. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024, and 2023, and net realized and unrealized gains on investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed and derived from information certified as complete and accurate by T. Rowe Price Trust Company, the “Trustee” of the Plan.

#### **E. Tax Status**

The Plan adopted a Prototype Non-standardized Profit Sharing Plan with CODA which has a favorable opinion letter, dated August 19, 2020, from the Internal Revenue Service (“IRS”). This opinion letter states that the form of the prototype plan is acceptable under Section 401 of the Code. The Company may rely on this letter with respect to the qualification of the Plan under Code Section 410(a) with certain limitations.

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Company believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there is currently no audit in progress for any tax periods.

#### **F. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, all amounts credited to participant’s accounts will become 100% vested.

#### **G. Party-In-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

The Plan invests in shares of a mutual fund managed by the Trustee. Transactions in such investments, as well as loans made to participants, qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.
