### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the McConkey Auction Group 401k Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ## Notes to Financial Statements

### Note 1 – Description of the Plan

The following description of the McConkey Auction Group 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information not included in these notes.

- a. **General** – Effective January 1, 1997, the sponsor, GB Auctions, Inc. dba Dealers Auto Auction (the Company) adopted a volume submitter, defined contribution, qualified retirement plan commonly referred to as a 401(k) plan. The Plan, which is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and all subsequent statutory revisions thereto, was created for the benefit of all eligible employees. Prior to January 1, 2021, the Plan name was Dealers Auto Auction 401(k) Profit Sharing Plan. Effective January 1, 2021, the Plan name was changed to McConkey Auction Group 401(k) Profit Sharing Plan.
- b. **Eligibility** – Employees are automatically enrolled in the Plan to make contributions and are eligible to receive allocations of employer contributions. Eligible employees may make contributions to the Plan if they have completed one year of service (1,000 hours), are age 19 or older, are not part of a collective bargaining agreement, and are not nonresident aliens.
- c. **Contributions** – Each year, eligible employees may contribute (through an elective deferral of compensation) up to the lesser of 100% of their qualified compensation, or the maximum amount allowed by the Plans discrimination tests. In any case, employee contributions cannot exceed the maximum amount allowed under the Internal Revenue Code (IRC). Employee contributions are fully vested. Additionally, the Company will make a safe harbor matching contribution equal to the lesser of 100% of salary deferrals or 4% of an employee's qualified compensation. Safe harbor contributions are fully vested. The Company may make other contributions equal to a discretionary percentage of employees' deferrals, a percentage which is determined each year. Company contributions are subject to vesting and additional special tests.
- d. **Participant accounts** – Separate accounts are maintained for each participant. Each participant's account is credited with the participant's contribution, an allocation of any Company contributions, the participant's portion of earnings (losses), and charged with an allocation of administrative expenses. Participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- e. **Vesting** – A participant is 100% vested in their participant elected contributions and actual earnings thereon. Employer discretionary contributions are vested based on a six-year graded vesting schedule. All employer contributions become 100% vested upon a participant's retirement, death, or disability. Normal retirement age is 65.
- f. **Forfeitures** – The nonvested portion of a participant's account is forfeited upon termination of employment. Forfeitures of employer matching contributions are first used to pay plan expenses and then to reduce future employer matching contributions. During 2024 and 2023, forfeited participant account balances totaled \$3,855 and \$3,488, respectively. Forfeitures of \$13,901 were used during 2024 to reduce plan expenses.

### Note 1 – Description of the Plan (Continued)

- g. **Payment of benefits** – A participant is eligible to receive benefits equal to the value of the vested interest in his or her account upon termination of employment or as in-service withdrawals after attaining age 59½, subject to certain requirements. Benefits are paid under various options as defined in the Plan. Withdrawals due to financial hardship are not permitted.

### Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The accounting records of the Plan are maintained on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- c. **Investment valuation and income recognition** – The Plan's investments are stated at fair value, as certified by the Plan's custodian, Reliance Trust Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- d. **Payment of benefits** – Benefits are recorded when paid.
- e. **Administration of the Plan** – Plan assets are invested in accordance with the employee's instructions and maintained by Reliance Trust, the Plan's custodian. Records of participant account activity are processed and maintained by T. Rowe Price, which also performs other administrative support services for the Plan. Certain administrative functions are performed by officers or employees of the plan sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses of the Plan are paid by the Plan or the plan sponsor, as provided in the plan document.
- f. **Participant loans** – Participants may borrow up to the lesser of \$50,000 or 50% of the vested interest of the participant in the Plan to be repaid in level installments every payroll period via payroll deduction. The loans are secured by the participant's account balance and bear interest at the rate of prime plus 1% of the interest rate in effect when the loan is made. Participant should refer to the Plan's loan policy agreement for a more complete description of the Plan's provisions. Loans go into default if payments are not received for four consecutive months, and the remaining balance is considered a deemed distribution.

- g. **Subsequent events** – Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

### Note 3 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Level 1* – Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Level 2* – The Plan had no investments that are classified as Level 2 for either year ended December 31, 2024 and 2023.

*Level 3* – The Plan had no investments that are classified as Level 3 for either year ended December 31, 2024 and 2023.

### Note 4 – Plan Termination

Although it has not expressed any intent to do so, the employer has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### Note 5 – Tax Status

The Plan document is a volume submitter profit-sharing plan that received a favorable opinion letter from the Internal Revenue Service on March 31, 2014, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the opinion letter. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan’s qualified status.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator evaluated the Plan’s tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 6 – Related-party and Party-in-interest Transactions

Certain plan investments are shares of mutual funds managed by T. Rowe Price. Reliance Trust is the plan custodian, as defined by the Plan, and is an affiliate of T. Rowe Price. Therefore, transactions with T. Rowe Price are considered to be party-in-interest transactions.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the rules governing prohibited transactions under ERISA.

### Note 7 – Risks and Uncertainties

The Plan provides for investments in various investment options. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 8 – Information Certified by the Plan Custodian

As permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected that information certified by Reliance Trust, the plan custodian, not be subject to any auditing procedures except for comparing such information to the custodian information included in the financial statements and supplemental information. The following information has been certified by the plan custodian as complete and accurate:

- (a) Investments as indicated on the statements of net assets available for benefits;
- (b) Net appreciation in fair value of investments as indicated on the statements of changes in net assets available for benefits; and
- (c) Supplemental schedule – assets held for investment.
