## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator  
Navvis & Company 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of Navvis & Company 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Navvis & Company 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the Navvis & Company 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan adopted by Navvis & Company (the "Company") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan provides participants an opportunity to defer portions of their earnings to provide supplementary retirement income. Under the terms of the Plan, eligible employees who have attained age 21 may immediately start participation.

The Plan is administered by management of the Company. The Company has overall responsibility for the operation and administration of the Plan. The Company determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Trustees.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. Navvis & Company, the Plan Sponsor, has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

Contributions

The Plan provides for an automatic election to have participant contributions made at 3% of compensation, as defined. The participant may elect a different percentage or elect not to make participant contributions. The Plan also has an Annual Increase Program ("AIP") for all participants who were initially auto enrolled in the Plan. In accordance with the AIP, a participant's deferral percentage will increase by 1% annually up to a maximum automatic deferral of 6%.

The Plan also allows participants to make Roth 401(k) contributions. Participants may contribute up to 100% of their annual compensation through payroll deferrals, subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. In addition, participants aged 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

The Company will contribute to the Plan an amount equal to 3% of the compensation a participant earns. In addition, the Company may, at its discretion, make an additional match. During the years ended December 31, 2024 and 2023, the Company made no discretionary additional match contribution.

Participant investment account options

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers mutual funds as investment options for participants. Participants may change their investment options at any time.

Participant accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions and discretionary profit-sharing contributions, and allocations of Plan earnings and charged with an allocation of administrative expenses. Plan earnings are allocated based on the participants' share of net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

Safe harbor employer contributions are subject to the following vesting schedule:

If a participant attains normal retirement age as defined by the Plan, dies or becomes disabled while employed by the Company, the participant becomes fully vested. Nonvested portions of Company contributions are forfeited as of a participant's termination date.

Payment of benefits

Participants are entitled to receive the balance of their accounts upon retirement, death, total disability, termination of employment, reaching age 72, or upon request after reaching age 59 ½. Participants who have suffered a hardship (as defined by the IRC and the Plan) may also withdraw a portion of their account balances.

Notes receivable from participants

Participants may borrow from their accounts up to the lesser of 50% of their vested account balance or \$50,000. All loans are secured by the participant's vested account and are repayable in installments through payroll deductions, over a maximum of five years. The loans bear interest at rates that are commensurate with prevailing market rates as determined by the Plan administrator.

Forfeited accounts

As of December 31, 2024 and 2023, forfeited nonvested account balances totaled \$68,861 and \$35,017, respectively. These amounts will be used to reduce future employer contributions or to pay plan administrative expenses. Also, for the years ended December 31, 2024 and 2023, employer contributions were reduced by \$35,017 and \$2,618, respectively, from forfeited nonvested account.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies followed by the Plan are described below:

Basis of accounting

The financial statements were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Sponsor to make estimates and assumptions that affect certain reported amounts of assets and liabilities therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions and contributions receivable

Contributions from participants and related receivables are recorded based on the date the contributions are separated from the participants' pay. Contributions from the Company are recorded in the year earned and coincide with the year in which the Company records the contributions to its general ledger. The Plan records receivables for contributions based upon the contributions recognized, less amounts received by the Plan as of the day of the Plan year. Rollover contributions from participants are recorded based on the date the rollover contributions have been received by the Plan's trustee.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

Subsequent events were evaluated through September 26, 2025, which is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the following information was certified by AdvisorTrust, Inc. as of and for the years ended December 31, 2024 and 2023, and was not subjected to any auditing procedures, except for comparing such information with the related information contained in the accompanying financial statements and schedule:

- All investments and notes receivable from participants as of December 31, 2024 and 2023, which are included in the statements of net assets available for benefits.
- Dividends and interest and net realized and unrealized appreciation in fair value of investments for the years ended December 31, 2024 and 2023, which are included in the statements of changes in net assets available for benefits.
- All information regarding assets held by the Plan at December 31, 2024, included in the Schedule H, Line 4i - Schedule of Assets (Held at End of Year).

4. FAIR VALUE MEASUREMENTS

The fair value framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quote prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. FAIR VALUE MEASUREMENTS (continued)

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There has been no change in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

5. INCOME TAX STATUS

The Plan's document is a non-standardized prototype agreement that received a favorable tax opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020. Although the Plan has been amended since receiving the tax opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that the related trust was tax exempt as of December 31, 2024.

6. RISKS AND UNCERTAINTIES

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. PARTY-IN-INTEREST TRANSACTIONS

As defined by the Plan, PCS Retirement, LLC is the recordkeeper, and Acropolis Investment Management, LLC is the fiduciary investment advisor and, therefore, these transactions qualify as permitted party-in-interest transactions. Fees paid by the Plan for investment and advisor fees are reflected in administrative expenses.

8. PLAN TERMINATION

As a result of a reduction of the Plan Sponsor's workforce which occurred during 2024, management determined that the plan underwent a partial plan termination. As a result of the partial plan termination, impacted participants of the Plan became fully vested in all applicable contributions and earnings.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.
