1. DESCRIPTION OF PLAN

The following description of the I. Kitagawa and Company, Ltd. 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a 401(k) savings plan covering all full-time employees of the Company. An employee shall be deemed an eligible participant for a plan year if he completes one year of service during that plan year and is age 21 or older. An eligible participant can share in Company contributions if he is credited with at least 1,000 hours of service during the plan year and is still an employee on the last day of the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Administration of Plan Assets

Empower Trust Company, LLC is the trustee and custodian of the Plan. The Plan utilizes an insurance product and the contract was issued by Empower Annuity Insurance Company of America.

c. Contributions

Each year, participants may contribute a percentage of their pretax or after-tax annual compensation as defined in the Plan agreement up to the maximum amounts allowable under the Internal Revenue Code (IRC) of \$23,000 and \$22,500 in 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Additionally, participants who attain age 50 before the end of the calendar year may contribute catch-up contributions up to an additional \$7,500 for the Plan years ended December 31, 2024 and 2023.

The Company may, in its sole discretion, make a matching contribution to eligible employees who participate in the plan. During the years ended December 31, 2024 and 2023, the employer made a matching contribution of up to 3% of the employee's contribution.

The Company may also elect annually to contribute, regardless of whether the employee contributes to the plan, an amount not to exceed 25% of annual wages of the eligible employees participating in the plan. The Company may allocate its own funds in a different manner if necessary to prevent discrimination against lower paid employees or violation of the legal contribution ceiling.

All contributions are invested ratably in the investment options selected by the participants and any Company contributions are subject to the vesting guidelines discussed below. Participants may change their investment options at any time.

d. Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution, if any, (b) Plan earnings (losses), and (c) forfeitures of terminated participant's non-vested accounts; and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan currently offers one guaranteed investment contract and shares in 25 registered investment companies as investment options for participants.

e. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant is 100% vested after three years of credited service.

f. Notes Receivable from Participants

Participants may borrow from their fund accounts for a minimum of \$1,000 and up to the maximum amount not exceeding the lesser of (i) \$50,000 reduced by the excess (if any) of the highest outstanding balance of such loans to the Participant during the one-year period ending on the day before the Loan Date over the outstanding balance of such loans on the Loan Date or (ii) 50% of the Participant's vested accrued benefits under such plans. The loans are secured by the balance in the participant's account. The loan interest rate varies between 4.25-9.50%.

g. Payment of Benefits

On termination of service, and subject to any special valuation provisions set forth by the Plan, the Trustee shall distribute the vested portion of the Participant's accounts, valued as of the last day of the preceding valuation period, minus any interim distributions and plus any interim allocations.

Outside of a few exceptions, the participants, upon termination will receive their vested balance in one lump sum payment. Partial or installment distribution may be permitted if needed to satisfy the required minimum distribution rules.

h. Forfeitures/Asset Holding Account

Forfeitures are non-vested portion of a participant's account and shall be used in the following manner: restore forfeitures, reduce employer contributions, or to pay reasonable plan expenses. There were no forfeitures in 2024 and 2023.

The asset holding account is funded by plan assets to pay for plan expenses, such as advisor fees and contract administrator fees. At December 31, 2024 and 2023, the forfeitures/asset holding account totaled \$45,550 and \$32,123, respectively. These amounts are part of the Key Guaranteed Fund Portfolio.

i. Administrative Expenses

All expenses incurred in the administration of the Plan shall be paid out of the Fund, unless the Company in its discretion or as required by law elects to pay certain expenses directly or reimburse the Fund for them.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of Accounting

The Plan's financial statements are prepared using the accrual basis of accounting generally accepted in the United States of America.

b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and insurance company. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

e. Net Appreciation (Depreciation) in Fair Value of Investments

Realized and unrealized appreciation (depreciation) in fair value of investments is based on the difference between the fair value of assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

f. Payment of Benefits

Benefits are recorded when paid.

g. Date of Management's Review

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820, *Fair Value Measurement and Disclosure*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 input consists of unadjusted quoted prices in active markets for identical assets and liabilities, Level 2 inputs consists of observable inputs, other than quoted prices for identical assets and liabilities, and Level 3 inputs are unobservable inputs, other than quoted prices for identical assets and liabilities, supported by little or no market activity. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of investments. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

As of December 31, 2024 and 2023, the Plan held only Level 1 assets as described below:

Level 1 Fair Value Measurements – the fair value of the shares of registered investment companies is determined using the net asset value of the units held by the Plan at year end.

5. **GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$535,641 and \$474,503, respectively.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The actual average yield earned by the plan for the benefit responsive fund can be derived by averaging the plan's quarterly interest rates. The average for 2024 and 2023 is 1.41% and 1.23% respectively.

Certain events limit the Plan's ability to transact at contract value with Empower Annuity Insurance Company of America. Such events include, but are not limited to: spin-off; sale; merger; full or partial plan termination, including distribution of assets performed by a qualified termination administrator, as that term is defined under federal law and regulations promulgated thereunder, or comparable person as allowed by applicable law. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Either party to the group annuity contract may terminate the contract with at least 60 days advance written notice to the other party. The contract termination date shall be any business day on or after the expiration of the 60-day notification period.

6. PARTY-IN-INTEREST

The Plan invests in a group annuity contract managed by Empower Annuity Insurance Company of America, which is the parent company of Empower and its affiliates and, therefore, qualify as party-in-interest transaction.

For the years ended December 31, 2024 and 2023, the Plan paid \$15,076 and \$12,993, respectively, for administrative services. These transactions are exempt from the prohibited transaction rules of ERISA.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their respective accounts.

8. REPORTABLE TRANSACTIONS

The Plan had no reportable transactions as defined in 29 CFR 2520.103-8.

9. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated September 29, 2010 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since that determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Company has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

The market volatility of equity-based investments is expected to substantially impact the value of such investments at any given time. It is likely that the value of the Plan's investments, both in total and in individual participant accounts, has fluctuated since December 31, 2024.
