### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Legacy Health Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Legacy Health Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We are required to be independent of Legacy Health Defined Contribution Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ### Note 1 – Description of Plan

The following description of the Legacy Health Defined Contribution Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

**General** – The Plan is a noncontributory defined contribution plan covering substantially all employees of Legacy Health, and is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Legacy Health (the Sponsor) is the Plan's sponsor and serves as plan administrator.

**Eligibility** – An employee must be a qualified employee to be eligible for participation in the Plan. Qualified employees exclude employees covered by a collective bargaining agreement that does not provide for participation in the Plan, students, residents, interns, post-doctoral research fellows, chaplains, and leased or temporary employees. A qualified employee is eligible to receive employer matching contributions upon reaching age 21, has completed one year with 1,000 or more hours of service, and is participating in the Legacy Health 403(b) Plan (403(b) Plan). A qualified employee is eligible to receive employer nonelective contributions upon reaching age 21 and is participating in the Legacy Health 403(b) Plan (403(b) Plan).

### Contributions –

*Employer matching contributions* – An employee with less than 10 vested years of service receives employer contributions equal to 50% of the employee's 403(b) Plan contributions, up to 5% of the employee's compensation. An employee with 10 to 15 vested years of service receives employer contributions equal to 60% of the employee's 403(b) Plan contributions, up to 5% of the employee's compensation. An employee with 16 or more vested years of service receives employer contributions equal to 70% of the employee's 403(b) Plan contributions, up to 5% of the employee's compensation. Participants must be employed at the end of the Plan year to receive a contribution, unless the participant's employment ends through a qualifying event as defined in the Plan Agreement.

*Employer nonelective discretionary contributions* – An employee with less than 6 vested years of service will receive nonelective employer contributions equal to 2.5% of the employee's compensation. An employee with 6 to 10 vested years of service will receive employer nonelective contributions equal to 4% of the employee's compensation. An employee with 11 to 15 vested years of service will receive employer nonelective contributions equal to 5% of the employee's compensation. An employee with 16 to 20 vested years of service will receive employer nonelective contributions equal to 6% of the employee's compensation. Employees with over 21 vested years of service will receive employer nonelective contributions equal to 7% of the employee's compensation.

Contributions to the Plan are made by the Sponsor and are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with an allocation of the (a) Sponsor's contributions and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participants may direct the investment of their account balances into various investment options offered by the Plan. The Plan currently offers various mutual funds, self-directed brokerage accounts, collective trusts, and an insurance investment contract as investment options for participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Vesting in the Sponsor’s contribution is based on years of service. For employer matching contributions, a participant is 100% vested after five years (20% each year) of credited service. For employer nonelective discretionary contributions, a participant is 100% vested after three years of credited service. Vesting service is one calendar year for each service period in which a participant has 1,000 or more hours of service.

**Payment of benefits** – On termination of service due to severance of employment, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments. Various annuity types are available depending on the type of underlying investment. If the total balance of a participant’s account does not exceed \$5,000 for balances paid prior to April 1, 2024, or \$7,000 for balances paid after April 1, 2024, the balance will be paid in a lump sum upon the participant’s termination of employment or death. If the total balance of a participant’s account exceeds \$1,000 but does not exceed \$5,000 (prior to April 1, 2024) or \$7,000 (after April 1, 2024), and the participant does not elect to have the distribution paid directly to an eligible retirement plan in a direct rollover or to receive the distribution directly, the balance will be paid in a direct rollover to an individual retirement account designated by the Retirement Committee.

**Forfeitures** – Forfeitures are the non-vested portion of a participant’s account that are lost upon termination of employment. Forfeitures are retained in the Plan and will first be used to restore the forfeitures of participants rehired before five consecutive one-year breaks in service, with any remaining amount used to reduce future Sponsor contributions or to pay Plan expenses. At December 31, 2024 and 2023 there were unused forfeitures of \$1,914,705 and \$1,404,091, respectively. During the year ended December 31, 2024, employer matching contributions were reduced by \$1,404,091 from forfeited nonvested accounts.

#### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The Plan’s investments are reported at fair value with the exception of the fully benefit-responsive investment contract, which is stated at contract value. The investment in the guaranteed investment contract consists of the Lincoln Stable Value Separate Account. The Plan’s custodian, Lincoln Financial Group Trust Company Inc., certifies the contract value of the guaranteed investment contract and the fair value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized depreciation and appreciation of those investments.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Certain administrative expenses of operating and maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Certain transaction fees and administrative expenses are paid by the Plan and are included in these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

#### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

*Collective trusts* – Units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 4 – Guaranteed Investment Contract**

The Plan invests in a fully benefit-responsive guaranteed investment contract (FBRIC) with Lincoln National Life Insurance Company (Lincoln). Lincoln maintains the contributions in a separate account and the investment is backed by the general account of the issuing company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The contract meets the FBRIC criteria and therefore is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- Failure to abide by state or federal law
- A breach of material obligation under the contract
- Failure to maintain assets of at least \$25,000
- Failure to make adoptions to the Plan in a reasonable period of time

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### **Note 5 – Tax Status**

The Internal Revenue Service has determined and informed the Sponsor by a letter dated September 28, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IR and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 6 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

### **Note 7 – Certified Investment Information**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial Group Trust Company, Inc., the custodian of the Plan, has certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividend income, and interest income on guaranteed investment contract reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

### **Note 8 – Party-In-Interest Transactions**

Certain Plan investments are managed by Lincoln National Corporation. Lincoln Financial Group Trust Company, Inc. is the custodian of the Plan and an affiliate of Lincoln National Corporation and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

Plan investments include the Lincoln Group Stable Value Contract, which is a guaranteed investment contract managed by Lincoln National Life Insurance Company, an affiliate of the custodian of the Plan (Lincoln Financial Group Trust Company) and, therefore, transactions with this entity qualify as exempt party-in-interest transactions.

#### **Note 9 – Plan Termination**

Although it has not expressed any intention to do so, the Sponsor has the right to terminate the Plan and discontinue contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

#### **Note 10 – Reconciliation to Form 5500**

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
