NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Gaylord Hospital, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all nonunion employees of Gaylord Hospital, Inc. (the Hospital) on their date of hire. Per diem employees must complete at least 1,000 hours of service in order to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan. Participants may direct their contributions as either pre-tax or Roth contributions. Employees are automatically enrolled at a 2% deferral rate of pre-tax contributions upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Hospital may, at its discretion, make a matching contribution. For the year ended December 31, 2024, the Hospital made a discretionary matching contribution to the account of each eligible employee equal to 100% of the first 2% of eligible compensation that a participant contributes to the Plan. Employees must complete one year of service in order to be eligible for the discretionary matching contribution. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Hospital's contributions, (b) Plan earnings/(losses), and (c) forfeitures, and is charged with their withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of their account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of their account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their contributions and rollover plus actual earnings thereon. Vesting in the remainder of their accounts, plus earnings thereon, is based on years of continuous service. A participant is 100% vested after three years of credited service. Prior to 2010, the Hospital made certain non-matching contributions. A participant is 100% vested in these non-matching contributions after five years of credited service.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in their account. Benefit amounts under \$5,000 are automatically distributed to participants. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a lump sum or installments. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants: Participants may borrow from their participant account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions.

Forfeitures: Forfeitures of employer matching contributions are used to offset future employer matching contributions or administrative expenses of the Plan. As of December 31, 2024 and 2023, forfeited unallocated accounts totaled \$65,095 and \$70,583, respectively. For the year ended December 31, 2024, \$36,269 of forfeitures were utilized to offset administrative expenses.

Plan Termination: Although it has not expressed any intent to do so, the Hospital has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Hospital contributions and earnings thereon.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Hospital and are excluded from these financial statements. Plan recordkeeping and contract administration fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as investment income and included in the net appreciation in fair value of investments reported by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than the fully benefit responsive investment contracts, are reported at fair value, as further described in Note 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, and risks pertaining to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 13, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company, the custodian of the Plan, and Transamerica Life Insurance Company (TLIC), trustee of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Traditional Guaranteed Investment Contract: The Plan holds a traditional guaranteed investment contract that is not fully benefit-responsive and, accordingly, it is measured at fair value. Fair value is estimated on an annual basis for financial statement reporting purposes only, as participant transactions are typically executed at contract value. The fair value of the contract has been determined to approximate contract value.

NOTE 5 - TRADITIONAL GUARANTEED INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive traditional investment contract with TLIC. This contract is a fully benefit responsive traditional investment contract that is reported at contract value as of December 31, 2024 and 2023. Amounts deposited under this traditional group annuity contract are held with general assets of TLIC.

As described in Note 2, because the guaranteed fixed annuity account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by TLIC, represents the accumulation of contributions, plus interest, less funds used to pay benefits and expenses. The contract value of the account was \$4,162,333 and \$4,253,492 as of December 31, 2024 and 2023, respectively.

Participants could withdraw their balances at contract value without restriction or charge on account of any of the following events: death, disability, retirement, terminations of employment, hardship, loans, attainment of age 59 ½, the purchase of an annuity from TLIC, or transfers to a non-competing fund. Benefit responsive withdrawals from this contract during any twelve-month period that are made on account of employer initiated events and in aggregate in excess of 15% of the contract balance at the beginning of such twelve-month period shall be subject to a withdrawal adjustment. TLIC will pay participant-elected withdrawals of all or a portion of the participant account that do not constitute benefit responsive withdrawals, to the extent permitted by the Plan and authorized by the contractholder, but such payments will be subject to a withdrawal adjustment with respect to the requested withdrawal amount.

NOTE 5 - TRADITIONAL GUARANTEED INVESTMENT CONTRACT (Continued)

The repayment of principal and interest credited to participants is a financial obligation of TLIC. Guarantees are based on the claims-paying ability of the issuer. As of December 31, 2024 and 2023, there are no reserves against contract value for credit risk of the contract issuer or otherwise.

The contract contained a minimum guaranteed interest rate, which will not be less than 1%. At the beginning of each calendar year, TLIC determines the declared interest rate, which will be credited to all monies invested in the guaranteed separate account during such calendar year. In no event will the declared rate of interest be less than the contracts minimum guaranteed interest rates. As of December 31, 2024 and 2023, the declared interest rate is 2.65% and 2.35%, respectively.

Certain events limit the Plan's ability to transact at contract value with TLIC. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable.

The plan administrator does not believe any events or circumstances would allow the issuer to terminate the contract with the Plan and settle at an amount different than contract value exist.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Hospital. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Hospital. The Plan holds guaranteed fixed annuity accounts managed by TLIC and Transamerica Financial Life Insurance Company, Inc. (TFLIC). TLIC and TFLIC are service providers to the Plan and, therefore, these transactions and the Plan's payment of fees to TLIC and TFLIC qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 7 - TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
