Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Note 1. Plan Description**

The following description of Gabrielli Savings and Retirement Plan for Employees (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering eligible employees of Gabrielli Holding LLC, Gabrielli Truck Sales of Connecticut LLC, Gabrielli Kenworth of New Jersey LLC, and Gabrielli Truck Leasing LLC, ("the Companies" or "the Company"). The Plan was amended effective March 1, 2021, in order to provide past service credit for employees who were employed by Browns Hunterdon Mack Sales and Service immediately prior to the closing of the business transaction involving Browns Hunterdon Mack Sales and Service and Gabrielli Truck Sales Ltd. and who became employees of Gabrielli Truck Sales Ltd. in connection with the transaction. The plan was amended effective August 9, 2021, in order to provide past service credit for employees who were employed by Albany Truck Sales immediately prior to the closing of the business transaction involving Albany Truck Sales and Gabrielli Truck Sales Ltd. and who became employees of Gabrielli Truck Sales Ltd. in connection with the transaction. The plan was amended effective January 3, 2022, in order to provide past service credit for employees who were employed by Mid-Hudson Mack immediately prior to the closing of the business transaction involving Mid-Hudson Mack and Gabrielli Truck Sales Ltd. and who became employees of Gabrielli Truck Sales Ltd. The plan was amended effective September 17, 2022, approving Gabrielli Kenworth of CT, LLC as a participating employer effective October 1, 2022 and in order to provide past service credit for employees who were employed by Tri-State Kenworth immediately prior to the closing of the business transaction involving Tri-State Kenworth and who became employees of Gabrielli Kenworth of CT, LLC. Participants become eligible to participate in the Plan after attaining age 21 and completing one year of service. A year of eligible service is based on 1,000 hours of service in the first twelve months of employment, or any subsequent calendar year. VOYA Retirement Insurance and Annuity Company ("VOYA") serves as the custodian and Associated Pension Consultants serves as the record keeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

***Contributions***

Each year, participants may contribute compensation, as defined in the plan document, subject to Internal Revenue Code ("IRC") limitations. The Plan allows for Roth 401(k) (after-tax) salary deferrals along with traditional 401(k) (pretax) deferrals. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. The Company may elect to contribute up to 2% of an employee's first \$75,000 of compensation with a maximum contribution of \$1,500. Participants may also contribute amounts representing distributions from other qualified pension or profit-sharing plans.

***Investment Options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers a variety of pooled separate accounts and a fixed interest account.

***Participant Accounts***

Each participant account is credited with the participant's contribution, the Company's contributions, and allocation of the Plan's earnings (losses), and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 2% above the prime interest rate. Repayments are generally made by payroll deductions. The maximum loan term is five years, with exception of loans used to purchase the participant's principal residence. Those loans have a maximum term of five years. At December 31, 2024, outstanding loans bore interest rates from 4.25% to 10.50%.

***Payment of Benefits***

Upon leaving the Company for any reason including termination, death, disability, or retirement, participants may received the vested balance in their accounts as a single lump-sum; if the participant's account balance is in excess of \$5,000, monthly payments may be received, or payments may be deferred until age 72 (70-1/2 for participants who attained age 70-1/2 prior to January 1, 2020). Under certain circumstances, the Plan may permit hardship withdrawals.

***Forfeitures***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$56,484 and \$47,168, respectively. These accounts will be used to pay Plan expenses and then to reduce employer contributions. During 2024, forfeitures of \$6,865 were used to reduce Employer contributions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Excess Contribution Payable***

Amounts payable to participants for ineligible contributions and contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan required corrective distributions of \$166,341 related to 2024 ineligible contributions. The Plan distributed the 2024 ineligible contribution to the applicable participants as of March 3, 2025.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Plan sponsors, as provided by the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distribution payments are charged directly to the participant's account and are included in administrative expenses. In addition, accounting, recordkeeping, and investment advisory fees paid by the Plan are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

***Subsequent Events***

The Plan has evaluated subsequent events through October 10, 2025 the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices included within level 1 that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan’s assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Pooled Separate Accounts***

The Plan invests in pooled separate accounts for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value (“NAV”) of units, as determined by VOYA as the estimated fair value. Because quoted prices in active markets for identical assets are not available, these prices are determined using observable market information such as quotes from less active markets and/or quoted prices of securities with similar characteristics.

The Plan held no investments within the fair value hierarchy as of December 31, 2024 and 2023.

The following table summarizes pooled investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

- a) These investments consist of stocks of companies within the United States and developed countries outside of the United States. International investing provides for greater diversification benefits than domestic securities alone and demonstrates the greatest volatility of performance.
- b) These investments seek capital appreciation by investing primarily in stocks of small and medium sized companies that are striving to develop new products or markets and have above average earnings growth potential. Funds carry higher risk than other domestic funds.
- c) These investments consist of funds that seek a combination of growth and income and exhibit a lower level of price volatility.

The asset allocation mixture is refined regularly based on market conditions in order to achieve the best risk adjusted performance.

**Note 4. Fully Benefit-Responsive Fixed Interest Account**

The Plan has a guaranteed investment contract (the "fixed interest account") with VOYA that totaled \$ 6,603,088 and \$8,337,203 as of December 31, 2024 and 2023, respectively. VOYA maintains contributions in a general account. The account meets the fully benefit-responsive investment contract criteria, and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The account's issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The account is a traditional investment contract under which the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on credit rates established by contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers. Such interest rates are reviewed on an annual basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with issuers. Such events include the following: (1) amendments to the Plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) premature termination of the investment contract, or (5) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material representation or (4) a material amendment to the agreements without consent of the issuer.

**Note 5. Unaudited Information Certified by Custodian**

The accompanying financial statements include the following unaudited information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that was obtained from data prepared and certified to be complete and accurate by VOYA.

**Note 6. Exempt Party-in-Interest Transactions**

Certain Plan investments are shares of pooled separate accounts managed by VOYA, which serves as the custodian as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid by the Plan to Associated Pension Consultants, Inc for administrative services amounted to \$109,412 for the year ended December 31, 2024.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 8. Tax Status**

The IRS has determined and informed the Company by a letter dated March 2, 2011, stating that the Plan and related trust are designated in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
