Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Associated Food Stores, Inc. 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution for the years ended December 31, 2024 and 2023 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

(1) PLAN DESCRIPTION

The following description of the Associated Food Stores, Inc. 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution, multiple-employer plan operated by Associated Food Stores, Inc and covered employers which have adopted the Plan (collectively referred to as the "Participating Employers".) The Investment Committee of the Participating Employers controls and manages the operation and administration of the Plan. Transamerica Retirement Solutions, LLC (Transamerica) serves as custodian of the Plan. The Plan's investments are administered by Transamerica. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Each Participating Employer may modify the provisions of the Plan for its own employees based on their individual adoption agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is designed to be compliant with the Safe Harbor Provisions of e-CFR 26 §1.401(k)-3.

(b) Employee Eligibility

An employee is eligible to participate in the Plan based on the individual adoption agreements of each Participating Employer. Once the eligibility requirements are met, an employee may enter the Plan.

(c) Employee Contributions

Employees may elect under a salary reduction agreement to contribute up to 25 percent of before-tax gross compensation. Contributions are limited by the Internal Revenue Code, which established a maximum employee contribution amount of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023. Participants age 50 and older may contribute an additional \$7,500 for the years ended December 31, 2024 and 2023. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans.

(d) Employer Contributions

Participating Employers may make contributions to the Plan in the form of matching contributions or discretionary profit sharing contributions. The matching contributions are determined annually by the Participating Employers within the Plan.

(e) Investment Options

Participants may direct contributions to any of the investment options as detailed in the accompanying schedule of assets (held at end of year).

(1) PLAN DESCRIPTION (CONTINUED)

(f) Vesting Schedule

Participants are vested immediately in their participant contributions plus actual earnings thereon. Vesting in the Participating Employers' contribution portion of their accounts is based on years of continuous service and the individual adoption agreements of each Participating Employer.

(g) Distribution of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

(h) Plan Termination

Although the Participating Employers have not expressed any intent to do so, it has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA.

(i) Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with (1) the participant's contribution, (2) the Employer's contribution, and (3) an allocation of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(j) Notes Receivable from Participants

Participants may borrow from their fund accounts based on the individual adoption agreements of each Participating Employer.

(k) Allocation of Earnings

The net increase or decrease in the value of each investment fund attributed to interest, changes in market value, expenses, and gains and losses realized from the sale of assets is allocated to employees' accounts based upon relative fund account balances.

(l) Hardship Withdrawals

Participants may withdraw their vested account balance, subject to certain limitations, in the event of undue hardship.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

(a) Basis of Presentation

The Plan's financial statements are presented on the accrual basis of accounting.

(b) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value or its equivalent when the fair value is not readily determinable.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded as earned. Dividends on mutual funds are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year.

(c) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

(d) Other Income and Administrative Expenses

For the years ended December 31, 2024 and 2023, other income is comprised of investment fund management fees refunded to the Plan by Transamerica. Administrative expenses consisted of loan fees, administrative custodial fees, and professional fees from independent consultants.

(e) Risk and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to a variety of risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such a change could materially affect the amounts reported in the statements of net assets available for benefits.

(f) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) INFORMATION CERTIFIED BY THE PLAN CUSTODIAN

The following data has been certified as complete and accurate by the Plan custodian:

- (a) Investments included in the statements of net assets available for benefits;
- (b) Investment income included in the statements of changes in net assets available for benefits, comprised of net appreciation in market value of investments, interest and dividends; and
- (c) Information included in supplemental Schedule 1 - Schedule H, Line 4i - Schedule of Assets (Held at End of Year).

(4) TAX STATUS OF THE PLAN

The Participating Employers adopted a Defined Contribution Pre-Approved Plan, intended to conform to and qualify under §401 and §501 of the IRC of 1986, as amended. In the opinion of the Plan administrator, the Plan and the underlying trust are being operated in compliance with the applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

(5) FAIR VALUE OF INVESTMENTS

The Plan adopted FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*. ASC 820 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

- Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets or liabilities;
- Level 2 - Quoted prices for identical or similar assets or liabilities in markets that are not considered to be active or identical or similar financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurements and unobservable.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuations techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. In periods of market inactivity, the observability of prices and inputs may be reduced for certain instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2 or from Level 2 to Level 3.

Investments in registered investment companies (mutual funds) traded on national securities exchanges are valued at quoted closing prices on the last business day of the year.

(6) GUARANTEED INCOME AND STABLE VALUE FUND

The Guaranteed Income Fund (GIF) is a group annuity product issued by Prudential Retirement Insurance and Annuity Company (PRIAC). Amounts contributed to the contract are deposited in PRIAC's general account. Payment obligations and the fulfillment of any guarantees specified in the group annuity contract are insurance claims supported by the full faith and credit of PRIAC. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract is affected directly between the Plan Sponsor and the issuer. The repayment of principal and interest credited to participants is a financial obligation to the issuer. Given these provisions, Prudential considers this contract to be benefit responsive. Therefore, contract value is the only required measure.

The Stable Value Strategy Fund offered by Transamerica Life Insurance Company seeks to protect against loss of principal while providing returns in excess of money market funds and one-year treasury bills. The Stable Value Strategy Fund has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis and there is no set maturity. The effective interest rate is set monthly and effective on the first day of the month. Contract charges may reduce this return. Deposits to this account are invested in the Transamerica Life Insurance Company's general account.

(7) COLLECTIVE TRUST ACCOUNTS

Investments in collective trust accounts (CT) are valued at the net asset value of units held by the Plan at year end reflecting the closing price reported on the applicable active market on which the underlying investments in equity securities are traded. ASC 820 allows net asset value (NAV) per share to serve as a practical expedient to estimate the fair value of a CT as long as certain requirements are met. The Plan's CT's meet those requirements. The CT's can be redeemed at NAV on a daily basis. Unfunded commitments typically are found in private equity funds and therefore are not applicable to CT's.

(8) RELATED PARTY TRANSACTIONS

Certain Plan investments are interests in pooled separate accounts managed by Transamerica Retirement. Transamerica Retirement is an affiliate of Transamerica, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest. However, these are not considered prohibited transactions by statutory exemptions under ERISA regulations.

(9) TRANSFERS

During 2024, the Plan had 17 new Participating Employers whose transfers into the Plan totaled \$28,945,782.

(10) SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 13, 2025, the date the financial statements were available to be issued, no subsequent events were noted.
