NOTES TO FINANCIAL STATEMENTS

Note A. Description of Plan

The following description of the Radiology Associates of Central Florida, P.L. 401(k) Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan was amended and restated effective February 12, 2021 to bring the Plan in compliance with Internal Revenue Code ("IRC") requirements. The Plan is a defined-contribution plan covering significantly all employees of Radiology Associates of Central Florida, P.L. (the "Company") and of Lake Medical Imaging and Breast Center at the Villages, LLC, an affiliate of the Company, who have completed one year of service and attained age 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan was established October 1, 1982.

Contributions – Each year, participants may contribute up to 100% of eligible compensation on a pre-tax or Roth basis, subject to annual limits, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company makes safe harbor contributions of 3% of a participant's compensation and may make additional profit-sharing amounts at the option of the Company's Board of Directors. The Company may also elect to make matching contributions equal to 100% of each eligible participant's elective deferral which does not exceed 2% of compensation. Those who are not employees at the end of the Plan year are not eligible for the discretionary match.

Participant Accounts/Vesting – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants are immediately vested in their contributions and Company safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service (0% in year one, 20% each year thereafter), upon attainment of normal retirement age as defined by the Plan, and if he or she incurs severance from employment as a result of death or disability.

Payment of Benefits – On termination of service, retirement, disability, or death, a participant or his or her beneficiary may elect to receive either a lump-sum amount equal to the vested value of his or her account, or payments in monthly, quarterly, or annual installments over a period not exceeding the life expectancy of the participant and his or her beneficiary. Upon attainment of normal retirement age, participants who continue employment with the Company may elect to receive all or any portion of his or her account balance. Participants may also receive distributions for financial hardships if they satisfy certain conditions.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Note A. Description of Plan (Continued)

Investment Options – Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a group annuity contract as investment options for participants. The Plan also permits participants to establish a Personal Portfolio Account in order to invest in securities other than the selected investment options.

Forfeited Accounts – Forfeited balances of terminated participants' nonvested accounts are used to reduce Plan expenses, reinstate previously forfeited account balances of participants, or reduce future Company contributions. At December 31, 2024 and 2023, forfeitures available to be applied were \$14,245 and \$8,820, respectively. In 2024, \$268 of forfeitures was used to pay Plan expenses and \$13,977 of forfeitures was used to reduce employer contributions.

Plan Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain fees related to distributions and administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Note B. Summary of Significant Accounting Policies

Basis of Accounting – The Plan uses the accrual basis of accounting to prepare the financial statements.

Benefit Payments – Benefit payments are recorded when paid.

Investment Valuation and Income Recognition – Investments are reported at fair value (except for group annuity contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest and dividends are recorded when received. There is no significant difference between the settlement-date basis and trade-date basis of accounting for the periods presented. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Note B. Summary of Significant Accounting Policies (Continued)

Subsequent Events – The Plan has evaluated subsequent events and transactions for potential recognition and presentation through the date the financial statements were available to be issued, October 9, 2025.

Note C. Unaudited Information

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received certifications from Empower Annuity Insurance Company of America and Empower Trust Company, LLC, Custodian and Trustee, respectively, of the Plan, acknowledging the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, the supplemental schedule of assets (held at end of year) as of December 31, 2024, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

Note D. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

Level 1 – Quoted market prices in active markets for identical assets and liabilities.

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data.

Level 3 – Unobservable inputs in which little or no market data exists.

The following is a description of the valuation methodologies used for assets of the Plan measured at fair value at December 31, 2024 and 2023:

- Mutual funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, and are classified as Level 1.
- Self-directed brokerage accounts: Accounts primarily consist of common stocks, exchange-traded funds, and interest-bearing cash which are valued at the closing price reported on the active market on which the individual securities are traded, and are classified as Level 1.

Note D. Fair Value Measurements (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the report date.

Note E. Fully Benefit-Responsive Investment Contracts

The Plan has a fully benefit-responsive investment contract in the form of a group annuity contract with Empower Annuity Insurance Company of America that invests contributions in the Fixed Account Fund. The Fixed Account Fund is a general account product. The group annuity contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Note E. Fully Benefit-Responsive Investment Contracts (Continued)

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the insurance company but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the product is established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions.

The Plan's ability to receive amounts due in accordance with the group annuity contract is dependent on the insurance company's ability to meet its financial obligations. The insurance company's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events may limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than contract value.

Note F. Party-in-Interest Transactions

Certain Plan investments are in a group annuity contract managed by the Custodian. In addition, the Trustee receives administrative fees from the Plan. These transactions qualify as party-in-interest transactions.

Note G. Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note H. Tax Status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing/money purchase/CODA document which has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan is acceptable under applicable sections of the IRC. The Plan Sponsor relies on the opinion letter and the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Sponsor believes the Plan is currently operated in compliance with applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is exempt from federal income taxes as of the financial statement date.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.
