Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Alexander Mann Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified to by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the Alexander Mann Retirement Savings Plan ("Plan") is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

General

The Plan is a defined contribution plan established by the Alexander Mann Solutions Corporation ("Company"), under the provisions of Section 401(a) of the Internal Revenue Code ("IRC"), and includes a qualified cash or deferral arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Effective September 18, 2024, the Plan was restated.

The plan administrator determined that a partial plan termination occurred in 2024 as a result of terminations in 2022, 2023 and 2024 attributable to layoffs (see Note 7).

Eligibility and Participation

Substantially all employees of the Company are eligible to participate in the Plan, except for the classes of employees excluded as defined by the Plan, on the first of any month following his or her date of employment. Participation in the Plan is voluntary.

Contributions

Eligible employees can make pre-tax or Roth 401(k) contributions up to 100% of their annual compensation, as defined by the Plan, subject to certain limitations under the IRC. In addition, employees who are projected to be 50 years or older by the end of the plan year are eligible to make catch up contributions subject to limitations in the IRC. The Plan has a negative election format in which employees are automatically enrolled the first of the month following 60 days of employment. Unless otherwise directed by the participant, 3% of compensation is withheld and invested in qualified default investment alternatives. The deferral amount will escalate at the rate of 1% each year to a maximum deferral of 6%. The Company makes matching contributions of fifty percent (50%) of deferrals made by eligible participants, up to a maximum of 3% of each participant's annual compensation, as defined. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participant Accounts

Charles Schwab Trust Bank ("Schwab"), from September 18, 2024 through December 31, 2024, and Newport Trust Company ("Newport"), from December 31, 2023 through September 17, 2024, the Custodians, maintained an individual account for each of the Plan's participants to reflect the participant's contributions and related Company matching contributions, as well as the participant's allocated share of the Plan's income and any administrative expenses. Allocations are based on participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of the Plan (Continued)

Vesting

Participants are fully vested in their contributions to the Plan and the earnings thereon. Vesting in Company matching contributions is based upon the occurrence of certain events or on years of service. A participant vests in Company matching contributions according to the following schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 3	0%
3 or more	100%

For purposes of the above vesting schedule, a "year of service" is a measuring period beginning on the employee's date of hire. Generally, an employee will be credited with a "year of service" for each plan year in which the employee completes 1,000 hours of service beginning on the employee's date of hire and ending on his or her last day of employment with the Company.

Benefits

Upon termination of service or due to death, disability or retirement or upon attainment of age 59½, a participant (or his or her beneficiary) may elect to receive a payment amount equal to the value of the participant's vested interest in his or her account. The form of payment is a lump-sum distribution or installments over a specified term. Additionally, the Plan has provisions for active participants to make withdrawals from their account, subject to limitations and restrictions.

Forfeitures

Forfeitures of non-vested account balances are used to pay Plan expenses or used to reduce future employer contributions, as defined. During 2024, \$-0- was used to pay Plan expenses and \$265,727 was used to reduce employer contributions. At December 31, 2024 and 2023, there were \$114,841 and \$8,918, respectively, of unallocated forfeiture accounts.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

Notes Receivable From Participants

A participant may borrow the lesser of \$50,000 or 50% of his or her vested account balance with a minimum loan amount of \$1,000. Loans are secured by the balance in the participant's account. Loans are repayable through payroll deductions over periods ranging up to 60 months or longer when the loan proceeds are used to purchase a primary residence. The interest rate is determined by the plan administrator based on prevailing market conditions and is fixed over the life of the loan.

Note 2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Note 2. Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided previously by Newport and currently by Schwab, and the Plan's investment advisors. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investment securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The administrative expenses of the Plan are paid from Plan assets or by the Company at the discretion of the Company, while loan processing and benefit payment fees are charged directly to the affected participants.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Note 3. Unaudited Information

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received certifications from Charles Schwab Trust Bank, from September 18, 2024 through December 31, 2024, and Newport Trust Company, from December 31, 2023 through September 17, 2024, acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) as of December 31, 2024, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

Note 4. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs for which little or no market data exists

The following is a description of the valuation methodologies used for Plan assets measured at fair value:

- Mutual funds: Investments in mutual funds are valued based on their quoted closing market prices in active markets for identical investments and are classified as Level 1.
- Pooled separate account: The fair value of investments held in the pooled separate account is based on its reported net asset value ("NAV"). The NAV is based primarily on observable inputs, the market value of the underlying investments and is classified as Level 2.
- Collective investment trust: The fair value of investments held in the collective investment trust is based on its reported NAV. The NAV is based primarily on observable inputs, the market value of the underlying investments and is classified as Level 2.

Note 4. Fair Value Measurements (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Tax Status

From December 31, 2023 through September 17, 2024, the Plan had adopted a prototype plan, which was designed by The Newport Group, the recordkeeper of the Plan, in accordance with applicable IRC requirements to qualify for tax-exempt status. This prototype document received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020. Effective September 18, 2024, the Plan adopted a prototype plan, which was designed by Schwab Retirement Plan Services, Inc., the recordkeeper of the Plan, in accordance with applicable IRC requirements to qualify for tax-exempt status. This prototype document received a favorable opinion letter from the IRS on September 21, 2020. The Plan has not been amended since receiving the opinion letter. The plan administrator believes that the Plan and related trust are designed and being operated in compliance with the applicable IRS and ERISA requirements to qualify as tax exempt.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

Newport and Schwab were the Custodians during 2024 as defined by the Plan and were paid fees from the Plan; therefore, these qualify as party-in-interest transactions.

Note 7. Partial Plan Termination

As a result of a reduction in the Company's workforce, management determined the Plan experienced a partial plan termination as defined by ERISA in 2024. Under ERISA, a partial plan termination may occur if a significant percentage of the Plan participants are terminated because of an action taken by the plan sponsor. All affected participants were made fully vested in their account balances at the date of the partial plan termination. The remaining participants' vesting continues to be determined per the provisions of the Plan.
