In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The PSMC Companies 401(k) and Profit Sharing Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of The PSMC Companies 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General – The Plan is a defined contribution plan covering all employees, other than certain union employees and nonresident aliens, of several companies included in an affiliated service group (the Companies), who have at least thirty days of service and have reached at least 21 years of age. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Companies' management oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.
- B. Contributions – Each year, participants may contribute up to 90% of pre-tax or post-tax annual compensation, as defined in the Plan. Participant's may also make voluntary, non-deductible, after-tax contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions (and employer contributions) into various investment funds offered by the Plan. The Plan currently offers various mutual funds and a stable value fund as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate of 4% of eligible compensation. The contribution percentage will increase by 1% annually until the deferral percentage reaches a total of 8% of compensation. Contributions are automatically invested in the target date fund corresponding to the participant's expected retirement date until changed by the participant. The Companies' contributions to the Plan, which may include a profit sharing contribution and a 401(k) match of employee deferrals, are discretionary and are determined by the Board of Directors. For the year ended December 31, 2024, the Companies' matched 50% of the first 6% of employee contributions. Contributions are subject to certain statutory limitations.
- C. Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of (1) the Companies' contributions and (2) Plan earnings (losses) and charged with administrative expenses directly attributable to participant activity. Allocations are based on participants' earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting – Vesting in participant accounts is 100% full and immediate.
- E. Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at fixed rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates at the time of initiation for each loan. Principal and interest are paid ratably through monthly payroll deductions, over a maximum payment term of five years or up to fifteen years for the purchase of a primary residence.

- F. Payment of Benefits – On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive an amount equal to the value of the participant’s account in a lump-sum amount. As outlined in the summary plan description, a participant may request a distribution from their voluntary contribution account for serious financial difficulties. The administrator of the Plan must approve each hardship request. Hardship withdrawals may not be repaid to the Plan. In-service withdrawals are permitted in some select circumstances.
- G. Forfeited Accounts – As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,123 and \$5,559, respectively. The amounts represent distribution checks that were not cashed within 180 days.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Companies determine the Plan’s valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in a default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Payments of Benefits – Benefits to participants are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Expenses for recordkeeping, advisory, and other fees are paid through an allocation to participant accounts and are included in administrative expenses.

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Common Collective Trust

The common collective trust is valued at the net asset value (NAV) of units of a collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions and terminate the Plan at any time, subject to the provisions of ERISA. In the event such discontinuance resulted in the termination of the Plan, the net assets of the fund would be allocated to plan participants and beneficiaries in the order described by ERISA.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Related Party and Party-in-Interest Transactions

Plan investments are managed by Fidelity Management Trust Company, who is also the custodian as defined by the Plan and, therefore, those transactions qualify as party-in-interest transactions. As described in Note 2, the Companies pay certain expenses related to Plan operations. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Nonexempt Transactions

During 2023, there were certain pay periods where employee withholdings and loan payments totaling \$667,824 were not timely remitted to the Plan by the Company. The Company has made a contribution representing lost earnings to the Plan associated with these untimely remittances.

During 2024, there were certain pay periods where employee withholdings and loan payments totaling \$1,172,381 were not timely remitted to the Plan by the Company. The Company has made a contribution representing lost earnings to the Plan associated with these untimely remittances.

10. Subsequent Events

In preparing its financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 9, 2025, the date the financial statements were available to be issued.
