NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the DiMarco Group Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Plan Amendments

Effective July 1, 2024, the Plan was amended whereby new loans are permitted for plan participants, as further described in Note 1 under "Notes Receivable from Participants".

Effective April 1, 2024, the Plan elected an operational provision under the SECURE Act 2.0 increasing the force-out distribution limited for terminated participants from \$5,000 to \$7,000. The Plan has not been formally amended for this provision as of December 31, 2024.

Effective May 1, 2024, the Plan elected an operational provision under the SECURE Act 2.0 whereby domestic abuse distributions are permitted for plan participants. Participants are allowed to take the lesser of \$10,000 or 50% of their vested account balance if they have been a victim of domestic abuse. The Plan has not been formally amended for this provision as of December 31, 2024.

Effective November 13, 2024, the Plan elected an operational provision under the SECURE Act 2.0 whereby Qualified Disaster Recovery distributions are permitted for plan participants. As it pertains to federally declared disasters, participants will be allowed to take an amount that does not exceed the aggregate of \$22,000 across IRA's and other retirement plans. The Plan has not been formally amended for this provision as of December 31, 2024.

Effective November 13, 2024, the Plan elected an operational provision under the SECURE Act 2.0 to offer a Terminal Illness Early Distribution Penalty Tax Exception, by which participants may receive a waiver of the 10% early withdrawal penalty if a physician certifies that illness of medical condition is reasonably expected to result in death in 84 months or less. The Plan has not been formally amended for this provision as of December 31, 2024.

General

The Plan is a qualified defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (IRC). The Plan covers substantially all of the employees of Admar Supply Co., Inc., The DiMarco Group, LLC, Admar PA, LLC, Admar PENN, LLC, Admar Ohio, LLC, Admar Holdings, Inc., DiMarco Constructors, LLC, J DiMarco Builders, Inc., 1950 Brighton Henrietta Town Line Road, DRO Greece LLC, DiMarco Staffing LLC, Baytown Liquor, LLC, and Baldwin Real Estate Corporation (collectively, the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

1. DESCRIPTION OF PLAN (Continued)

Administration

The DiMarco Group, LLC, is the sponsor and administrator of the Plan. Modern Wealth Business (previously known as Enhanced Retirement Solutions) serves as the third-party administrator. Empower Retirement, LLC (Empower) is the custodian and provides record-keeping services. Beginning July 1, 2024 Empower Trust Company, LLC also serves as trustee to the Plan. Prior to July 1, 2024, three shareholders of Admar Supply Co., Inc. served as trustees to the Plan.

Eligibility

Employees of the participating employers are eligible to participate in elective deferrals and the employer match provisions of the Plan upon the attainment of age 18. Participants are eligible to contribute to the Plan immediately upon the attainment of these eligibility requirements. Participants are eligible for profit-sharing contributions upon the first day of the quarter following attainment of age 18, completion of one year of eligibility service, and must be employed on the last day of the plan year. A year of eligibility service covers a 12-month period beginning on the employee hire date.

Contributions

Active participants may make voluntary contributions in the form of salary reductions. Participants are permitted to make elective deferrals in any amount up to 90% of compensation, not to exceed the maximum contribution limits established by the Internal Revenue Code (IRC). The Plan includes an automatic enrollment provision. Newly eligible employees who have not affirmatively opted out of enrollment or made an alternative deferral election in the Plan are automatically enrolled at 4% of their compensation. As long as a participant does not opt out of the automatic increase provision, the participant's elective deferral amount will automatically increase by 1% each year at the beginning of each plan year, up to a maximum of 10%.

The Plan includes a Qualified Automatic Contribution Arrangement (QACA) Safe Harbor Match. The matching formula is calculated based on 100% of the participant's first 1% of elective deferrals plus 50% of the next 5% of participant elective deferrals, not to exceed 6% of the participant elective deferrals matched. Participants will be fully vested in these matching contributions upon the completion of two years of service. QACA Safe Harbor Match contributions were \$1,021,583 and \$1,027,940 for the years ended December 31, 2024 and 2023, respectively.

The Company may also make discretionary profit-sharing contributions to the Plan on behalf of eligible participants. Such contributions shall be allocated to one group per participant, in an amount designated by the Company to be allocated to each group. The contribution shall be allocated to each group in a manner determined by the Company. The amount allocated to one group need not bear any relationship to amounts allocated to any other group. The Company shall notify the plan administrator and/or the trustees in writing of the amount of contributions allocated to each group. There were no profit-sharing contributions made during 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution, QACA safe harbor matching contributions, discretionary profit-sharing contributions, and investment earnings or losses, and is reduced by benefit payments and administrative expenses. Company contributions, investment income and losses, and plan expenses are allocated to each participant's account based on compensation or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their contributions and actual earnings and losses thereon. QACA Safe Harbor Match contributions become fully vested after two years of service. Profit-sharing contributions vest 20% per year beginning upon completion of two years of service. Participants are fully vested in the profit-sharing contributions upon completion of six years of service.

Benefit Payments

Normal retirement age is 65, at which time participants are entitled to 100% of their account balance. On termination of service due to death, disability, retirement or termination of the Plan, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For the year ended December 31, 2023, and the for the period January 1, 2024 to June 30, 2024, if the account balance is less than \$5,000, the Plan may make an automatic rollover of the entire account balance if the participant does not make an affirmative election to take the distribution. If the account balance is greater than \$5,000, the participant may choose a lump-sum distribution, equal installments over various periods based on life expectancy, or partial withdrawal of any amount. Effective July 1, 2024, if the account balance is less than \$7,000, the Plan may make an automatic rollover of the entire account balance if the participant does not make an affirmative election to take the distribution. If the account balance is greater than \$7,000, the participant may choose a lump-sum distribution, equal installments over various periods based on life expectancy, or partial withdrawal of any amount.

Actively employed participants that have reached the age of 59 ½ may elect to receive in-service distributions. Hardship withdrawals are also permitted from the Plan for actively-employed participants. Distributions from the rollover source are permitted at any time.

Forfeitures

If an employee terminates their employment before their account has become fully vested, they will forfeit the unvested balance of their account and the forfeitures are used to reduce employer contributions. Any remaining forfeitures are used to offset plan expenses for the Plan year in which the forfeiture occurs. The Company used \$98,619 and \$90,642 of forfeitures to reduce employer match contributions and pay plan expenses in 2024 and 2023, respectively. Amounts forfeited by participants, including related investment earnings and fees totaled \$118,408 and \$85,925 in 2024 and 2023, respectively. Unapplied, forfeited accounts totaled \$45,885 and \$26,096 at December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loan transactions are limited to one loan outstanding at any given time or two solely for the purpose of refinancing. The loans are payable in their entirety upon the occurrence of a distributable event, as defined by the Plan, and bear interest at a rate of prime plus 2%. Loans must be repaid over a maximum term of 5 years.

Plan Termination

While the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Investments

The Plan's investments in mutual funds and variable annuities are reported at fair value as reported by Empower. Purchases, sales, and interest income are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. The net appreciation in the fair value of investments consists of both realized and unrealized gains and losses on the Plan's investments purchased and sold as well as held during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the accompanying financial statements.

Fair Value Measurements - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board *Accounting Standards Codification 820* (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

Benefit Payments

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Administrative Expenses

The Company pays certain administrative expenses of the Plan. Investment management and distribution fees are charged directly to the participants for the transactions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. CERTIFIED INVESTMENT INFORMATION

As of and for the years ended December 31, 2024 and 2023, the following information was certified as complete and accurate by Empower, the custodian of the plan and is included in the financial statements and accompanying supplemental schedule.

Following is a description of the valuation methodology used for assets measured at fair value.

4. FAIR VALUE MEASUREMENTS (Continued)

Mutual funds: valued at fair value based on quoted market prices in active markets.

Variable annuities: valued based on observable inputs. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund net asset value (NAV) calculation: dividing the net assets by the number of units outstanding.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

The Plan may invest in shares of variable annuities managed by Empower. Empower acts as a custodian and trustee (effective July 1, 2024) for these investments. As such, transactions between Empower and the Plan qualify as party-in-interest transactions. In addition, transactions involving notes receivable from participants also qualify as party-in-interest transactions.

6. INCOME TAX STATUS

The Plan obtained its latest opinion letter on July 16, 2024, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving that opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. RECONCILIATION TO FORM 5500

While total net assets available for benefits and the total change in net assets available agree between the financial statements and Form 5500 for 2024 and 2023, certain classifications differ between the financial statements and Form 5500.

8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
