We have performed audits of the financial statements of Maritz Holdings, Inc. **Note 1. Description of the Plan**

***General***

The following description of Maritz Holdings, Inc. Employees' Investment Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Maritz Holdings, Inc. (the "Company") for the benefit of its full-time and regular part-time employees. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* ("ERISA"). T. Rowe Price Trust Company is the trustee and custodian of the Plan. T. Rowe Price Retirement Plan Services, Inc. is the recordkeeper of the Plan.

***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 90% before tax, and 6% after tax, of eligible compensation. Employee rollover contributions are also permitted. The Plan also permits discretionary matching contributions as determined by the Company. The Company will make matching contributions of 100% of employees' salary deferral amounts up to the first 2%, and 50% of employees' salary deferral amounts up to the next 5%. Contributions are subject to certain limitations.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options or its brokerage account offered by the Plan.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of vesting service. A participant is fully vested after three years of continuous service. The non-vested balance is forfeited upon termination of service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may receive the value of the vested interest in their account only as a lump-sum distribution.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$159,706 and \$317,234, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. Employer contributions were reduced by \$900,414 and \$64,751 from forfeited nonvested accounts during the years ended December 31, 2024 and 2023, respectively.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Valuation of Investments and Income Recognition***

Mutual funds, including those held in self-directed brokerage accounts, are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan's interest in common collective trust funds is valued daily utilizing the values of the underlying assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

### ***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

## **Note 3. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

**Level 1** Quoted prices in active markets for identical assets

**Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying Statements of Net Assets Available for Benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan has no securities valued in Level 2 or 3 of the fair value hierarchy.

**Note 4. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

**Note 5. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of funds managed by T. Rowe Price Trust Company. T. Rowe Price Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid \$104,165 and \$136,690 of recordkeeping fees during the years ended December 31, 2024 and 2023, respectively. The Plan also incurs expenses related to general administration. The Company pays certain of these expenses and provides certain administrative services at no cost to the Plan.

**Note 6. Transfer of Plan Assets**

On July 1, 2024, the Company acquired Convention Data Services, LLC (CDS). CDS employees became employees of the Company as part of the transaction and, effective July 1, 2024, are eligible to participate in the Plan subject to certain provisions. CDS employees were participants in the Freeman 401(k) Plan prior to the plan transfer. An aggregate of \$13,915,180 was transferred into the Plan during the year ended December 31, 2024, and is included as a transfer on the statement of changes in net assets available for benefits.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 8. Tax Status**

The IRS has determined and informed the Company by a letter dated September 21, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.
