### Report on the Audit of the Financial Statements

**NOTE 1 DESCRIPTION OF THE PLAN**

The following description of the Bergstrom Inc. Profit Sharing and Employee Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective July 1, 1966. The Plan has been amended throughout the years to comply with tax legislation. The Plan excludes leased and part-time employees and employees covered by a collective bargaining agreement. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for the oversight of the Plan.

**Eligibility**

Employees of Bergstrom Inc., Bergstrom Parts LLC, Bergstrom Electrified Systems, and Bergstrom Climate Systems LLC (the Companies) are eligible to participate in the deferral and match components of the Plan after completing 30 days of consecutive employment and may start participating as of the first day of each month, except for temporary employees, who become eligible after one year of service. Participants are eligible for the profit sharing contribution if they meet the eligibility requirements above and are employed on the last day of the Plan year. Effective June 26, 2023 employees are eligible to participate after completing one month of service.

**Contributions**

Participants may elect to contribute to the Plan a percentage of their eligible compensation or a specific dollar amount up to a maximum amount as defined by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. If employee contributions cause the Plan to exceed the 401(k) discrimination limits, excess contributions will be refunded to the participants. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation with annual increases of 1% at the beginning of each year up to a maximum of 5%. Employee contributions are invested in the designated default fund until changed by the participant.

The Plan provides for the Companies to make safe harbor matching contributions weekly. The safe harbor matching contributions equaled 100% of each participant's voluntary contributions up to 3% of compensation, plus 50% of each participant's voluntary contributions in excess of 3% of compensation up to 5% of compensation. The total safe harbor contributions for the year ended December 31, 2024 was \$1,123,694. Companies' matching contributions to the Plan are at the discretion of the Companies' Board of Directors. There were no discretionary matching contributions for the year ended December 31, 2024. The Companies' profit sharing contributions to the Plan are at the discretion of the Companies' Board of Directors; however, the total contributions may not exceed the maximum allowable by the IRC. There were no profit sharing contributions for 2024.

**NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's voluntary contributions, the Companies' safe harbor matching contributions, Companies' matching contribution, if applicable, an allocation of the Companies' profit sharing contribution, if applicable, and the administrative expenses, income, losses, appreciation, and depreciation attributable. The allocations of the Companies' profit sharing contributions and profit sharing forfeitures to the participants' accounts are based on points earned for the year. One point is awarded for each \$100 of compensation up to \$100,000, and three points is awarded for each year of service, up to 1,000 points. Plan earnings are allocated based on account balances. Participants elect the direction of their investments.

**Vesting**

Participants are immediately 100% vested in their voluntary tax deferred contributions, employer safe harbor matching contributions, and earnings thereon. Participants are vested in the Companies' discretionary profit sharing and discretionary matching contributions based on years of continuous service. Participants are vested in the Companies' discretionary profit sharing and discretionary matching contributions according to the table below:

**Investment Options**

Upon enrollment in the Plan, a participant must direct all contributions to selected investments as made available and determined by the Plan administrator. Participants have the option to transfer monies between funds and change the allocation of their investment elections daily.

**Benefit Payments**

Upon termination of service, the trustee shall distribute the participant's vested account balance in: (a) a lump sum amount or (b) equal installments over the life expectancy of the participant, as designated by the participant. The Plan allows for hardship distributions subject to Plan provisions.

If the vested benefits are less than \$5,000, the balance will be distributed as either a cash distribution to the participant or transferred to an eligible retirement plan, at the direction of the participant. If the participant does not elect a method of payment and the balance is greater than \$1,000, it will automatically be rolled over into an Individual Retirement Account (IRA). Balances of less than \$1,000 will be distributed in cash to the participant. If the balance is more than \$5,000, an election to receive the benefit must be made.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate of interest based on the rates for similar types of loans. Principal and interest payments are made through payroll deductions.

**Forfeited Accounts**

Forfeitures may be used to reduce the Companies contribution, pay administrative expenses, or reallocated to participant accounts as defined in the Plan. The forfeiture account balance at December 31, 2024 and 2023 was \$10,886 and \$7,416, respectively. There were no forfeitures used to reduce Employer contributions for the Plan year ended December 31, 2024. There were no forfeitures used to pay administrative expenses in 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit Payments**

Benefit payments to participants are recorded when paid.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as distributions based upon the terms of the Plan documents.

**Administrative Expenses**

All Plan related expenses are paid by the Plan and reported in the accompanying statement of changes in net assets available for benefits. Expenses incurred in connection with the general administration of the Plan, fees related to benefit payments and fees related to the administration of notes receivable from participants are reported as administrative expenses. In addition, certain investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2023.

T. Rowe Price Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024, the statement of changes in net assets available for benefits for the period from January 2, 2024 to December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan did not receive a certification as to the completeness and accuracy of investment information and notes receivable from participants for the date of January 1, 2024, due to the conversion of assets from Ascensus, LLC as an authorized representative of Ascensus Trust Company to T. Rowe Price Trust Company. The only activity on that date was the loss on sale of investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets and liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Fund* – Valued daily at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Companies reserve the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE 7 PLAN TAX STATUS**

The Plan is operating under a standardized adoption agreement for which the prototype plan was issued a letter by the Internal Revenue Service (IRS) determining that the Plan and related trust are designed in accordance with Section 401(a) of the IRC and is therefore exempt from federal income taxes under the provisions of Section 501(a). Although minor amendments have been made since that date, Plan management and the trustee believe the Plan is designed and is currently operating in compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds and a collective fund managed by T. Rowe Price Trust Company and Ascensus Trust Company. T. Rowe Price Trust Company and Ascensus Trust Company are the qualified institutions of the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Certain administrative functions are performed by officers or employee of the Companies for which no compensation is received from the Plan.
