Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of National Consumer Cooperative Bank Retirement and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report.

Basis for Opinion (Continued)

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the National Consumer Cooperative Bank Retirement and 401(k) Plan (the Plan), provides only general information. Participants should refer to the plan agreement or to the information provided by Fidelity Management Trust Company for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of National Consumer Cooperative Bank and its subsidiaries, National Cooperative Bank, N.A., and Rochdale Capital Corporation, Inc. (collectively the Companies). The Plan has a 401(k) feature and a profit-sharing component. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 60% of pretax annual compensation, as defined in the Plan, subject to the maximum limit under Section 415 of the Internal Revenue Code. The Plan allows automatic enrollment deferral and matching contributions 30 days following the participant's date of hire. The automatic deferral contribution rate is 6%. The employee can elect out of the automatic enrollment feature. The Companies contribute matching contributions up to a maximum of 6% of eligible compensation. As of June 7, 2021, the Companies direct Fidelity to make available to participants who have attained or are expected to attain before the close of the calendar year, age 50 or greater, a separate election to designate an additional percentage election (Catch-up Election). The profit-sharing contribution is a discretionary percentage based on eligible compensation. In order to be eligible for the discretionary profit-sharing contribution, participants must be employed on December 31st, earn at least 1,000 hours of service, and complete one year of service. The profit-sharing contributions are subject to IRS limitations. The Companies made a 4% and 2% profit-sharing contribution for 2024 and 2023, respectively. Participants direct the investment of their contributions into various investment options offered by the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct both employee and employer contributions to a variety of money market and mutual fund investments and common and collective investment trusts held by the custodian. The Plan also includes a Brokeragelink account option in which participants may make investments that are not otherwise offered by the Plan and include a wide array of mutual funds from either Fidelity Management Trust Company or other mutual fund companies. Brokerage services are provided through Fidelity Brokerage Services LLC, a member of the New York Stock Exchange and Securities Investor Protection Corporation.

Participants' Accounts

Each participant's account is credited with the participant's contributions and the Companies contributions on their behalf. The accounts are also credited with investment results and charged for withdrawals and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their individual accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the value of the vested balance in their account. Loan terms range from one to five years or longer, in the case of a loan used to acquire a principal residence. The loans are secured by the balance in the participant's account and bear interest at prevailing rates as determined by the plan administrator.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in the account, periodic installment distributions, or an annuity. For termination of service for other reasons, a participant may receive the value of the vested account balance as a lump-sum distribution.

Forfeitures

As of December 31, 2024 and 2023, the balance of forfeited nonvested accounts totaled \$206,185 and \$220,356, respectively. Forfeited accounts will be used to reduce employer contributions and/or administrative expenses. During the years ended December 31, 2024 and 2023, forfeitures totaling approximately \$200,000 and \$250,000, respectively, were used to reduce employer contributions and approximately \$-0- and \$15,500, respectively, were used to reduce administrative expenses.

Vesting

Participants are always 100% vested in their own employee pre-tax account balances and earnings. Employees hired prior to October 1, 1993, are 100% vested in employer matching and profit-sharing contributions and earnings. Employees hired after September 30, 1993, are subject to a vesting schedule based on years of service. Participant matching contributions, profit-sharing contributions, and earnings thereon are vested in accordance with the following schedule:

Basis of Accounting

The Plan presents its financial statements under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results may differ from those estimates.

Notes Receivable from Participants

Participant loans are measured at their unpaid balance. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's common and collective investment trust funds are valued at the net asset value of the units held of the collective investment trust as a practical expedient to estimate fair value. Participant loans receivable are valued at cost, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits to participants are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Plan and are allocated proportionately to participant account balances. The Companies absorb other costs related to managing the Plan.

The plan administrator has obtained certification from Fidelity Management Trust Company, the custodian of the Plan's assets, regarding certain financial information. 4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs to the valuation methodology are unadjusted quoted prices for similar assets in active or inactive markets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Registered Investment Companies - The fair value of the money market and shares of mutual funds owned by the Plan is based on quoted market price values on the last business day of the plan year.

Common and Collective Investment Trusts - The fair value of collective investment trust funds is based on the net asset value (NAV) on the last business day of the plan year provided by the entity holding the trust funds. The NAV of the collective investment trusts is used as a practical expedient to estimate fair value and is determined by the custodian, based on the fair value of underlying assets in the trust, less the liabilities. Investments in all collective investment trust funds can be redeemed immediately at the current net asset value. There are no withdrawal limits, redemption frequency limits, or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2024 and 2023.

Self-Directed Brokerage Accounts - These accounts include interest-bearing money market accounts and mutual funds which are valued at the quoted price of shares held by the Plan at year end.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. FIDELITY MANAGED INCOME PORTFOLIO

The Fidelity Managed Income Portfolio CL1 (the Portfolio) is a fully benefit responsive, open-end commingled pool sponsored by an affiliate of the custodian. The Portfolio's investment strategy is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. The portfolio invests primarily in short- and long-term investment contracts issued by insurance companies, investment contracts issued by commercial banks, synthetic investment contracts comprising underlying assets and a "wrapper" contract issued by a third party, and cash equivalents represented by units in Fidelity money market portfolios, all of which are subject to the credit-quality standards established by Fidelity.

5. FIDELITY MANAGED INCOME PORTFOLIO (CONTINUED)

Investments in the commingled pool are pooled within the general accounts of the issuing insurance companies and banks. Consequently, the ability to satisfy the terms of the insurance and bank contracts is dependent upon the general financial soundness of the issuers of those contracts. The insurance and bank contracts are not guaranteed by the U.S. government or any agency thereof. The portfolio is included as a common and collective investment trust in the accompanying financial statements. Redemption of units is made upon the participant request with no waiting period.

6. RELATED PARTY TRANSACTIONS

Fidelity Management Trust Company (Fidelity) managed all plan investments. Fidelity is a custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest. For the years ended December 31, 2024 and 2023, the investment fees and other fees paid by the Plan to Fidelity were \$58,684 and \$55,869, respectively. These amounts are included in administrative expenses on the accompanying statements of changes in net assets available for benefits.

7. PLAN TERMINATION

Although the Companies have not expressed any intent to do so, they have a right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become fully vested in their accounts.

8. TAX STATUS

The Plan meets the requirements of the Internal Revenue Code (IRC) and ERISA to qualify as exempt from federal income taxes. The Plan has adopted Fidelity Management & Research Company's (FMR Co.) Volume Submitter Defined Contribution Plan With CODA. FMR Co. received a favorable determination letter for this plan from the Internal Revenue Service on June 30, 2020. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
