Opinion

1 Description of Plan

The following description of the Eaton Corporation Group Insurance Plan for U.S. Employees ("Plan") provides only general information. Information about available benefits is contained in various Plan documents, which are available from the Company's Human Resources Department.

General:

The Plan became effective January 1, 1995 and covers certain active employees of Eaton Corporation ("Company"), or their assignees. The Company is a subsidiary of Eaton Corporation plc ("Eaton"). The Plan complies with the Health Insurance Portability and Accountability Act ("HIPAA") and provides for medical and other benefits. The Plan was amended and restated effective January 1, 2018 to change its name from the Eaton Corporation Medical Plan for U.S. Employees and to formally consolidate the Plan's various existing health, welfare and flexible benefits plans and programs by merging into the Plan the Eaton Corporation HMO Plan for U.S. Employees, the Eaton Corporation Life Insurance Plan for U.S. Employees, the Eaton Corporation Disability Plan for U.S. Employees, and the Eaton Corporation Employee Assistance Plan for U.S. Employees. The Plan was amended August 25, 2022, effective January 1, 2021, to add a procedure for processing benefit claims and appeals in relation to the COVID-19 Pandemic. The Plan was most recently amended October 18, 2022, to extend participation in the Plan until December 30, 2020 for participants who were part of the Lighting business sale. The amendment is retroactive to the closing of the Lighting business sale in 2020 until December 30, 2020.

The Plan's trustee is KeyBank National Association, and the Plan's assets are held in the Eaton Corporation Voluntary Employee Beneficiary Association Trust ("Master Trust, including General and Sub Trust Accounts"). Within the Master Trust, sub accounts were established in 2011 to pre-fund the postretirement Medicare Part D prescription benefits for the Company's eligible United States employees and retirees. The sub accounts are divided into two groups - accounts for eligible employees and retirees covered by a Collective Bargaining Agreement and accounts for eligible retirees who were not affiliated with a Collective Bargaining Agreement. All medical and dental claims covered under the Plan are paid from the Master Trust. Premiums for life insurance benefits, fully insured medical/dental/vision benefits, disability benefits, and employee assistance programs and contributions to employee health reimbursement accounts are paid directly by the Company.

On January 5, 2022, Eaton acquired Royal Power Solutions. Employees became eligible to participate in the Plan on January 1, 2023. These transactions did not have a financial impact on the net assets available for benefits.

Eligibility:

Benefits are paid to Plan participants based on terms specified in various agreements with participating groups of the Company's employees.

Contributions:

The Company has agreed to voluntarily contribute such amounts as are necessary to provide assets sufficient to meet the benefits to be paid on behalf of Plan members. Participants contribute, via payroll deductions, to enhance benefits provided under the Plan. The Plan's benefit obligation (see Note 5) will be funded primarily through future Company contributions.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the modified cash basis of accounting, which differs from accounting principles generally accepted in the United States. The Plan records contributions and interest income when received. The Plan records benefit costs when paid (see Note 5).

The fair value of the Plan's interest in the Master Trust is based on the Plan's interest in the Master Trust as of the beginning of the year, plus Company contributions, actual participant contributions, and allocated investment income (loss) less actual benefit payments. The investment of the Master Trust is stated at fair value, as determined by the Trustee.

Use of Estimates:

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees:

Certain administrative expenses paid from the Master Trust consist of investment and Trustee fees. Other administrative expenses of the Plan are paid by the Company.

Plan Termination:

The Company has the right under the Plan to discontinue contributions at any time and amend, modify, suspend, or terminate the Plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). If the Plan were to terminate, assets would be available first for administrative expenses of the Plan, and second for benefits to participants, as provided under the Plan.

Risks and Uncertainties:

The Master Trust invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

3 Investments

All investment information disclosed in the accompanying financial statements, including investments held at December 31, 2024 and 2023, and net appreciation or depreciation in fair value of investments, net investment gain or loss, and interest and dividends for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by KeyCorp National Association, the Trustee.

The Plan's investments are in the Master Trust, which was established for the investment of assets and payment of medical and dental benefits of the Plan and of the Eaton Corporation Medical Plan for Retired U.S. Employees. The Master Trust consists of the General Trust Account, which is for the Plan and for the Eaton Corporation Medical Plan for Retired U.S. Employees, and the Sub Trust Accounts which were created specifically for the Eaton Corporation Medical Plan for Retired U.S. Employees. Investment income in the General Trust Account is allocated to the Plan based upon its pro rata share in the net assets of the General Trust Account. Investment income in the Sub Trust Accounts is allocated to the Eaton Corporation Medical Plan for Retired U.S. Employees.

4 Tax Status

The Master Trust funding the Plan has received an exemption letter from the Internal Revenue Service dated June 23, 1988, stating that the Master Trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code ("Code") as a Voluntary Employee Beneficiary Association. The Plan and Master Trust are required to operate in conformity with the Code to maintain the tax-exempt status of the Master Trust. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. Currently, no audits for any tax periods are in progress.

5 Benefit Obligations

Benefit obligations include health care claims incurred, but not reported, as of the end of the Plan year, the present value of estimated future disability benefits payable to participants who are expected to receive long-term disability benefits as of the date of the financial statements, and a liability for health reimbursement claims for eligible employees who have unused balances as of the date of the financial statements. The Plan's actuary estimates the present value of future long-term disability benefits by applying actuarial assumptions to adjust for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death and recovery) between the valuation date and the expected date of payment. The result is further adjusted to reflect the portion of costs expected to be borne by Social Security and other providers. Plan obligations for health claims submitted, but not paid were \$0 (2024 and 2023).

Significant assumptions underlying the actuarial computations for long-term disability benefits are:

Valuation method	Benefits accumulated represent the expected increase in obligation due to new disabilities in the upcoming year determined using the one-year term cost method. Under this method, the increase in the obligation is the present value as of the beginning of the year of all benefit payments and expenses that will be made on expected long-term disability claims incurred during that year.
Discount rate	3.80% (2024); 3.90% (2023)
Social Security	Members not yet approved for Social Security benefits and disabled for five or more years are assumed to have been denied Social Security benefits. Members disabled within the past five years are assumed to be pending approval according to the schedule developed from Table III(b) of the Group Long-Term Disability Benefit Offset Study – 2012 sponsored by the Society of Actuaries.
Rates of disability	Rates of disability incidence were developed based on an experience study of emerging hourly disabled members for the period from 2010 through 2016. Incidence for salaried members is assumed to be 1/5th that of the hourly population.
Rates of termination (mortality and recovery)	Select rates were used for the first 10 years of disability. The select rates were developed using the Society of Actuaries' 2008 Group Long-Term Disability Experience Tables assuming no diagnosis code, an elimination period of 6 months, an own occupation period of 24 months, and an average indexed gross monthly benefit between \$1,500-\$1,999. Ultimate rates of termination of disability were used after the first 10 years of disability and were based on the 15th year of disability of the tables detailed above. Rates have also been adjusted to reflect the results presented in the Society of Actuaries' 2016 Group Long-Term Disability Experience Study Preliminary Report and associated pivot tables. Finally, termination rates have been adjusted based on an experience review for the period 2015-2019.

6 Party-in-Interest Transactions

Party-in-interest transactions include the investment in the funds of the Trustee and payments of administrative expenses by the Company. Such transactions are exempt from being prohibited transactions. In addition, the Plan has arrangements with various service providers, and these arrangements qualify as party-in-interest transactions.

7 Fair Value Measurements

In accordance with United States generally accepted accounting principles Accounting Standards Codification 820, the Master Trust's financial instruments have been categorized, based on the degree of subjectivity inherent in the valuation technique, into a fair value hierarchy of three levels as follows:

- Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

7 Fair Value Measurements, Continued

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common collective and other trusts: Valued at the net unit value of units held by the trust at year end. The unit value is determined by the total value of fund assets divided by the total number of units of the fund owned. The equity investments in collective trusts are predominantly in index funds for which the underlying securities are actively traded in public markets based upon readily measurable prices. The investments in other trusts are predominantly in exchange traded funds for which the underlying securities are actively traded in public markets based upon readily measurable prices. Common collective and other trusts measured at fair value using the net asset value per share practical expedient have not been categorized in the fair value hierarchy and are being presented in the tables to permit a reconciliation of the fair value hierarchy to the total Master Trust assets.

Cash equivalents: Primarily certificates of deposit, commercial paper, and repurchase agreements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
