**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Pinterest 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

**A. General**

The Plan is a defined contribution plan that was established January 1, 2013 to provide benefits to eligible employees of Pinterest, Inc. (the "Company"). The plan was restated January 1, 2021. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**B. Administration and Expenses**

The Company authorized a 401(k) Committee to administer the Plan. The Committee designated the Vanguard Group, Inc. to serve as third-party administrator and maintain participant records. An affiliate, Vanguard Fiduciary Trust Company, serves as directed trustee. Investment fund management fees and operating expenses are charged directly to the fund and thereby factored into each fund as a reduction of investment return. Other costs of administering the Plan were paid by the Company.

**C. Eligibility**

Leased employees, nonresident aliens, collectively bargained employees, temporary employees, U.S. employees working in a foreign country and foreign entities, and interns are specifically excluded from the Plan. Substantially all other employees of the Company of age 21 or older are eligible to participate. There is no service requirement. Eligible employees may enter the Plan immediately.

**D. Contributions**

Participants may elect to make pre-tax, after-tax and or Roth after-tax contributions. Participants who make pre-tax contributions receive an equivalent reduction in taxable compensation. Pre-tax deferrals and Roth contributions are limited to 90% of eligible compensation and subject to applicable Code limits. After-tax contributions are limited to 12% of eligible compensation and will not be eligible for employer matching contributions. Participants age 50 and older may elect to make additional catch-up contributions as allowed under Code regulations. Employee contributions from all deferral sources remain subject to a maximum of 90% of eligible compensation and applicable Code limits.

Newly hired employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled in the Plan on the first day of the month after attaining eligibility at a pre-tax deferral rate equal to 6% of compensation. The deferral rate of auto-enrolled participants who do not make an alternative election will increase 2% annually in April of each successive year to a maximum of 12%.

The Plan permits participants to make rollover contributions of eligible amounts received from other tax-qualified retirement plans subject to the approval of the plan administrator. Such contributions are invested in accordance with participant directions.

**D. Contributions (Continued)**

The Company is allowed to make discretionary matching contributions, as defined in the Plan and as approved by the Board of Directors. The Company matched 50% of participants' deferred contributions up to a maximum annual matching contribution of \$6,000 per participant.

**E. Participant Accounts**

Each participant's account is credited with the participant's contributions, Company contributions, if any, rollovers, and the participant's share of investment earnings or losses and expenses. Participants may direct the investment of their accounts among a diversified menu of mutual funds provided under the Plan or may elect to establish a self-directed brokerage account in which they may invest in any investment security approved by the 401(k) Committee. Assets of the Plan are invested based solely on participant directions. Contributions allocated to a participant who declines to make an investment election are invested in the Vanguard Target Retirement Fund that is appropriate based on the individual's age and projected date of retirement.

**F. Vesting**

Participants are immediately 100% vested in their accounts.

**G. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their account balance. A loan is secured by a participant's account, bears a fixed rate of interest commensurate with commercially available borrowing rates determined at loan inception and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence in which case the repayment period may be extended. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with various maturities through July 2053.

Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

**H. Payment of Benefits**

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability, retirement, or attainment of age 59½ a participant or beneficiary may maintain his or her account in the Plan or receive benefits in a lump sum equal to the value of the participant's account or partial payments. Hardship withdrawals are permitted under limited circumstances as defined in the Plan document.

The Plan provides for mandatory distribution of terminated participant accounts valued at \$5,000 or less. If the value of such account is between \$1,000 and \$5,000 and no distribution election has been received from the participant or beneficiary of the account, the account will be rolled over to an individual retirement account at the direction of the plan administrator. If such account does not exceed \$1,000, the balance will be paid in a lump sum.

**I. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade-date basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in the dividend income. Net appreciation includes realized and unrealized gains and losses on investments bought and sold as well as held during the period.

**D. Risks and Uncertainties**

Plan investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in markets, interest rates, or other factors in the near term would materially affect participant accounts and the amounts reported in the financial statements.

**NOTE 3 - INCOME TAX STATUS**

The Company adopted a prototype plan that has received an opinion letter from the Internal Revenue Service stating that the form of the plan qualifies under applicable provisions of the Code for tax-exempt status. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are offered by the Vanguard Group, Inc. Transactions in these funds and payment of direct and indirect fees to Plan service providers by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information relating to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

Accounting guidance establishes a hierarchy which prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at closing market prices of shares held by the Plan at year end. Investments maintained in self-directed brokerage accounts consist of common stocks and a money market mutual fund that are valued at closing prices reported by the active markets on which the securities are traded. The following table summarizes Plan investments at December 31 based on the inputs used to value them:
