Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Tax Deferred Annuity Plan of OATS, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the Tax Deferred Annuity Plan of OATS, Inc. (the Plan) provides only general information. Participants should refer to the plan document for a more comprehensive description of the Plan's provisions.

General: The Plan is a 403(b) defined contribution plan covering all eligible employees of OATS Inc, (the Employer). The Plan was established October 1, 1992, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: All employees, except non-resident aliens, are eligible to participate in the Plan on the first day of employment. Any eligible employee may elect to become a participant in the Plan by directing the Employer to make salary reduction contributions to the Plan on his or her behalf.

Contributions: Participants may elect to contribute a portion of pre-tax or post-tax annual compensation per pay period, as defined in the Plan, not to exceed maximum amounts specified by the Internal Revenue Service (IRS), in accordance with a participant salary deferral agreement. Participants who are at least 50 years of age may make an additional contribution to the Plan not to exceed \$7,500 for 2024 and 2023, under certain conditions. Also, participants with 15 years of service may make special catch-up contributions as allowed by the IRS. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Employer currently makes no contributions to the Plan. Participants direct the investment of contributions into the various investment options offered by the Plan.

Participant accounts: Each participant's account is credited with the participant's contributions, the participant's rollover contributions from other qualified plans, an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are automatically 100% vested in their accounts.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate that is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are payable ratably through payroll deductions.

Payment of benefits: Participants may receive all or a portion of their account upon termination of service due to death, disability, or retirement. Benefits may be paid in the form of a single lump sum or may be paid under optional forms, including the following: (a) non-refund life annuity; (b) 10-year period certain and continuous annuity; (c) joint and survivor life annuity; or (d) full cash refund annuity.

In the event of a financial hardship, a participant may receive a distribution from their account. Any distribution of this type must be because of the employee's immediate and heavy financial need as described in the plan document.

Administration: Mutual of America Life Insurance Company (Mutual of America) was the Plan's custodian and third-party administrator until September 2023. At that time, a second custodian was added, Empower Annuity Insurance Company of America (Empower), and Benefit Plans Plus (BPP) became the third-party administrator. The custodians hold the Plan's assets, administer investment activity, and invest contributions into funds designated by each participant. Mutual of America and Empower maintain the individual participant accounts and provide records of balances and transactions to the Plan administrator and participants. Certain administrative and record-keeping costs are being absorbed by the Employer. The Employer's Board of Directors is responsible for oversight of the Plan. The Plan's management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Employer's Board of Directors.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Valuation of investments: Investments are reported at fair value, except for fully benefit-responsive contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the declaration date. Interest is recorded when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities of the Plan are exposed to various risks, such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Contributions: Contributions from plan participants are recorded in the year which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain administrative functions are performed by officers and employees of the Employer. No officer or employee receives compensation from the Plan for these services. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events: Events that have occurred subsequent to December 31, 2024, have been evaluated through October 13, 2025, which represents the date the Plan's financial statements were approved by management, and, therefore, available to be issued.

3. TERMINATED PARTICIPANTS

Net assets available for benefits at December 31, 2024 and 2023, included \$718,080 and \$853,523, respectively, allocated to the accounts of individuals who, as of or prior to that date, had withdrawn from actively participating in the operations of the Plan, generally as a result of terminating employment. These amounts are available to be paid upon request of the terminated participants. These participants receive no further contributions but do receive allocations of investment income and Plan expenses.

4. TAX STATUS

Effective December 2, 2008, the Plan adopted a 403(b) plan sponsored by Mutual of America. Effective January 1, 2019, the Plan was amended and restated to adopt a prototype non-standardized 403(b) plan sponsored by Mutual of America. The IRS has determined and informed Mutual of America by a letter dated March 31, 2017, that the prototype non-standardized 403(b) plan sponsored by Mutual of America is in a form acceptable under section 403(b) of the Internal Revenue Code (IRC).

Effective January 1, 2023, the Plan was amended and restated to adopt a pre-approved 403(b) plan sponsored by CCH Incorporated, DBA ftwilliam.com (CCH). As a result of the amendment and restatement, the Plan added a provision to permit Roth deferral contributions and permit participant loans. The IRS has determined and informed CCH by a letter dated March 31, 2017, that the volume submitter 403(b) plan sponsored by CCH is in a form acceptable under section 403(b) of the IRC.

An adopting sponsor may rely on the opinion letters issued by the IRS as evidence that the Plan is qualified under the applicable sections of the IRC. The Plan is relying on the opinion letters. Although the Plan has been amended since receiving the opinion letters, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

6. CERTIFICATION OF INVESTMENT INFORMATION

Certain information in the accompanying financial statements and the ERISA-required supplemental schedule of assets held at year-end related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company and Empower Annuity Insurance Company of America, qualified institutions.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. FAIR VALUE OF INVESTMENTS

Plan investments are held in a trust and managed by Mutual of America Life Insurance Company and Empower Annuity Insurance Company of America, the Plan's custodians, and are unsecured. Therefore, these transactions qualify as party-in-interest transactions.

A fair value hierarchy is used that prioritizes the inputs to valuation techniques used to measure fair value of balances that are required or permitted to be measured at fair value for reporting in financial statements. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to the unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the asset or liability. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodologies used for assets recorded at fair value.

Separate accounts: Valued at the net asset value (NAV) of units held by the Plan at year-end. The separate accounts are not publicly traded. The units of separate accounts are stated at fair value as determined by the issuer of the account based on the fair value of the underlying investments. Individual participant accounts invested in the separate accounts are maintained on a unit value basis. The separate accounts held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments. The investment strategy for each separate account is included in the annual report of Mutual of America Life Insurance Company.

Mutual funds: Valued at the daily closing price as reported by the fund on an active market which is based on the underlying NAV of shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan holds traditional fully benefit-responsive guaranteed investment contracts with Mutual of America through the Mutual of America interest accumulation account (general account) and Empower through the Empower Investments fixed account (general account). Contributions are maintained in the general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contracts do not permit the insurance companies to terminate the agreement prior to the scheduled maturity date.

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the custodians, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

9. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include transactions with fiduciaries or employees of the Plan, any person providing services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer, and relatives of parties-in-interest. The Plan has various parties-in-interest. Investments are held with parties-in-interest and certain fees are paid to parties-in-interest.

10. PROHIBITED TRANSACTIONS

The DOL considers late deposits of employee deferral contributions to be nonexempt prohibited transactions. During the year ended December 31, 2023, the Employer inadvertently failed to remit certain February and May 2023 employee deferrals totaling \$7,469 to the Plan within the time frame required by the DOL under plan asset rules. The Employer remitted the employee deferrals to the Plan in February 2023 and July 2023, and paid \$11 in missed earnings to the Plan in 2024.

During the year ended December 31, 2024, the Employer inadvertently failed to remit certain July 2024 employee deferrals totaling \$70 to the Plan within the time frame required by the DOL under plan asset rules. The Employer remitted the employee deferrals and paid \$4 in missed earnings to the Plan in February 2025.
