Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Frederica Academy 403(b) DC Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Frederica Academy 403(b) DC Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Frederica Academy 403(b) DC Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

In addition, as more fully described in Note 1E, the Plan's financial statements do not present information regarding certain investments in annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. The Plan Administrator has elected to exclude those contracts and accounts and related activity from the Plan's financial statements for purposes of the annual reporting requirements of the Employee Retirement Income Security Act of 1974 (ERISA) as permitted by Department of Labor Field Assistance Bulletin 2009-02, *Annual Reporting Requirements for 403(b) Plans*. Presentation of this information is required by the modified cash basis of accounting. The effects of this departure from the modified cash basis of accounting on the Plan's financial statements are not reasonably determinable.

Basis of Accounting

We draw attention to Note 2A of the financial statements, which describes the basis of accounting. The financial statements and the supplemental schedules are prepared on the modified cash basis of accounting which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2, which includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Frederica Academy 403(b) DC Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing

standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of Frederica Academy, Inc. (the “Academy” or “Plan Sponsor”) 403(b) DC Plan (the “Plan”), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

- A. *General.* The Plan is a defined contribution 403(b) plan covering all employees of the Academy except for student employees and employees who typically work less than 20 hours per week. Employees are eligible to contribute pre-tax contributions immediately and become eligible to receive employer contributions on the day of completion of 1 year of service at an educational organization or teaching institution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Coronavirus Aid, Relief, and Economic Security Act. The Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”) was signed into law on March 27, 2020. The CARES Act allowed retirement plans to provide participants who were impacted by the coronavirus (as defined in the CARES Act) with greater access to their savings. The Plan Sponsor adopted the provisions of this Act and is in the process of amending the plan document accordingly. The ability to utilize the provisions of the CARES Act ceased as of December 31, 2020.

The *Securing a Strong Retirement Act* (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2023 and later. The Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly.

- B. *Contributions.* Participants may contribute up to 100% of their pretax annual compensation, as defined by the Plan, except that no employee may make annual tax-deferred contributions in excess of amounts as provided by the Internal Revenue Code. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Academy contributes 6% of base compensation for participants that contribute 4% or more of their base compensation.
- C. *Participant Accounts.* Each participant's account is credited with the participant's deferral contribution and allocations of (a) the Academy’s contribution (if any) and (b) plan earnings. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- D. *Vesting.* Participants are immediately vested in their contributions plus actual earnings thereon and in the Academy’s matching contributions plus actual earnings thereon.
- E. *Beginning Balances:* The investment and transaction data prior to January 1, 2009, regarding certain investments in annuity contracts and custodial accounts issued to current and former employees, are not sufficient to provide assurance with regards to the December 31, 2009 balances and ultimately, the December 31, 2024 and 2023 balances as reported on the statements of net assets available for benefits – modified cash basis. Given the number of years the Plan has been in existence, it is not possible to obtain required transaction data and investment detail. The Plan Administrator has elected to exclude those contracts and accounts and the related activity from the Plan’s financial statements in accordance with the transition relief provided by Department of Labor Field Assistance Bulletin 2009-02, *Annual Reporting Requirements for*

403(b) Plans. Presentation of this information is required by the modified cash basis of accounting. The effects of this departure from the modified cash basis of accounting on these financial statements are not reasonably determinable.

- F. *Plan Loans.* The Plan was amended January 1, 2020 to not allow plan loans. Previously, participants were allowed to borrow amounts directly from the Plan's custodian. Plan loans could be requested by a participant, using their account as collateral for the loan. A plan loan is not treated as a distribution from the Plan and is not considered a Plan asset. Therefore, plan loans are not reported on the statements of net assets available for benefits.

There is one outstanding plan loan which was issued prior to the amendment. As of December 31, 2024 and 2023, \$3,082 and \$6,008, respectively, of a participant's account served as collateral for the outstanding loan balance. The interest rate of the outstanding plan loan was 5.28%.

- G. *Payment of Benefits.* A participant's deferral contributions and employer contributions may be withdrawn upon retirement (on or after the attainment of normal retirement age), attainment of age fifty-nine and a half, termination of employment, and death. Upon disability, only participant's contributions may be withdrawn. Additionally, participant contributions rolled over from a previous plan may be withdrawn at any time.

A participant may elect to receive payment in the form of a lump sum of a participant's entire vested account balance, a single sum distribution of a portion of the participant's vested account balance, an installment payment over a fixed number of years, or apply the participant's vested account balance toward the purchase of an annuity contract. Distributions must be taken in a single distribution of cash as soon as administratively feasible if, upon termination, the participant's account balance is equal to or less than \$1,000.

- H. *Plan Expenses:* Certain expenses of maintaining the Plan are paid directly by the Academy and are excluded from these financial statements. Custodian administrative fees are paid by the Plan in the form of reductions of net investment income earned by participants and are included in the net depreciation in fair value of investments.

2. Summary of Accounting Policies

- A. *Basis of Accounting.* The accompanying financial statements have been prepared on the modified cash basis. Investment income is recognized when received, and disbursements are recognized when made. Additionally, securities investments are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the plan in accordance with accounting principles generally accepted in the United States of America.
- B. *Use of Estimates.* The preparation of financial statements in conformity with the modified cash basis requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C. *Investment Valuation and Income Recognition.* The Plan's investments are reported at fair value, with the exception of fully benefit-responsive investment contracts ("FBRIC"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the

Plan's valuation policies utilizing information provided by the investment advisors and the custodians. See Note 4 for discussion of fair value measurements.

The Plan's fully benefit-responsive investment contracts (see Note 5) are valued at contract value. Contract value equals the accumulated cash contributions and interest credited to the Plan's contracts.

Purchase and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. *Payment of Benefits.* Benefit payments are recorded when paid.

3. Information Certified by the Plan's Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF ("TIAA") and The Variable Annuity Life Insurance Company ("VALIC"), the custodians of the Plan, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the investments on the schedule of assets (held at end of year).

4. Fair Value Measurements

FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described below:

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following discussion describes the valuation methodologies used for assets measured at fair value on a recurring basis. The techniques utilized in estimating the fair values of financial instruments are reliant on the assumptions used. Care should be exercised in deriving conclusions based on the fair value information of financial instruments presented below.

Fair value estimates are made as of a specific point in time, based on available market information and judgments about the financial instrument. Such estimates do not consider the tax impact of the realization of unrealized gains or losses. In addition, the disclosed fair values may not be realized in the immediate settlement of the financial instrument. No significant changes were made to the valuation process during 2024 and 2023.

Fixed Annuity Contracts:

The Plan offers two types of TIAA fixed annuity contracts, Supplemental Retirement Annuities (“SRA”) and Group Supplemental Retirement Annuities (“GSRA”), and two VALIC fixed annuity contracts, all of which are fully-benefit responsive contracts and are reported at contract value (see Note 5). The Plan also offers a TIAA fixed annuity contract, Retirement Annuities (“RA”) Traditional Annuity Contract, which is non-fully-benefit-responsive (“NFBR”) and totaled \$974,468 and \$933,611 as of December 31, 2024 and 2023, respectively. The RA contract is a fixed rate annuity contract that is fully and unconditionally guaranteed by TIAA and backed by TIAA’s claims-paying ability and is reported at fair value. The value equals the accumulated cash contributions and interest credited to the Plan’s contract, less withdrawals and transfers, if any. The TIAA Traditional Annuity Contract is not available for sale or transfer on any securities exchange. The fixed annuity contract is subject to various restrictions.

Variable Annuities:

TIAA Access, CREF, and VALIC variable annuities: These funds are registered investments that invest in mutual funds. Units held in these variable annuities are valued at NAV. The NAV, as provided by TIAA and VALIC, is used as a practical expedient to estimate fair value. The NAV is measured based on the fair value of the underlying investment held by the fund less its liabilities. The fair value of the underlying investments is determined using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing. Money market account holdings are generally valued at amortized cost. On a daily basis, units in the registered investments are revalued to reflect the performance of the underlying investments minus as fees and charges.

Real Estate Annuity: Units held in the TIAA Real Estate Account (REA) are valued at Net Asset Value (“NAV”) based on the fair market value of the underlying investments of the account less its liabilities. The REA holds between 15% and 25% of its net assets in investments other than real estate and real estate related investments, comprised of publicly traded, liquid investments. Determination of fair value of the real estate assets involves a significant judgement. Valuation of the REA’s real estate properties is based on real estate appraisals, which are estimates of property values based on a professional’s opinion and may not be an accurate predictor of the amount the REA would actually receive if it sold a property.

Additionally, the REA generally obtains appraisals on a quarterly basis. Therefore, there may be instances in the period between appraisals or interim valuation adjustments in which the true realizable value of a property is not reflected in the REA’s daily NAV calculation. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During 2024 and 2023, the TIAA Traditional Annuity Contract (NFBR) had purchases totaling \$29,202 and \$37,062, respectively.

5. Guaranteed Investment Contracts with Insurance Companies

The Plan holds guaranteed investment contracts from TIAA and from VALIC. Both TIAA and VALIC maintain the contributions in general accounts. The accounts are credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

TIAA SRA and GSRA contracts are fully benefit-responsive and are presented on the statements of net assets available for benefits at contract value and total \$204,402 and \$205,738 as of December 31, 2024 and 2023, respectively. The guaranteed investment contracts with VALIC are fully benefit-responsive and presented on the statements of net assets available for benefits at contract value and total \$153,412 and \$149,949 as of December 31, 2024 and 2023, respectively. Contract values, as reported to the Plan by TIAA and VAIC, represent contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer, but it may not be less than 3.0% for both the TIAA and the VALIC contracts. Such interest rates are reviewed on an annual basis for TIAA contracts and a monthly basis for VALIC contracts.

Certain events limit the Plan's ability to transact at contract value with issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples

of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with plan participants or the issuer, is probable.

The guaranteed investment contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity date.

6. Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by TIAA and VALIC, custodians of the plan assets. Such investments involving the custodians qualify as exempt party-in-interest transactions.

7. Plan Termination

Although it has not expressed intent to do so, the Academy has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. Tax Status

The Plan is a defined contribution retirement plan intended to qualify under Section 403(b) of the Internal Revenue Code. The Plan was adopted from a pre-approved plan document sponsored by TIAA which received a favorable IRS opinion letter dated August 7, 2017. The opinion letter provides assurance that the form of the plan document complies with the requirements of Section 403(b). To maintain its tax-qualified status, the Plan must be operated in accordance with the applicable provisions of the Code. Plan management believes the plan is currently designed and operating in accordance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risk and Uncertainties

The Plan provides various investment options. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Delinquent Participant Contributions

The plan sponsor has \$234,664 of participants' deferral contributions that have not been remitted timely and require correction. Of that total, \$231,875 employee withholdings have been remitted, and \$2,789 employee withholdings have yet to be remitted to the Plan. The Plan Sponsor is in the process of calculating the amount of lost earnings for the late remittances and depositing the withholdings and lost earnings into the affected participants' accounts.

11. Subsequent Events

Plan management evaluated the need for disclosures or adjustments resulting from subsequent events through October 10, 2025, the date the financial statements were available for issuance:

Effective January 1, 2025, the Plan was amended for the following:

- Open plan eligibility up to all employees with a minimum age of 21 years
- Increase the threshold of force-out distributions for participants with total balances up to \$5,000.

No other material events were identified which require disclosure in or adjustment to the financial statements.
