## INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor of the  
Shapiro Sales Company Employees' Savings Plan and Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Shapiro Sales Company Employees' Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ## NOTES TO THE FINANCIAL STATEMENTS

### (1) Plan Description

The following description of Shapiro Sales Company Employees' Savings Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### *General Information*

The Plan, which was established January 1, 1979 and subsequently amended, is a defined contribution and 401(k) plan covering substantially all employees of Shapiro Sales Company (the "Company") who meet the eligibility provisions of the Plan. The Plan is subject to provisions of ERISA.

#### *Contributions*

Each year, participants may contribute up to 100% of their eligible compensation, as defined in the Plan, not to exceed the maximum amount allowed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes a provision for a safe-harbor matching contribution of 100% of the participant deferrals up to 3% of the eligible compensation plus 50% of the participant deferrals that exceed 3% of the eligible compensation but do not exceed 5%. In addition, the Plan includes a provision for a matching and profit-sharing contribution determined by the Company at its discretion. Additional amounts may be contributed at the option of the Company's Board of Directors. Participants direct the investment of the contributions into various investment options offered by the Plan.

#### *Eligible Participants*

Employees are eligible to participate in the Plan if they are at least 18 years of age (changed from 21 years as of July 1, 2024). Employees are eligible to participate in Company profit-sharing contributions if they are at least 18 years of age (changed from 21 years as of July 1, 2024) and have completed one year of service. An eligible employee means any employee of the Plan Sponsor other than a leased employee, certain union employees, or non-resident alien with no U.S. source income. Under a collective bargaining contract, employees of Teamsters Local 245 are eligible employees. Unless an employee opts out of participating in the Plan, the employee will be automatically enrolled to defer 3% of eligible compensation upon attainment of eligibility.

#### *Participant Accounts*

Each participant's account is credited with (a) the participant's contributions, (b) the Company's contributions, and (c) Plan earnings and appreciation. Each participant's account is charged with (a) any withdrawals or distributions, (b) Plan losses and depreciation, and (c) an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately vested in their elective deferrals, employer safe-harbor matching contributions and rollover contributions, plus or minus actual earnings or losses thereon.

For employer discretionary matching and profit-sharing contributions to the Plan, participants will vest as follows:

Participants are fully vested in employer contributions upon the attainment of normal retirement age, retirement due to disability, death, or the termination of the Plan.

Participants are considered to have completed one year of service upon the completion of 1,000 hours of service at any time during the employment year.

#### *Forfeited Plan Assets*

If a participant forfeits any unvested balances in his/her account, the forfeited assets are used to reduce future employer contributions. There were no forfeitures used to reduce employer contributions for the years ended December 31, 2024 and 2023. As of December 31, 2024 and 2023, the Plan held immaterial amounts of unallocated investments available to reduce future employer contributions.

#### *Notes Receivable from Participants*

Subject to provisions under the Plan, participants may borrow from the Plan an amount which does not exceed the lesser of \$50,000 or 50% of the present value of the participant's vested benefit under the Plan. Notes receivable, which are secured by the balance in the participant's account, bear interest at 1% above the prime interest rate, and have terms which range from 12 to 60 months, unless the loan was made for the participant to acquire his/her principal residence. In this case, the term is for a period that ranges from 12 to 360 months. Principal and interest are paid ratably through weekly or semi-monthly payroll deductions or may be repaid before maturing without penalty.

#### *Retirement and Terminations*

In the case of normal retirement or retirement due to permanent disability, participants will receive the value of their vested plan benefits, in accordance with the provisions of the Plan, either in a lump-sum distribution or partial withdrawals. Installments are only permitted for required minimum distributions.

In the event that a participant dies before retirement, the beneficiary will receive the value of the participant's vested plan benefit in a lump-sum distribution.

In the case of termination of an employee, the participant may request early payment of the vested benefit by submitting a withdrawal form online. The portion of the terminated participant's account balance that is not vested is forfeited and remains in the Plan to reduce future employer contributions.

### (1) Plan Description (Continued)

#### *In-Service Distributions*

The Plan allows for in-service distributions upon the attainment of 59-1/2 years and only from funds in which the participant is 100% vested.

#### *Hardship Withdrawals*

The Plan allows for hardship withdrawals, as defined in the Plan, which are limited to the amount needed to meet the financial need. These withdrawals may not be recontributed to the Plan and may be subject to income tax and penalties.

#### *Administration*

Charles Schwab Trust Bank ("Schwab") is the Plan's custodian. Epic Retirement Plan Services, LLC ("Epic") is the Plan's third party administrator. All assets of the Plan are held by Schwab and managed by Epic.

### (2) Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual method of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. The fair value of the Plan's other financial instruments approximates their carrying amounts, either because the expected collection or payment period is relatively short or because the terms are similar to market trends. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### (2) Summary of Significant Accounting Policies (Continued)

#### *Investment Risk*

Participants in the Plan assume all adverse investment risk connected with any decrease in value of plan assets, and such assets are the sole source of payments under the Plan.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan document.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Administrative Expenses*

It is the policy of the Plan that certain administrative expenses pertaining to the Plan be paid by the Company. It is the policy of the Plan that certain administrative expenses pertaining to the Plan be paid by the Plan, except for the fees of the independent auditor issuing the accompanying report, which are paid by the Company.

#### *Subsequent Events*

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

### (3) Transactions with Parties-In-Interest

The Plan is administered by the Company. Employees of the Company serve as the Plan's administrators and trustees and participate in the Plan. The Company pays the administrative expenses related to the Plan except for the annual investment charge that each fund charged to its participants in 2024 and 2023. All investment funds are managed by Epic.

### (4) Fair Value Measurements

Under the Fair Value Measurements and Disclosures topic of the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”), a guideline is provided for measuring fair value under generally accepted accounting principles. The topic establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs include quoted prices in active markets for similar assets, quoted prices in inactive markets for similar assets, or inputs that are observable or can be corroborated by observable market data or other means for substantially the full term of the asset; and Level 3 inputs have the lowest priority and are based on prices or valuation techniques that are unobservable and not corroborated by market data. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when an active market comparable is not available and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### *Level 1 Fair Value Measurements*

The fair values of cash are based on quoted net asset values. The fair values of the registered investment companies are based on quoted market prices.

The Plan enters into common/collective trusts with Schwab, investing in collective trust funds as well as a variety of separate accounts and mutual funds. The common/collective trusts are valued at net asset value, which serves as a practical expedient to estimate fair value of a common/collective trust. The net asset value, which is not publicly quoted, is based upon the underlying investments and vendor pricing agents.

#### (5) Common/Collective Trusts at Contract Value

The Plan enters into fully benefit-responsive common/collective trust contracts with Schwab. Schwab maintains the contributions in the general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Schwab. Contract value approximates fair value for these investments as of December 31, 2024 and 2023 of \$219,857 and \$282,482, respectively. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The common/collective trust contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Certain events limit the Plan's ability to transact at contract value with Schwab. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan; or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

The common/collective trust contracts do not permit Schwab to terminate the agreement prior to the scheduled maturity date.

The interest rates are reviewed on a quarterly basis for resetting. The average yields based upon actual earnings at December 31, 2024 and 2023 were 4.88% and 4.92%, respectively. The interest rates credited to participant accounts at December 31, 2024 and 2023 were 3.35% and 2.93%, respectively.

### **(6) Certification**

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C). As permitted under such election, the Plan administrator has obtained certifications from Schwab that the investment and loan balances and their related income as reported in the accompanying financial statements are complete and accurate.

### **(7) Plan Termination Policies**

Although it has not expressed intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions set forth in ERISA. In the event of termination of the Plan, the right of all participants to benefits would become 100% vested and nonforfeitable. The amount of the account balance due each participant would be distributed in accordance with the payment provisions of the Plan.

### **(8) Internal Revenue Service Status**

The Internal Revenue Service has determined and informed the plan administrator by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan was amended subsequent to this date; however, the plan administrator and management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan accounts for any uncertain tax positions in accordance with the Income Taxes topic of the FASB ASC. The topic prescribes a recognition threshold and measurement process for financial statement recognition of uncertain tax positions taken or expected to be taken in an annual return/report of an employee benefit plan. In evaluating the Plan's tax position, interpretations and tax planning strategies are considered. The Plan believes its tax-exempt status is appropriate based on current facts and circumstances.

### **(9) Risks and Uncertainties**

The Plan invests in various securities. The underlying investments may include corporate debt instruments and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
