#### **Opinion**

We have audited the financial statements of **ACSM, Inc. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**(1) Description of the Plan**

The following description of the **ACSM, Inc. Employee Stock Ownership Plan** (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. General** - ACSM, Inc. (the “Company” or the “Plan Sponsor”) established the Plan effective January 1, 2022. The Plan operates as a leveraged employee stock ownership plan (“ESOP”), designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (“IRC”), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan is administered by a trustee and a Plan Administrator and Committee appointed by the Company.
- B. Eligibility** - Employees of the Company who are 18 years of age and have completed one year of service are generally eligible to participate in the Plan. Excluded employees include those represented by collective bargaining agreements, leased, independent contractors, and non-resident aliens, and stockholders of the Company who have sold common stock of the Company to the Plan. For purposes of eligibility, a year of service is defined as the completion of 1,000 hours of service in a period of twelve consecutive months. Eligible employees enter the Plan on the first day of January or July of each Plan year after he or she becomes eligible.
- C. Contributions** - The Company makes annual contributions in an amount equal to or greater than the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on the ESOP Loan. For the 2024 Plan year, the Company authorized contributions totaling \$2,206,282, of which \$2,118,201 was for minimum debt service requirements and \$88,081 was for liquidity to fund the Plan’s benefit payments.
- D. Dividends** - The declaration of dividends by the Company or other distributions made by the Company on shares owned by the Plan is discretionary. No dividends were declared during the 2024 Plan year.
- E. Participant accounts** - Each participant’s account is credited as of the last day of each Plan year with an allocation of shares of the Company’s common stock released by the trustee from the unallocated account and forfeitures of terminated participants’ non-vested accounts.

Allocations of Company contributions and forfeitures are based on each participant’s share of points earned relative to total participant points allocable for each Plan year. A participant is credited with one point for each \$1,000 of eligible compensation, as defined in the Plan document, plus ten points for each year of service. In order to be credited with an allocation, the employee must have worked at least 1,000 hours during the Plan year, be employed on the last day of the Plan year, or their death, disability or retirement date must have fallen within the Plan year. During 2024, approximately 1,181 shares of forfeited common stock were reallocated to Plan participants.

Allocations of Plan earnings are based on participant account balances or eligible compensation, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

- F. Vesting** - Participants vest 100% in the Company’s contributions, plus earnings thereon, upon the earlier of (i) reaching age 65 and five years of service, death, or disability, as defined by the Plan document, or (ii) based on years of credited service as follows:

**G. Payment of benefits** - Distributions from the Plan due to death, disability, or retirement, as defined by the Plan, shall commence as soon as administratively feasible following the end of the Plan year in which such event occurs. On termination of service due to reasons other than death, disability, or retirement, if a participant's vested account balance is \$7,000 or less, a lump sum distribution will be made to the participant as soon as administratively feasible after employment is terminated, however, the Plan Administrator may elect to delay such distributions up to an additional five Plan years, subject to certain provisions per the IRC.

Any common stock allocated to a participant's account that was acquired with proceeds from the ESOP Loan is not eligible for distribution until the earlier of (i) the close of the Plan Year in which the ESOP Loan is repaid in full, or (ii) the tenth Plan Year, subject to certain provisions per the IRC. Generally, if the vested account balance exceeds \$7,000, the distribution will be in substantially equal annual payments over a period of:

- Five years; or
- If the vested balance is greater than \$1,230,000, then five years plus one additional year for each \$245,000 or fraction thereof over \$1,230,000 (but not more than five additional years). These dollar amounts are raised periodically in accordance with the IRC.

**H. Termination of the Plan** - The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

**I. Administrative expenses** - Substantially all administrative expenses of the Plan are paid by the Company and are not reimbursed by the Plan.

**J. Voting rights** - The trustee shall vote all Company stock held by it as part of the Plan assets. However, each participant is entitled to direct the trustees as to the manner in which voting rights on the Company's common stock attributable to the shares allocated to his or her account are to be exercised. The trustee shall vote any allocated shares for which a participant has failed to give timely voting direction and votes such shares in the collective best interests of the participants.

**K. Put option** - Under federal income tax regulations, employer stock that is held by a plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years, with the first installment paid no later than 30 days after a participant exercises the put option. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

- L. Diversification** - Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in the Company common stock to investments which are more diversified. Participants who have attained age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive cash for a stock distribution that is repurchased by the Company for cash. The election to diversify is made subsequent to year-end based upon the shares of company stock in the participant's account at year end.
- M. Reshuffling** - The Plan Administrator, at its discretion, may reshuffle the Company stock accounts, as defined in the Plan document, of certain terminated participants and alternate payees by converting the vested and non-vested shares of the Company's common stock of such participants to cash, subject to certain limitations defined in the Plan document.

**(2) Summary of significant accounting policies**

The significant accounting policies followed by the Plan are summarized below:

**Basis of accounting** - The financial statements of the Plan are prepared using the accrual method of accounting. Accordingly, income and contributions are recognized when earned, and expenses are recorded when incurred.

**Management's use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Actual results could differ from those estimates.

**Investment valuation and income recognition** - Shares of the Company's common stock are reported at fair market value, which approximates fair value and is determined by an annual independent appraisal. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

**Payment of benefits** - Benefits paid to participants are recorded in the period in which they are paid.

**Risks and uncertainties** - The Plan's investments consist of the Company's common stock. Investments are exposed to various risks, such as interest rate, lack of marketability and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Subsequent events** - The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

**(3) Fair value measurement**

The investments in the Plan are stated at fair value in accordance with the Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement* ("ASC 820"). ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The fair value of the Plan's investment in the sponsor company common stock is measured using Level 3 inputs within the fair value hierarchy. As of December 31, 2024 and 2023, the Plan's investment in the sponsor company common stock totaled \$12,949,200 and \$6,598,350, respectively.

The table below sets forth a summary of changes in the fair value of the Plan's level 3 investments for the year ended December 31, 2024:

The Plan's level 3 investments have been determined based on an appraisal by an independent third-party valuation specialist. The sponsor company common stock held by the Plan was valued on a non-marketable, 100% controlling interest basis. Valuation of the sponsor company common stock was determined by applying various valuation techniques including the mergers and acquisitions and discounted cash flow methods. Various assumptions were incorporated into each of these methods in arriving at an overall fair value that was determined using a weighted average.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain assets or liabilities could result in a different fair value measurement at the reporting date.

**(4) Loan payable**

On February 3, 2023, the trustee of the Plan entered into a Stock Purchase Agreement (“SPA”) whereby the ESOP purchased 495,000 shares of common stock held by the Selling Stockholder of the Company for an aggregate purchase price of \$22,027,120. The purchase of the common stock was funded by \$2,400,000 of cash held in the ESOP and a \$19,627,120 Internal ESOP Note. Concurrently, an Assignment & Assumption Agreement was executed whereby the Company was assigned the rights of the Selling Stockholder under the Internal ESOP Note and assumed the obligations of the ESOP to the Selling Stockholder (“ESOP Loan”).

The ESOP Loan is collateralized by the unallocated shares of common stock, bears interest at 3.86% annually, and is payable in annual installments of principal and interest commencing January 1, 2024, with a final payment of outstanding principal and accrued interest due upon maturity on January 1, 2063.

Dividends, distributions and fully tax-deductible Company contributions to the Plan will be used to repay the loan. As the Plan makes each payment of principal, an appropriate percentage of common stock will be allocated to eligible employees’ accounts in accordance with applicable regulations under the IRC. The sellers will have no rights against shares of common stock once they are allocated under the Plan.

**(5) Party-in-interest transactions**

As of December 31, 2024 and 2023, all of the Plan’s investments are shares of common stock of the Company, which qualify as party-in-interest transactions. In addition, during the year ended December 31, 2024, the Plan made payments towards the outstanding loan payable described in Note 4. As the loan payable is between the Plan and the Plan Sponsor, the loan repayments qualify as party-in-interest transactions.

The Plan holds non-interest bearing cash in an account managed by UMB Bank, N.A.; therefore, these transactions qualify as party-in-interest transactions. Administrative fees for these services were substantially paid for by the Company.

**(6) Income tax status**

The Plan received a favorable determination letter from the Internal Revenue Service (“IRS”) dated August 13, 2024 stating that the Plan is qualified under the applicable sections of the IRC and the related trust established under the Plan is tax-exempt. The Company and the Plan Administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.
