We have performed an audit of the financial statements of Umatilla-Morrow Head Start, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Description of Plan

The following description of the Umatilla-Morrow Head Start, Inc. (the Organization) 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Organization established the Plan to provide employees with a systematic means of saving and investing for the future. The Plan is a defined contribution plan under Code 403(b)(7), originally effective January 1, 2012, and most recently restated as of January 1, 2022, covering substantially all eligible employees of Umatilla-Morrow Head Start, Inc. The Plan has been amended throughout the years to comply with tax legislation. The Plan excludes nonresident aliens and employees covered by a collective bargaining agreement. Prior to January 1, 2022, the Plan also excluded Hermiston employees who were eligible to participate in another 403(b) plan that the employer sponsored (Umatilla-Morrow Head Start, Inc. 403(b) Plan One). Effective January 1, 2022, Umatilla-Morrow Head Start, Inc. 403(b) Plans One and Two merged into one Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by trustees who receive assistance from a retirement plan administration organization which processes and maintains records of participant account activity.

Eligibility - Employees are eligible for salary deferrals upon the first day of employment with the employer. Employees are eligible for participation in employer discretionary nonelective and matching contributions in the Plan after the completion of one year of service and attainment of age 18. Employees enter the Plan on the first day of the month following the completion of the eligibility requirements.

Contributions – Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization makes matching contributions of 100% of employee deferrals, up to 3% of annual compensation. The Organization, at its discretion, may also make discretionary nonelective contributions to the Plan. The Organization made matching contributions of \$130,858 and discretionary nonelective contributions of \$371,936 for the year ended December 31, 2024. Contributions are subject to certain statutory limitations.

Participant Accounts - Each participant's account is credited with the participant's contribution and Organization matching contributions, as well as allocations of (a) the Organization's nonelective contributions and, (b) Plan earnings or losses, and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Note 1 – Description of Plan (continued)

Vesting – Participants are immediately vested in their contributions, plus actual earnings thereon.

Vesting in the Organization’s matching and discretionary nonelective contributions, plus actual earnings thereon, is based on years of credited service. A participant is 100 percent vested after five years of credited service.

Benefit Payments - Upon termination of service, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account, subject to Plan provisions. The Plan allows for in-service installment or lump-sum distributions of the participant’s vested account balance if a participant reaches age 59 ½, subject to Plan provisions. If a participant terminates employment and the participant’s account balance does not exceed \$5,000, the Plan administrator may authorize the benefit payment without the participant’s consent.

Forfeited Accounts - Forfeited non-vested accounts may be used to first pay Plan expenses and then reduce employer contributions. Forfeiture amounts totaled \$17,427 and \$427 at December 31, 2024 and 2023, respectively. Forfeitures of \$31,514 were used to pay Plan expenses for the year ended December 31, 2024.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Benefit Payments - Benefits are recorded when paid.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Administrative Expenses – Certain administrative expenses of the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to participant contributions.

Subsequent Events - In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 – Guaranteed Investment Contracts

The Plan has fully-benefit-responsive guaranteed investment contracts with Empower Annuity Insurance Company of America, Western United Life Insurance Company, and Kansas City Life Insurance Company (collectively, “The Companies”). The Companies maintain the contributions in their general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully-benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed interest accounts. The fixed interest accounts are presented at contract value on the face of the statement of net assets available for benefits. Contract value, as reported to the Plan by the Companies, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract values for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers, but it may not be less than 4 percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan’s prohibition on competing investment options; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan’s normal operations; (4) the failure of the Plan to qualify under 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax exempt under Section 501(a) of the IRC; or (5) premature termination of the contract. The Plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan’s investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100 percent vested in their employer contributions.

Note 8 – Plan Tax Status

The Plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan is required to operate in accordance with the Internal Revenue Code (IRC) to maintain the tax-exempt status for plan participants under Section 403(b). The Internal Revenue Service (IRS) has determined the Plan is designed in accordance with the applicable sections of the Internal Revenue Code by an opinion letter dated March 31, 2017.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Related Party and Party-In-Interest Transactions

The Plan investments were managed by Empower Annuity Insurance Company of America, as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

The sponsor is a party in interest to the Plan. However, there were no transactions with the sponsor other than the sponsor contributions and payment of certain administrative expenses to the Plan. These transactions qualify as exempt party in interest transactions.
