### Report on the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C)**

We have performed audits of the accompanying financial statements of Halvik Corp. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 DESCRIPTION OF PLAN**

The following description of the Halvik Corp. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution safe harbor plan originally effective January 1, 2010. The Plan has been amended throughout the years to comply with tax legislation and was most recently amended effective December 1, 2023. The Plan excludes leased employees, union employees, and nonresident aliens. The Plan provides retirement benefits to qualified employees of Halvik Corp., SP Systems, and SSB (collectively, the Company). The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Ascensus Trust Company serves as the trustee of the Plan effective December 1, 2023.

**Eligibility**

Employees of the Company are eligible to participate in the deferral and match components of the Plan upon turning 21 years of age and having three months of service. Employees are eligible to participate in the safe harbor component of the Plan upon turning 21 years of age and having one year of service. Employees are eligible for Company prevailing wage contributions upon service for the respective contract. Employees will become participants in the Plan on the first day of the Plan year quarter following the date they meet the participation requirements.

**Contributions**

Each year, participants may contribute a certain percentage up to 90% of their annual eligible compensation, as defined in the Plan, subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may make Roth contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Company makes safe harbor matching contributions in an amount equal to the sum of 100% of the amount of the participant's elective deferrals that does not exceed 3% of the participant's annual eligible compensation, plus 50% of the amount of the participant's elective deferrals that exceeds 3%, but does not exceed 5% of the participant's eligible compensation.

The Company may make discretionary nonelective contributions annually to the Plan. For the year ended December 31, 2024, the Company did not make discretionary nonelective contributions to the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's safe harbor matching, as well as allocations of (a) the Company's discretionary nonelective contributions, if any, and (b) Plan earnings (losses), and (c) administrative expenses. Allocations are based on account balances, compensation, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions, safe harbor matching contributions, and the Company's prevailing wage contributions, plus actual earnings thereon. Vesting in the Company's discretionary nonelective contributions are based on the following schedule:

If a participant terminates due to death or total and permanent disability, they will automatically become 100% vested in their entire account balance.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are collateralized by the balance in the participant's account and bear interest at rates equal to commercially reasonable rate of interest at the time of the loan. Loans are to be repaid within a period of five years, unless used for the purchase of a principal residence, in which repayment length is determined by the Plan administrator. Loans are repaid through payroll deductions based upon an established amortization schedule.

**Benefit Payments**

On termination of service due to retirement, disability, death, or other reasons, a participant will receive benefit payments in the form of a lump sum, partial payment, or installment payments, equal to the vested value of the participant's account. Upon reaching age 59½, a participant may elect to withdraw all or a portion of their vested account while still employed with the Company. Participants may withdraw voluntary contributions from their accounts by reason of financial hardship, under specific guidelines set forth in the Plan. Upon termination of employment, if the participant's vested interest in the value of their termination benefits does not exceed and has not exceeded \$1,000, at the time of any prior distributions, the participant will receive an immediate lump-sum cash payment of their vested balance. If a participant's vested interest at such time exceeds \$1,000 but not \$5,000, the participant's account will be distributed in a direct rollover to another qualified plan, unless the participant requests otherwise. At all times, participants may withdraw in total or a portion of their rollover contributions.

**Forfeitures**

Forfeited nonvested accounts were \$4,909 and \$17,690 at December 31, 2024 and 2023, respectively. Forfeitures may first be used to pay any administrative expenses and any remaining amounts will be used to reduce future Company contributions. Forfeitures of \$13,123 were used to reduce Company contributions during the year ended 2024.

**Reclassifications**

Certain amounts in the 2023 financial statements have been reclassified to conform with the 2024 presentation. These reclassifications do not affect net assets available for benefits as previously reported.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment adviser, insurance company and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Funds:* The fair value of money market funds is determined by obtaining quoted prices published on nationally recognized securities exchanges, which are generally classified within Level 1 of the fair value hierarchy.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust:* Valued at the NAV of units as determined by the issuer. NAV is a readily determinable fair value and is the basis for current transactions.

**NOTE 7 PLAN TAX STATUS**

The Plan adopted a prototype plan which had received a determination letter dated June 30, 2020, from the Internal Revenue Service (IRS) which stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
