## Independent Auditor's Report

**To the Plan Administrator and Trustees**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Engolve Employee Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the U.S. Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—



# Notes To Financial Statements

## NOTE 1. PLAN DESCRIPTION

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Envolve Employee Savings Plan (the "Plan") is a defined contribution plan covering all eligible employees of Envolve Client Services Group, LLC (the "Company"). The Plan also covers all eligible employees of Envolve Community Management, LLC; Ross Management LMG, LLC; and MacDonald Property Management, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

During 2020, the Plan changed its name from LEDIC Management Group Employee Savings Plan to Envolve Employee Savings Plan.

### **Participation**

In order to participate in the Plan, the employee must be at least age 21 and have completed twelve months of service. The employee will become a participant on the first day of the quarter following completion of the eligibility requirements.

### **Contributions**

Each year, participants may contribute a certain percentage of their compensation as defined in the Plan. The Plan allows participant contributions up to the maximum allowed by the Internal Revenue Service ("IRS"). Participants direct the investment of their contributions into investment options offered by the Plan. The Plan currently offers various mutual funds held in pooled separate accounts and a stable value collective trust fund as investment options for participants. The Plan provides for an automatic participant deferral of 3% upon attainment of eligibility. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company contributes a match of 50% of contributions up to 6% of eligible compensation.

### **Participant Accounts**

Each participant's account is credited with the participant's elective contributions, the employer's discretionary match, and allocations comprising (a) Plan earnings or losses and (b) expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1.****PLAN DESCRIPTION (CONTINUED)****Vesting**

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts, plus earnings thereon, is based on years of service. A participant is 100% vested after five years of credited service for matching contributions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%. Loan terms range from one to five years, or longer for the purchase of a primary residence. Principal and interest are paid ratably through monthly payroll deductions.

**Payment of Benefits**

A participant becomes eligible for distributions at the normal retirement age of 65 regardless of years of service. All distributions are paid in lump sum amounts. In the event of total and permanent disability, a participant shall be eligible to receive the entire amount in his individual account. If a participant dies while in the service of the Company, his or her beneficiary shall receive the entire amount of the participant's individual account. In the event of death of an inactive participant, any remaining benefits which were payable to the inactive participant shall be paid to his or her beneficiary.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested and nonforfeitable.

**Forfeitures**

If an employee terminates before his or her Company matching contribution account has become fully vested, such portion of the account is forfeited. Participant forfeitures are used to reduce future matching contributions by the Company or to pay Plan expenses. Participant forfeitures totaled \$41,727 and \$42,502 as of December 31, 2024 and 2023, respectively. The Plan used \$14,610 of forfeitures to reduce Plan expenses during 2024.

**NOTE 2.****SIGNIFICANT ACCOUNTING POLICIES****Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contribution Income**

The Plan records employer and employee contributions receivable when compensation is paid and deferrals are withheld. The Plan adopted ASC 326, Financial Instruments - Credit Losses, effective January 1, 2023, using the modified retrospective method. In accordance with ASC 326, no allowance for credit losses has been recorded at December 31, 2024 or 2023, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan had excess contributions payable of \$18,931 and \$6,065 for the years ended December 31, 2024 and 2023, respectively.

**Payment of Benefits**

Benefits are recorded when paid.

**NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Subsequent Events**

The Plan Administrator has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**NOTE 3. ADMINISTRATIVE EXPENSES**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The majority of the administrative expenses are paid directly by the Company; however, certain fees are paid directly from the Plan. Fees incurred by the Plan for investment management services are included in administrative expenses. Recordkeeping fees are also included in administrative expenses.

**NOTE 4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1 -** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2 -** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets,
- quoted prices for identical or similar assets or liabilities in inactive markets,
- inputs other than quoted prices that are observable for the asset or liability, and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3 -** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

*Mutual funds held in pooled separate accounts:* Valued at the net asset value ("NAV") of units of the pooled separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Withdrawals can be executed any time but are generally limited to one per calendar quarter. Were the Plan to initiate a full redemption of a pooled separate account, the investment adviser reserves the right to temporarily delay withdrawal from the account in order to ensure that the securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments related to the pooled separate accounts.

*Stable value collective trust fund:* Valued at the NAV of units of the collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments related to the stable value collective trust fund.

**NOTE 5. INFORMATION CERTIFIED BY PLAN CUSTODIANS**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company for the period from January 1, 2024 through September 30, 2024, and Fidelity Management Trust Company for the period from October 1, 2024 through December 31, 2024, the custodians of the Plan, have certified to the completeness and accuracy of the retirement investment fund contracts reflected in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule of Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024. As permitted under the election, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to said information certified by the custodians previously mentioned, except for comparing such information certified by the custodians to information included in the Plan’s financial statements and supplemental schedule. The Plan Administrator has obtained certifications from the custodians that the following information is complete and accurate.

**NOTE 6. INCOME TAX STATUS**

The IRS has determined that the volume submitter profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”) and informed the third-party administrator of such in a letter dated June 30, 2020. Although the Plan has been amended since adopting the volume submitter profit sharing plan, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds in pooled separate accounts and a stable value collective trust fund managed by Reliance Trust Company as of December 31, 2023 and the period from January 1, 2024 through September 30, 2024, and Fidelity Management Trust Company for the period from October 1, 2024 through December 31, 2024. Both are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions for the periods denoted above.

The Company pays directly any other fees related to the Plan's operations. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments.

**NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
