INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Velocity Outdoor Inc. - The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 **Description of the Plan**

The following brief description of the Velocity Outdoor Inc. Retirement Incentive Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a voluntary defined-contribution plan covering certain eligible employees of Crosman Corporation (Crosman), Ravin Crossbows LLC (Ravin), and Kings Camo LLC (Kings). The Plan is sponsored by Velocity Outdoor Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and is intended to qualify under Internal Revenue Code (IRC) §401(a) and §401(k).

The Plan is administered by the Company's Investment Committee.

Employees are eligible to participate in the Plan on the first day of the month after completing 60 days of service and attaining age 21.

During April 2024, Crosman was sold to an unrelated entity and ceased its participation in the Plan effective April 29, 2024. Crosman employees became fully vested in their account balances and were permitted to rollover their account balances from the Plan to any 401(k) plan established by the buyer or one of its affiliates.

Contributions

Under the provisions of the Plan, eligible participants can contribute in pre-tax dollars an amount up to 75% of their annual compensation, not to exceed the legal maximum deferral. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate within 45 days of attaining eligibility. All participants that are automatically enrolled in the Plan begin contributing 3% of their annual compensation and on an annual basis are automatically increased 1% each year up to a maximum of 15% of their annual compensation. The company contributes and allocates to each participant's account an amount equal to 50% of the participant's deferral contributions, up to a maximum contribution of 3%.

The maximum contribution allowed for deferral for United States federal income tax purposes in 2024 was \$23,000.

All employees eligible to make contributions under the Plan who have attained or will attain age 50 before the close of the Plan year are eligible to make catch-up contributions in accordance with, and subject to the limitations of, §414(v) of the IRC. The maximum allowable catch-up contribution for 2024 was \$7,500.

Vesting

Participants vest in the Company's matching contributions as follows:

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings and charged with withdrawals and an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings/(losses) or account balances, as defined. The assets of the Plan are valued daily, and gains or losses are allocated based on the participant's daily shares. Dividends are allocated when paid based upon participant's shares at the distribution date. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Participants (or their beneficiaries) are eligible to receive vested benefits upon retirement, death or when they cease to be an employee. A participant can also withdraw all or any portion of their vested account balance in the event of undue financial hardship, as defined in the Plan or upon attaining age 59½. Participants may keep any portion of their account in the Plan beyond the attainment of age 73. Inactive participants, after age 73, must take the required minimum distribution of their balances on or before April 1st of the calendar year after they retire.

Administrative Expenses

Certain Plan administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan's administrative expenses can be paid by the Plan.

Forfeitures

Forfeitures of nonvested employer contributions are applied first to the payment of Plan administrative expenses, to the extent not previously paid by the Company, with any excess being applied to reduce future contributions of the Company. The Plan utilized \$500 from the forfeiture account to pay administrative expenses for the year ending December 31, 2024. As of December 31, 2024 and 2023, forfeited nonvested employer contributions that remained to be used by the Company were \$33,873 and \$8,030 respectively.

Plan Service Credit Account

The Plan has a plan service credit account which is a suspense account funded with service revenue generated by the Plan. These funds may be used to pay or offset allowable Plan expenses.

The service revenue earned by the Plan in 2024 amounted to \$34,191 and is included in other income on the statement of changes in net assets available for benefits. Service revenue used to pay expenses was \$28,000 during 2024. The unused balance of this account amounted to \$20,651 and \$38,325 as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Under the Plan, participants may borrow from their fund accounts up to a maximum equal to the lesser of (i) 50% of their vested account balance, or (ii) \$50,000 reduced by the excess of their highest outstanding loan balances in the prior 12 months over their current outstanding loan balances at the date of the new loan. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. The maximum loan repayment period is five years unless the loan is for the purchase of a primary residence. The loans are collateralized by the balance in the participant's account and bear interest at a rate consistent with the prevailing commercial rate for similar type loans.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Subsequent Events

In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date that the financial statements were available to be issued.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Contributions

Participant contributions are recorded by the Plan when withheld from employees' paychecks. Employer contributions are recorded when earned by the participant.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with these securities, it is at least reasonably possible that changes in their values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 3 **Guaranteed Interest Account**

The Plan participates in a group annuity contract with New York Life Insurance Company (New York Life). New York Life maintains the contributions in a separate account, which is credited with earnings of the account's underlying investments and charged for participant withdrawals and administrative expenses. The contracts are recorded in the financial statements at contract value as reported to the Plan by New York Life. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract has certain restrictions that impact the ability to collect the full contract value; for example, if the contract were to be terminated, the Plan may elect to receive either an immediate lump sum distribution subject to a market value adjustment or receive a contract value distribution in six annual installments. In addition, withdrawals initiated by the Plan sponsor including total or partial plan termination, mergers, spin-offs, lay-offs, early retirement incentive programs, etc. may be subject to a market value adjustment. Any participant initiated transfer out of the stable value fund must first go through a non-competing investment option and reside there for at least 90 days before transfer to a competing investment option.

New York Life is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. Interest rates guaranteed by New York Life are to be no less than 1%, before any deduction for expenses.

Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. New York Life may not terminate the contract at any amount less than contract value.

Note 4 **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan follows the fair value measurement guidance required by accounting principles generally accepted in the United States of America for financial and nonfinancial assets and liabilities. This guidance defines fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan’s investments at fair value as of December 31:

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

The Plan presents in the statement of changes in net assets available for benefits, the net appreciation in the fair value of its investments which consists of the realized gains or losses and unrealized appreciation (depreciation) on those investments.

Note 5 **Certified Information**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, John Hancock Trust Company LLC (John Hancock), the trustee of the Plan, has certified to the completeness and accuracy of the following information:

- Investments and notes receivable from participants on the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, other income and interest on notes receivable from participants on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Registered Investment Companies, guaranteed interest account and participant loans on the Schedule of Assets (Held at End of Year) as of December 31, 2024.

Note 6 **Party-In-Interest**

Notes receivable from participants qualify as party-in-interest transactions, as defined by ERISA.

Note 7 **Tax Status**

The Plan adopted a pre-approved plan sponsored by John Hancock. The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status dated June 30, 2020. The pre-approved plan opinion letter has been relied upon by the Plan. The Plan has been amended since the pre-approved plan received the opinion letter. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
