## **INDEPENDENT AUDITOR'S REPORT**

To the Board of Trustees and participants of the  
Valkyrie Enterprises 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Valkyrie Enterprises 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules

that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of Plan

The following description of the Valkyrie Enterprises 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Valkyrie Enterprises, Inc. (Plan Sponsor) and its wholly owned subsidiaries, who have completed two months of service. Eligible employees may enter the Plan on the first day of the month after which eligibility has been attained. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended effective June 1, 2023 and employees may enter the Plan immediately following their hire date.

Effective January 1, 2024, the Plan was amended to change the safe harbor matching contribution to be calculated at 100% of 6% of eligible compensation per payroll period, rather than on an annual basis.

#### Contributions

Prior to June 1, 2023, all eligible employees were automatically enrolled in the Plan and pre-tax contributions were withheld at 3% of eligible compensation unless the employee elected differently. This deferral rate would automatically escalate annually by 1% to a maximum deferral of 6% unless otherwise elected by the participant. Effective June 1, 2023, the Plan was amended to remove the auto enrollment and the auto-escalation features. Participants may elect to make pre-tax and/or Roth contributions up to 100% of eligible compensation as defined in the Plan document, not to exceed \$23,000 in 2024, plus catch-up contributions of \$7,500 for those qualifying participants who are at least 50 years of age by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan Sponsor contributes an employer safe harbor matching contribution which is calculated at 100% of 6% of eligible compensation during the plan year. Prior to June 1, 2023, the Plan Sponsor could also make employer discretionary contributions to eligible participants who were active on the last day of the Plan year. Effective June 1, 2023, the Plan was amended and no longer allows for employer discretionary contributions.

The Plan Sponsor contributes employer wage rate contributions for certain employees working on a job to which a prevailing rate schedule is applied. During 2024, the Plan Sponsor made employer wage rate contributions in the amount of \$233,742 related to the 2024 Plan year.

### Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Plan Sponsor's contributions, and earnings and losses on the investments in their account and is charged with certain administrative expenses and transaction fees. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in all contributions plus actual earnings thereon.

### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have two notes outstanding at any time. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest determined by the plan administrator. During 2024, notes had fixed rates of 4.25% to 9.50% for the term of the note, not to exceed 5 years, unless used for the purchase of a residence. Principal and interest are paid through payroll deductions.

### Payments of Benefits

At the time of retirement, death, disability, or termination of employment, a participant or their beneficiary, whose vested balance exceeds \$7,000, may receive the payment of the vested interest in their account in a lump sum distribution, installment payments, or partial withdrawals of at least \$500. Upon termination, participants with vested account balances less than \$7,000 will receive a lump sum payment and may be automatically rolled over to an individual retirement account unless the participant directs otherwise. In-service withdrawals are also permitted for participants who have attained age 59½. Participants are eligible to receive hardship withdrawals when certain conditions are met.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. The Plan Sponsor does not expect reimbursement from the Plan for any payments of administrative expenses paid on behalf of the Plan. Other administrative expenses are allocated proportionately based on the participants' account balances. Certain expenses specifically incurred by a participant, such as taking a withdrawal from the Plan or loan initiation fees, are paid directly by that participant. These expenses are paid to a service provider of the Plan and therefore qualify as party-in-interest transactions. Investment related expenses are included in net change in fair value and contract value of investments.

The Plan has an ERISA account where a service provider of the Plan, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal), deposits revenue sharing payments that can be used to pay Plan administrative expenses or allocated to participant accounts. During 2024, there was \$83,804 of non-excludable plan assets designated to revenue sharing deposits into the account and revenue sharing payments of \$82,823 of non-excludable plan assets were used to pay administrative expenses related to the Plan. There were no payments from this account allocated to participants. Deposits to this account are included in net change in fair value of investments in the accompanying statement of changes in net assets available for benefits. The ERISA account had a balance of \$7,162 and \$6,181 as of December 31, 2024 and 2023, respectively.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates, and such differences may be material to the financial statements.

### Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The employer safe harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. The discretionary employer contributions are considered payable to the Plan after approval by the administrative committee. The wage rate employer contributions are payable to the Plan on the last day of each Plan year quarter. Any unfunded participant, employer safe harbor matching contributions, or employer wage rate contributions are included in the participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board's Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Plan Sponsor estimates the current credit risk associated with employer contribution receivables. The Plan Sponsor determined that no allowance for credit loss was necessary as of December 31, 2024 and 2023.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the guaranteed interest account, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net change in fair value and contract value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received. See Note 4 for a discussion of fair value measurements.

### Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

### Payment of Benefits

Benefits are recorded when paid.

### Subsequent Events

The Plan's management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

### 3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule of assets held, including investments held and notes receivable from participants at December 31, 2024 and 2023, net change in fair value and contract value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal.

### 4. Investments and Fair Value

Plan investments include a pooled separate account and a guaranteed interest account managed by Principal, which is a service provider of the Plan. Accordingly, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value and contract value of investments, as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to several risks, such as market, interest rate, currency and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, and other similar events. It is at least reasonably possible that changes in their fair values will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

The investment in the pooled separate account is valued daily using its net assets value (NAV) (Level 1). The NAV is based on the fair value of the mutual funds, stocks, debt instruments, and other securities in the accounts. The pooled separate account can be traded daily at its NAV.

The Plan invests in a stable value fund, which is held in a common/collective trust fund (CCT). Fair value of the CCT is determined by prices published daily by the trust manager, which is NAV. NAV is based on the fair value of the underlying investments held by the stable value fund, generally fixed income securities, bond funds, and wrap contracts, less its liabilities. NAV is used as a practical expedient to measure the fair value of the CCT and the CCT is therefore not

classified in the fair value hierarchy. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The guaranteed interest account is a fully-benefit responsive investment contract and is a general obligation of Principal. Principal maintains the contributions in a general account. The account is credited with interest at a guaranteed interest rate Principal declares for a set period of time. The Plan's investment in this account is stated at contract value. Contract value of the guaranteed interest account represents deposits and transfers made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

### 6. Income Tax Status

The Plan is operating under a Volume Submitter Defined Contribution Plan created by Principal. The Internal Revenue Service has determined and informed Principal by a letter dated June 30, 2022, that the Plan is designed in accordance with applicable sections of the Internal

Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since receiving the Principal opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan administrator believes the Plan has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
