To the Trustee

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Affordable Engineering Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. # Affordable Engineering Services, Inc. 401(k) Plan

## NOTES TO THE FINANCIAL STATEMENTS

### **Note A - Description of the Plan**

The following description of the Affordable Engineering Services, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan was formed on May 11, 2007, as a profit-sharing plan which contains a cash or deferred arrangement pursuant to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). On January 1, 2016, the plan was restated upon adoption of The Contractors Retirement Plan.

On November 15, 2023, the Plan Sponsor's board of directors approved an agreement to amend and restate The Contractors Retirement Plan sponsored by Affordable Engineering Services, Inc. effective January 1, 2024. Plan assets were transferred to the custodian of the Affordable Engineering Services, Inc., 401(k) Plan subsequent to December 31, 2023.

#### **Administration**

Jalpesh Vora acts as the Plan's trustee. Empower is the custodian for the Plan and Economic Group Pension Services has been appointed as the third-party administrator of the Plan.

#### **Eligibility**

Eligible individuals consist of employees rendering services for Affordable Engineering Services, Inc., and Madison Research Corporation on contracts subject to the Davis-Bacon Act, Service Contract Act or other federal, state or municipal prevailing wage laws. Other employees whose services are not subject to such prevailing wage laws may be included. Non-union participants must be 18 years of age and have completed one year of service to participate in elective deferral contributions and to receive nonelective profit sharing or matching contributions. There is no age or service requirement for union employees to participate in the Plan or for any participant to receive prevailing wage contributions.

#### **Contributions**

Each year participants may contribute a percentage of their pre-tax annual compensation not to exceed the limitation (\$23,000 and \$22,500 in 2024 and 2023 respectively) set forth in Section 402(g) of the Internal Revenue Code ("IRC"). Participants may make after-tax Roth contributions. Participants who are (or will be) age 50 or older by the end of the calendar year may make pre-tax catch-up contributions that exceed the annual elective deferral limit. Participants' total catch-up contributions during 2024 and 2023 cannot exceed \$7,500 and \$7,500, respectively.

**Note A - Description of the Plan, continued**

**Matching contributions under Collective Bargaining Agreement, employment contract or equivalent:**

Union 1-ARA 1AM-North Island Miramar Pendleton will receive a match of 100% up to 4% each payroll on a Bi-Weekly basis.

Union 2-2ARA 1AM-Yuma will receive no match contribution.

Union 3-IMA North Carolina will receive a match of 50% up to 6% each payroll on a Bi-Weekly basis.

There are three groups, and the Employer may make different contributions to each group. The contributions are as follows:

Group 1: Corporate formula is 100% up to \$4,000.

Group 2: Non-Corporate formula is 40% up to \$4,000.

Group 3: Prevailing Wage formula is discretionary.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's matching contribution and an allocation of any non-elective contribution and earnings (losses) on the investments selected by the participant. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

**Investment Options**

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Company's contributions into various investments offered by the Plan.

**Vesting**

Participants are immediately 100% vested in their elective deferral contributions, their share of employer prevailing wage contributions and net trust earnings on such contributions. Profit sharing contributions and earnings on such contributions vest according to the following schedule:

### **Notes Receivable from Participants**

Participants may borrow from their accounts on a pro-rata basis from all contribution sources up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms

must not exceed five (5) years unless the loan is to be used in the financing of the participant's homestead in which case the loan may be payable in terms of similar length provided by conventional lending institutions.

The loans are secured by the vested balance in the Participant's account and bear an interest rate of prime plus one percent. Principal and interest payments are made by means of payroll withholdings according to the terms of the promissory note and the Plan document. The interest rates on outstanding notes receivable from participants are 3.25% to 8.50% as of December 31, 2024. A participant may have only one loan outstanding at any time.

### **Payment of Benefits**

Upon termination of employment due to death, disability, attainment of age 59 ½ or retirement, a participant (or his/her designated beneficiary in the event of death) may elect to receive a lump-sum amount. For termination of employment due to other reasons, the vested interest in his or her account may be distributed as rollover to another plan, a lump-sum distribution or it may be left in the Plan if the account balance is greater than \$5,000.

A Participant may not receive an in-kind distribution in the form of property or securities, even if the Plan holds such property on behalf of any Participant.

### **Forfeited Accounts**

All employer contributions credited to a participant's account, but not vested, are forfeited by the participant upon his/her termination from the Plan. Per the Plan document forfeitures may be used to reduce the Company's contributions or to offset future employer contributions. In addition, forfeitures may also be used to pay plan expenses. There was \$4,623 in forfeitures at the year ended December 31, 2024.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payment transactions are charged directly to the participant's account and are included in administrative expenses. During the year ended December 31, 2024, the plan paid fees of \$131,578.

## **Note B - Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

## **Note B - Summary of Significant Accounting Policies, continued**

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of net assets available for the benefits and changes therein. Actual results could differ from those estimates.

### **Risk and Uncertainties**

The Plan provides various investment options. These investment options are exposed to market risk, which generally means the risk of loss in the value of certain investment securities due to changes in interest rates, commodity prices and general market conditions. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

### **Investment Valuation and Income Recognition**

Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Investments in fully-benefit responsive investment contracts are reported at contract value as discussed in Note C.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued. No events have occurred subsequent to the date of the statement of net assets available for benefits that would require adjustment to, or disclosure in, the financial statements.

### **Contributions**

Contributions from employees and the Company are recorded in the period in which the Company makes the payroll deductions from participant accounts.

### **Benefit Payments**

Benefits are recorded when paid.

### **Note C - Guaranteed Investment Contract with Empower**

On December 31, 2024 and 2023, the Plan had a traditional fully benefit-responsive guaranteed investment contract, in the amount of \$617,138, and \$546,387, respectively with Great-West Life and Annuity Insurance Company. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The MassMutual Guaranteed Interest Account is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly and may not be less than .05%. Empower, at its discretion, may credit interest during the calendar year greater than the base rate established by the contract. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

## **Note D - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the best level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 input).

It is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The following is a summary of the Plan’s financial information that is included in the financial statements based on information certified by the Custodian, Empower, as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under

Empower also certified to the completeness and accuracy (including gains and losses on investments bought and sold, as well as held during the year) of \$1,420,367 of net appreciation in the fair value of investments and \$19,590 in participant loan interest for the year ended December 31, 2024.

#### **Note F – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will become 100% vested in their accounts.

#### **Note G – Tax Status**

The IRS has determined and informed the Company's document provider by an opinion letter dated June 30, 2023, that the Volume Submitter Profit Sharing Plan with CODA is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Although the Plan has not received a determination letter and has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been made in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note H – Party-in-Interest Transactions**

The Plan invests in participant loans. These transactions qualify as party-in-interest transactions. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Certain Plan investments are funds managed by the trustee and the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

#### **Note I – Benefit Claims Payable**

On December 31, 2024 and 2023, there were no benefit claims payable for distributions requests made prior to year-end.

#### **Note J – Prohibited or Non-Exempt Transactions**

During 2024, the Company failed to submit \$497,076 in deferral contributions and loan repayments in a timely manner. The failure to submit employee contributions and loan repayments is a technical violation of the provisions of ERISA even though the Company did not profit from the transaction. The plan will correct this violation outside the Internal Revenue Service's Voluntary Fiduciary Correction Program by filing Form 5330. On the date of this report the Sponsor has deposited lost earnings and is in the process of completing Form 5330.

**Note K– Recent Accounting Pronouncements**

Recent accounting pronouncements issued by the FASB did not or are not believed by management to have a material impact on the Plan’s present or future financial statements.
