Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Capstone IT Inc 401(k) Profit-Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following brief description of the Capstone IT Inc 401(k) Profit-Sharing Plan and Trust (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits to the employees of Capstone IT, Inc. (the Company).

Employees, excluding union and non-resident aliens, become eligible to make pre-tax and Roth after-tax salary deferral contributions and receive Company safe-harbor matching contributions, and discretionary profit-sharing contributions after attaining 21 years of age and completing three months of service. Participants are eligible to receive Company discretionary profit-sharing contributions if they are employed on the last day of the Plan year. Eligible employees may become participants on the first day of the following month they meet the eligibility requirement.

Contributions

Participants may make voluntary salary deferral contributions up to 92% of pre-tax or Roth after-tax annual eligible compensation, subject to the maximum dollar amounts allowable by law. Eligible employees become automatically enrolled with a salary deferral of 4%, that increases 1% annually on the first day of the Plan year up to 6%. At any time, a participant can elect not to contribute or may increase or decrease their deferral rate at any rate allowed under the Plan provisions.

The Plan is a "Safe-Harbor 401(k) Plan", whereby the Company makes safe-harbor matching contributions. Company safe-harbor matching contributions are made in an amount equal to 100% of the amount of the participant's elective deferrals up to 1% of the participant's eligible compensation, plus 50% of the amount of the participant's elective deferrals greater than 1% and up to 6% of the participant's eligible compensation. The Company may also make discretionary profit-sharing contributions.

All participants who were eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's salary deferral contribution and an allocation of (a) the Company's safe-harbor matching contributions, (b) the Company's discretionary profit-sharing contributions, (c) Plan earnings or losses, and (d) administrative expenses. Company safe-harbor matching contributions are allocated among participants based upon each participant's elected salary deferral. Company discretionary profit-sharing contributions are allocated on the basis of the participant's eligible compensation for the Plan year. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Certain Plan expenses that are incurred by or attributable to a particular participant are allocated to the individual participant's account. Participant-directed investments are maintained in individual member accounts managed by the record-keeper, Paychex, and investments are certified by the asset custodian, Mid Atlantic Trust Company (Mid Atlantic).

Vesting

Participants are immediately vested in their contributions and Company safe-harbor matching contributions plus actual earnings thereon. Company discretionary profit-sharing contributions credited to participants' accounts are vested based on years of continuous service. A participant is 20% vested after two years of credited service and vesting increases 20% per year until a participant is 100% vested after six years of credited service.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary may receive up to an amount equal to the value of the vested funds allocated to the participant's account in lump sum, installment and annuity payments. The Plan requires mandatory distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. The Plan allows in-service distributions from fully vested accounts for participants who have reached age 59 ½. The Plan also allows for hardship distributions as defined by the Plan. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of their discretionary profit-sharing contributions not then vested shall be forfeited. The forfeited portion of any participant's account will be used to pay Plan expenses, reduce Company contributions, or are re-allocated to Plan participants. At December 31, 2024 and 2023, there were \$1,776 and \$21,646 of forfeited, non-vested accounts available, respectively. During the years ended December 31, 2024 and 2023, the Company utilized \$9,367 and \$7,317, respectively, to pay Plan expenses. During the year ended December 31, 2024, the Company utilized \$21,646 to re-allocate to Plan participants.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plan*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Expenses

Investment management, record-keeping and other expenses are paid by the Plan and are included in administrative expenses. Fees related to the administration of payments of benefits are charged directly to the participants account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 22, 2025, noting no items requiring disclosure.

3. Information Certified by Mid Atlantic

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Mid Atlantic, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurement and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: Valued at the NAV based on the fair value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these trusts meet those requirements. The participants have the ability to redeem the accounts at NAV as of the measurement dates on a daily basis. There are no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distribution of account balances to participants would be made as soon as practicable after the termination date.
