Independent Auditors' Report

**To the 401(k) Committee
The National Bank of Indianapolis Corporation
401(k) Savings Plan**

Opinion

We have audited the financial statements of The National Bank of Indianapolis Corporation 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

NOTE 1 - PLAN DESCRIPTION

The following description of The National Bank of Indianapolis Corporation 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

General

The Plan is a defined contribution plan sponsored by The National Bank of Indianapolis Corporation (the “Company”) for the benefit of all employees of the participating employer who are age 18 and older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Entrance Date

An employee is eligible to enter the Plan immediately following completion of the age requirement.

Plan Amendment

Effective January 1, 2024, the Plan was amended and restated to incorporate all amendments adopted since the last restatement and certain provisions under the SECURE Act 2.0.

Contributions

Each year, participants may contribute from 1% to 100% of eligible compensation, as defined by the Plan, up to the maximum amount allowed by the Internal Revenue Service. The Plan allows for catchup contributions for participants who have reached age 50 by the end of the year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company contributes Safe Harbor matching contributions, whereby the Company contributes 100% of the participant deferral and catch-up contributions up to 3% plus 50% of the next 2% of deferrals. The Company may, at its discretion, make an additional matching contribution or a profit-sharing contribution to the Plan. Additional service requirements, as defined, are necessary in order for a participant to receive the profit-sharing contribution. Participant contributions may be directed into various investment options offered by the Plan. Employer contributions are generally invested in National Bank of Indianapolis Common Stock, although the Plan limits the amount of National Bank of Indianapolis stock an individual may hold. All contributions are subject to certain limitations. Safe Harbor matching contributions were \$1,248,015 in 2024. No additional matching contributions or profit-sharing contributions were made in 2024.

When rolling funds into the Plan, participants are provided the opportunity to invest the lesser of 25% of the rollover contribution or \$200,000 in National Bank of Indianapolis Common Stock. Shares of National Bank of Indianapolis Stock are purchased at the price from the most recent valuation.

Participant Investment Account Options

The Plan currently offers various mutual funds and common stock. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company matching contributions, as well as profit sharing contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The appreciation arising from the annual valuation of The National Bank of Indianapolis Stock creates a timing difference between the Plan's financial statements and allocated assets at December 31 of each year. The appreciation for 2024 is reflected in participant accounts in the first quarter of 2025. As a result, net assets exceeded allocated assets by \$373,715 at December 31, 2024.

Vesting

Participants are immediately vested in their contributions and the Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company discretionary matching contributions and the Company profit-sharing contributions portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Benefit Payments

Upon termination of service, distribution of benefits are made in a single sum amount equal to the value of the participant's account.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. These accounts will be used to reduce employer contributions. Also, for the year ended December 31, 2024, no employer contributions were reduced from forfeited nonvested accounts.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification (ASU) Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in inactive markets, inputs other than quoted market prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, then the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds: Valued at cost, which approximates fair value.

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The National Bank of Indianapolis Common Stock: Valued at fair value by utilizing information provided by an independent outside valuation.

NOTE 4 - PARTIES-IN-INTEREST TRANSACTIONS

The Plan's investments are held by The National Bank of Indianapolis, the trustee of the Plan. In addition, certain Plan investments are shares of non-publicly traded stock of the trustee. Therefore, these transactions qualify as party-in-interest transactions.

The Plan incurs expense related to general administration and recordkeeping. The Plan paid \$80,110 of recordkeeping and other fees during the year ended December 31, 2024. Additionally, other income of \$29,632 was offset against expenses during the year. This amount includes administrative service fees, 12B-1 fee rebates, and other income.

Certain accounting and administrative functions are performed by officers or employees of the Company. No officer or employee receives compensation from the Plan for such services. Other expenses of the Plan are paid by the Company.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by letter dated February 14, 2018, that the Plan and the related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 6 - TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, approximately 26% and 25% of the Plan's investments were invested in Vanguard Institutional Index Fund, respectively.

NOTE 8 - SUBSEQUENT EVENTS

Effective January 1, 2025, those between the ages 60 through 63 are eligible for a higher catch-up contribution limit of \$11,250.

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.
