1. Description of Plan

The following description of the Connection Employee 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of PC Connection, Inc. (the Company) and its subsidiaries.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An officer of the Company is the administrator of the Plan. Fidelity Management Trust Company (the Trustee or Fidelity) is the recordkeeper and trustee of the Plan.

Eligibility

All employees, including temporary employees, become eligible to participate in the Plan once they have attained age 18. Eligible employees may enter the Plan on the first day of each month.

Contributions

Each year, eligible employees who elect to become participants may make contributions to the Plan through salary deferrals on a pre-tax basis up to 60% of eligible earnings, as defined by the Plan. The maximum amount that a participant may contribute on a pre-tax basis is limited by provisions of the Internal Revenue Code (the Code).

The Company provides for a discretionary matching contribution based on a percentage of the participants' eligible compensation. The matching contribution was 50% of the participants' contributions up to 6% of eligible earnings in 2024.

The Company, as approved by the Board of Directors, may also make certain discretionary nonelective contributions to the Plan. No discretionary contributions were made during 2024.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, and allocations of the Company's discretionary nonelective contribution and investment earnings and charged with an allocation of investment losses and certain investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of their contributions, Company matching contributions, and Company discretionary contributions into various investment options offered by the Plan. At December 31, 2024 and 2023, the Plan offered several mutual funds, a common collective trust, and a brokerage-link account for participant investment allocations.

Vesting

Participants are fully vested with respect to the portion of their accounts that relates to their contributions. Participants become fully vested in the Company's contributions after three years of service. Participants also become fully vested in the Company's contributions at death, permanent disability, or the normal retirement age (62).

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$198,530 and \$5,285, respectively. These accounts are used to reduce Company contributions. Company contributions were reduced by \$256,332 from forfeited nonvested accounts during the year ended December 31, 2024.

Payment of Benefits

Participants shall become eligible to receive their vested account balances upon retirement (normal retirement age is 62 and early retirement age is the first day of the month after the participant attains age 55 and completes five years of service), death, disability, or termination in a lump-sum payment. Participants may withdraw their vested balance upon attaining age 59½. In addition, participants may withdraw their pre-tax contributions upon demonstration to the trustee that they are suffering a hardship, as defined in Section 401(k) of the Code.

Notes Receivable from Participants

Participants may borrow from their vested accounts amounts not to exceed the lesser of one-half of their vested account balance reduced by the highest outstanding loan balance during the previous 12-month period or \$50,000. Only one loan may be outstanding at any time. The minimum loan amount is \$1,000. Loan terms generally are not to exceed five years, unless the loan is used to acquire a principal residence, in which case the period for which the loan may remain outstanding may not exceed ten years. Loans are secured by the balance in the participant's account. Loans to participants bear interest as determined by the plan administrator based on the prevailing interest rates. The plan administrator reserves the right to withhold approval of such loan applications. Loan principal and interest is normally paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and are presented in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for the discussion of fair value measurement.

Net appreciation in the fair value of investments includes realized and unrealized gains and losses on fair value of investments held by the Plan. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Administrative Expenses

Investment management, recordkeeping, and certain administrative fees relating to the operation of the Plan's investments are paid from Plan assets. Other administrative expenses are paid by the Company.

Subsequent Events

Management has considered transactions or events occurring through October 14, 2025, the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued using market quotations.

Common and preferred stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Money market and interest-bearing accounts: Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end.

Government bonds: Valued based on yields currently available on comparable government securities or using quoted market prices for similar securities in active markets.

Common collective trust: Valued at the NAV of shares held by the Plan at year-end. NAV is used as a practical expedient; therefore, the common collective trust is excluded from the fair value hierarchy table below.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

4. Investment in Common Collective Trust

The Plan has an investment in the Fidelity Managed Income Portfolio, a common collective trust, with a contract value based on the quoted market prices of the underlying assets in the common collective trust. The investment objective of the Fidelity Managed Income Portfolio is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. Withdrawals from the Fidelity Managed Income Portfolio are permitted at any time by participants.

The common collective trust contract is not considered a fully benefit-responsive contract because the contract is with a trust and not directly with the Plan. There are no redemption restrictions for this investment.

5. Tax Status

The Plan was originally established, and all subsequent amendments have been made, under the provisions of the third-party administrator prototype plan. The Internal Revenue Service has determined and informed the third-party administrator by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. Information Prepared and Certified by Trustee

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants, and interest and dividends were obtained by management and agreed to or derived from information certified by the Trustee as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i - Schedule of Assets (Held at End of Year).

7. Party-In-Interest

Certain Plan investments are shares of registered mutual funds managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management, recordkeeping, and certain administrative fees amounted to \$364,568 for the year ended December 31, 2024.

8. Plan Termination

The Company has the right, under the Plan, to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. The Company has not expressed any intention to terminate the Plan. In the event of termination of the Plan, each participant or former participant with an account in the Plan or beneficiary receiving or entitled to receive a distribution from the Plan will receive a benefit equal to 100% of his or her account balance, as determined in accordance with the plan document.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

1. Description of Plan

The following description of the Connection Employee 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of PC Connection, Inc. (the Company) and its subsidiaries.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An officer of the Company is the administrator of the Plan. Fidelity Management Trust Company (the Trustee or Fidelity) is the recordkeeper and trustee of the Plan.

Eligibility

All employees, including temporary employees, become eligible to participate in the Plan once they have attained age 18. Eligible employees may enter the Plan on the first day of each month.

Contributions

Each year, eligible employees who elect to become participants may make contributions to the Plan through salary deferrals on a pre-tax basis up to 60% of eligible earnings, as defined by the Plan. The maximum amount that a participant may contribute on a pre-tax basis is limited by provisions of the Internal Revenue Code (the Code).

The Company provides for a discretionary matching contribution based on a percentage of the participants' eligible compensation. The matching contribution was 50% of the participants' contributions up to 6% of eligible earnings in 2024.

The Company, as approved by the Board of Directors, may also make certain discretionary nonelective contributions to the Plan. No discretionary contributions were made during 2024.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, and allocations of the Company's discretionary nonelective contribution and investment earnings and charged with an allocation of investment losses and certain investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of their contributions, Company matching contributions, and Company discretionary contributions into various investment options offered by the Plan. At December 31, 2024 and 2023, the Plan offered several mutual funds, a common collective trust, and a brokerage-link account for participant investment allocations.

Vesting

Participants are fully vested with respect to the portion of their accounts that relates to their contributions. Participants become fully vested in the Company's contributions after three years of service. Participants also become fully vested in the Company's contributions at death, permanent disability, or the normal retirement age (62).

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$198,530 and \$5,285, respectively. These accounts are used to reduce Company contributions. Company contributions were reduced by \$256,332 from forfeited nonvested accounts during the year ended December 31, 2024.

Payment of Benefits

Participants shall become eligible to receive their vested account balances upon retirement (normal retirement age is 62 and early retirement age is the first day of the month after the participant attains age 55 and completes five years of service), death, disability, or termination in a lump-sum payment. Participants may withdraw their vested balance upon attaining age 59½. In addition, participants may withdraw their pre-tax contributions upon demonstration to the trustee that they are suffering a hardship, as defined in Section 401(k) of the Code.

Notes Receivable from Participants

Participants may borrow from their vested accounts amounts not to exceed the lesser of one-half of their vested account balance reduced by the highest outstanding loan balance during the previous 12-month period or \$50,000. Only one loan may be outstanding at any time. The minimum loan amount is \$1,000. Loan terms generally are not to exceed five years, unless the loan is used to acquire a principal residence, in which case the period for which the loan may remain outstanding may not exceed ten years. Loans are secured by the balance in the participant's account. Loans to participants bear interest as determined by the plan administrator based on the prevailing interest rates. The plan administrator reserves the right to withhold approval of such loan applications. Loan principal and interest is normally paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and are presented in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for the discussion of fair value measurement.

Net appreciation in the fair value of investments includes realized and unrealized gains and losses on fair value of investments held by the Plan. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Administrative Expenses

Investment management, recordkeeping, and certain administrative fees relating to the operation of the Plan's investments are paid from Plan assets. Other administrative expenses are paid by the Company.

Subsequent Events

Management has considered transactions or events occurring through October 14, 2025, the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued using market quotations.

Common and preferred stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Money market and interest-bearing accounts: Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end.

Government bonds: Valued based on yields currently available on comparable government securities or using quoted market prices for similar securities in active markets.

Common collective trust: Valued at the NAV of shares held by the Plan at year-end. NAV is used as a practical expedient; therefore, the common collective trust is excluded from the fair value hierarchy table below.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

4. Investment in Common Collective Trust

The Plan has an investment in the Fidelity Managed Income Portfolio, a common collective trust, with a contract value based on the quoted market prices of the underlying assets in the common collective trust. The investment objective of the Fidelity Managed Income Portfolio is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. Withdrawals from the Fidelity Managed Income Portfolio are permitted at any time by participants.

The common collective trust contract is not considered a fully benefit-responsive contract because the contract is with a trust and not directly with the Plan. There are no redemption restrictions for this investment.

5. Tax Status

The Plan was originally established, and all subsequent amendments have been made, under the provisions of the third-party administrator prototype plan. The Internal Revenue Service has determined and informed the third-party administrator by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. Information Prepared and Certified by Trustee

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants, and interest and dividends were obtained by management and agreed to or derived from information certified by the Trustee as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i - Schedule of Assets (Held at End of Year).

7. Party-In-Interest

Certain Plan investments are shares of registered mutual funds managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management, recordkeeping, and certain administrative fees amounted to \$364,568 for the year ended December 31, 2024.

8. Plan Termination

The Company has the right, under the Plan, to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. The Company has not expressed any intention to terminate the Plan. In the event of termination of the Plan, each participant or former participant with an account in the Plan or beneficiary receiving or entitled to receive a distribution from the Plan will receive a benefit equal to 100% of his or her account balance, as determined in accordance with the plan document.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
