## INDEPENDENT AUDITOR'S REPORT

To the Trustees

Community Health Connection, Inc. 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Community Health Connection, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **Opinion**

**Note 1 – Description of Plan**

The following description of the Community Health Connection, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

- (a) *General.* Community Health Connection, Inc. 401(k) Profit Sharing Plan (the Plan) is a salary reduction plan covering all employees of Community Health Connection, Inc. (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Plan's effective date is January 1, 2009.
- (b) *Eligibility.* The Plan covers all full-time employees of Community Health Connection, Inc. who are age 18 or older and have completed three months of service. An employee becomes eligible for entry and participation in the Plan as an active member on the first day of the month after they meet the entry requirements.
- (c) *Contributions.* Each year, participants may contribute up to the maximum amount allowed by law of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The participant directs the investment of their contributions into various mutual funds offered by the Plan. Investment options and allocations may be modified at any time by the participant. The Employer makes a safe harbor matching contribution equal to 100% on the first 5% of compensation deferred. The Plan also allows for discretionary employer matching and discretionary non-elective contributions equal to a percentage of the participant's compensation, though this contribution is not required. If such a contribution is made, the percentage contributed will be determined each year by the Employer and will be subject to the vesting schedule below. During 2024 and 2023, the Employer did not make any discretionary employer matching or discretionary non-elective contributions to the plan.
- (d) *Participant Accounts.* John Hancock Financial Services (John Hancock) holds Plan assets and maintains all participant account information (e.g., allocation of all contributions, investment earnings, and Plan distributions). A proportionate share of investment earnings or losses is credited to each participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- (e) *Vesting.* All employee elective deferral contributions, employee rollover contributions, qualified non-elective contributions, and safe harbor matching contributions as well as earnings thereon, are 100% vested to the participants at all times. Vesting in the discretionary

employer matching contributions and discretionary non-elective contributions account is based on continuous years of service, as follows:

For vesting purposes, completion of 1,000 hours or more is considered one year of service. A participant's matching employer contributions and employer non-elective contributions become fully vested on 1) completion of four years of service; 2) reaching retirement, death, or disability; 3) the date the employee reaches age 65; or 4) termination of the Plan.

- f) *Payment of benefits.* Amounts contributed through salary or wage reductions may be withdrawn by, or distributed to, a participant upon (1) termination of employment or (2) attaining the age of 59 ½. Withdrawals prior to attaining age 59 ½ are not permitted, except in the event of retirement, disability, or as a hardship distribution. Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a single lump-sum payment in cash.
- g) *Notes receivable from participants.* The Plan permits participants to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Only one outstanding loan is permitted at any time. The loans are secured by the balance in the participant's account and bear interest at commercially reasonable rates established by the Plan administrator. Principal and interest are paid ratably through regular payroll deductions.
- h) *Forfeited accounts.* Forfeitures of the nonvested portion of terminated participants' accounts are not allocated to active participants' accounts. Forfeitures may first be used to pay Plan administrative expenses. Any forfeitures not used to pay administrative expenses are applied to reduce the earliest Employer matching contributions made after the forfeitures are determined. During 2024, there were no forfeited contributions. At December 31, 2024, and 2023, there were no unused forfeitures.
- i) *Operating Expenses.* Certain expenses of maintaining the Plan are paid by the Company, and certain expenses are paid by the Plan.

## **Note 2 – Significant Accounting Policies**

### *Basis of accounting*

The Plan's financial statements are prepared on the accrual basis of accounting.

### *Date of Management's Review*

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

### *Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the administrator and management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### *Investment valuation and income recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion of fair value measurement

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant's loan to be in default, the loan balance is reduced, and the delinquent participant's note receivable is recorded as a benefit payment based on the terms of the Plan document.

### *Payment of benefits and administrative expenses*

Benefits are recorded when paid.

### **Note 3 – Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value.

That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Mutual funds: Valued at quoted market prices, which represent the net asset value of shares held by the plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 5 – Related Party Transactions**

Certain Plan investments are shares of mutual funds managed by John Hancock, the Plan custodian. These transactions qualify as exempt party-in-interest transactions.

The party-in-interest transactions above are exempt from the prohibited transactions rules of ERISA.

#### **Note 6 – Income Tax Status**

The Internal Revenue Service has determined and informed the Employer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income examination for years prior to 2021.

#### **Note 7– Plan Termination**

The Employer may amend or terminate the Plan at any time. Any such termination or amendment shall be effective at such dates as the Employer shall determine. In the event of termination of the Plan, the value of the participants' accounts attributable to the Employer's contributions becomes fully vested to the participants.

An amendment may affect participants' interests in the Plan at the time thereof as well as future participants' interests, but may not diminish the interests of participants' accrued benefits as of the effective date of such an amendment.

#### **Note 8 – Risks and Uncertainties**

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
