**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Illinois Institute of Technology Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a deferred compensation plan, which satisfies the Internal Revenue Code (IRC) Section 403(b) covering substantially all employees. The effective date of the Plan was November 28, 2000. Substantially all employees of Illinois Institute of Technology (IIT or the Plan Sponsor) who have satisfied the eligibility requirements are covered by the Plan. An employee must be a qualified employee and have completed two years of service (staff) or one year of service (faculty and administrative officers) to be eligible for the Plan's match and be employed on the first day of the month subsequent to their anniversary and have a completed salary reduction agreement to receive a contribution. Employees covered by a collective bargaining agreement that does not provide for participation in the Plan and adjunct, leased, or temporary employees are not qualified and, therefore, not eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

During 2024 and 2023, active record-keepers included Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (collectively TIAA and CREF), Fidelity Management Trust Company (Fidelity); inactive record-keepers included FASCore, LLC (FASCore) and Mutual of America Life Insurance Company (MOA).

Contributions: Each year, participants may make Tax Deferred (TD) contributions as defined by the Plan, subject to the limitations of the IRC. Additionally, participants age 50 or older or who will attain age 50 during the plan year may make a "catch-up" contribution as defined by the IRC. Upon eligibility and direction by the participant, the Plan Sponsor makes contributions to the Plan equal to 5% of the employee's eligible salary and, upon direction, an additional dollar-for-dollar match of the employee's matchable TD contributions, up to 4% of an employee's compensation. Contributions are made at the end of the biweekly or monthly payroll periods. The Plan Sponsor does not match participants' catch-up contributions. The Plan also allows rollover contributions.

Effective May 1, 2023, the Plan Sponsor suspended entirely and indefinitely all non-elective Employer contributions. Effective June 1, 2024, the Plan Sponsor resumed non-elective Employer contributions.

Participant Accounts: Each participant's account is credited with TD contributions, the Plan Sponsor contributions, and earnings/(losses) thereon and is charged with their withdrawals and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that will be provided from the participant's vested account. Participants may direct their contributions into a variety of investment options.

Vesting: Participants are always vested in TD contributions and 100% vested in the Plan Sponsor contributions when eligible to participate. Therefore, the Plan does not generate any forfeitures.

Payment of Benefits: Participants may receive all or a portion of their account balance upon termination of employment or reaching 59 1/2 years of age. If permitted under the terms of a participant's funding vehicle, a participant may request an in-service hardship withdrawal from the participant's account. Income earned on or after January 1, 1989, shall be available for hardship withdrawal only to the extent permitted by the IRC.

A participant may elect to receive benefits under any of the forms of benefit available under the relevant funding vehicle subject to the Joint and Survivor Annuity requirements set forth in the plan document and the minimum distribution requirements set forth in the plan document. Notwithstanding the preceding sentence, in addition to any of the other forms of distribution otherwise permitted under the relevant funding vehicle, a married participant shall be entitled to elect to receive his or her benefit as an immediate annuity payable to the participant during the participant's lifetime after retirement with seventy-five percent (75%) of such benefit continued to the participant's spouse for the duration of the spouse's lifetime after the death of the participant. Participants who terminate employment prior to retirement may, subject to the terms of their chosen funding vehicle, elect to have their balance distributed in a lump sum or transferred to an individual retirement account or another employer's qualified plan. Death benefits are paid according to the benefits election in effect at the time of death.

Notes Receivable from Participants: Participants may borrow, from their before-tax account or rollover account at Fidelity, a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000 (ii) 50% of their vested pretax and rollover account balance. Additionally, starting December 4, 2020, participants may also borrow from their before-tax account or rollover account at TIAA, subject to the same limits noted for Fidelity. Loans used to purchase a primary residence can be repaid over 10 years. Loans for all other purposes must be repaid within 5 years. Principal and interest are repaid through a required borrower's automatic bank deduction. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. The Plan allows Fidelity and TIAA to establish reasonable interest rates for participant loans.

Plan Loans: Loans are available to participants through TIAA, subject to certain limitations. Plan loans are issued directly from the funds owned by TIAA and loan proceeds are not removed from a participant's account balance. However, a portion of a participant's TIAA Traditional Annuity account balance is reserved, or held in collateral, to cover the outstanding loan amount for the period of time the loan is outstanding. See Note 5 for discussion of the TIAA Traditional Annuity. For active loans, investments equal to 110% of the outstanding loan amount are reflected in the statements of net assets available for benefits and serve as collateral for the loan. Investments underlying defaulted loan balances are reflected in the statements of net assets available for benefits until a distribution event occurs.

As of December 31, 2024 and 2023, participants had outstanding plan loan balances due to TIAA of \$836,427 and \$816,241, respectively. The plan loan balances are not separately identified in the Statements of Net Assets Available for Benefits. Effective December 4, 2021, participants are no longer able to obtain Plan loans issued directly by TIAA.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Administrative expenses related to investment management are allocated amongst various funds and are included as an offset to net appreciation (depreciation) in fair value of investments. Certain other administrative expenses of the Plan are paid by the Plan Sponsor.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks, such as interest rate, market, liquidity and credit risks as well as risks associated with global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (Fidelity); Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (collectively TIAA and CREF) including TIAA as agent for TIAA Trust, N.A. as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

**NOTE 4 - FAIR VALUE MEASUREMENTS** (Continued)

The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Registered Investment Companies:* Determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Interest Accumulation Account:* The fair value is determined by Mutual of America similar to a Money Market Fund (Level 1 inputs).

*Variable Annuities:*

*TIAA and CREF:* The fair values of the Plan's investments held in these variable annuity accounts are determined by obtaining quoted prices on the NASDAQ Stock Market (Level 1 inputs).

*MOA Separate Account No. 2:* The fair value of the Plan's interest in the variable annuities of MOA Separate Account No.2 is based on the values for the underlying funds. The Separate Account No. 2 is divided into distinct funds, which invest its assets in an underlying mutual fund, and the name of each variable annuity investment reflects the name of the corresponding underlying mutual fund. The underlying investments of the funds that Separate Account No. 2 invests in are based on quoted market prices within an active market and such are classified as Level 1. Investments held in the Separate Account are stated at market value, which represents fair value.

The dollar value of an accumulation unit for each underlying fund reflects changes in the underlying fund's daily NAV, which is considered by the Plan's management to be the best approximation of fair value, and separate account charges under the contracts, with annual rates calculated as a daily charge. The accumulation unit values for the underlying funds are calculated daily and participants have the right to transfer funds between investment alternatives on a daily basis. These investments are classified within Level 1 of the fair value hierarchy.

*Stable Value Fund:* Valued at fair value by discounting the related cash flows of the investment contracts based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer of the underlying contracts. This investment is classified within Level 2 of the fair value hierarchy.

*Traditional Investment Contracts (not fully benefit-responsive):* The TIAA Traditional Annuity Contracts are individual guaranteed fixed annuity investment contracts issued by TIAA (“Issuer”). Due to certain liquidity restriction provisions, certain contracts within the TIAA Traditional Annuity contract held by the Plan are not fully benefit-responsive and, accordingly, are measured at fair value. TIAA and Plan management have determined contract value to be the most reasonable estimate of fair value for these contracts. Contract value equals the contributions deposited into the contracts, plus interest credited to the contracts, less contract withdrawals, and it reflects the value at which participant transactions are executed under the contracts. The fair values of the Plan’s investment contracts have been estimated by TIAA by discounting the projected cash flows using risk-adjusted market discount rates which correlate closely with TIAA Traditional Annuity’s historical interest crediting rates (generally 3% for current premiums on accumulating annuities, but in some recent contracts between 3% and 5% and provide the potential for additional interest as declared by TIAA’s discretion). The contract values are guaranteed by TIAA. Based upon recent credit ratings for TIAA, management believes no adjustment to contract value is required related to credit quality. Since investment contracts are not transferable, there is no market from which to obtain observable market prices for the contracts held by the Plan or comparable contracts (level 3 inputs). During the year ended December 31, 2024, there were purchases and sales of \$13,905,074 and \$(16,518,738), respectively, of these level 3 investments held by the Plan.

The Plan’s Investment committee reviews and evaluates the valuation methodology, assumptions and performance of investments on a quarterly basis.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - TIAA TRADITIONAL INDIVIDUAL FIXED ANNUITY CONTRACTS**

The Plan holds fully investment contracts through its investment holdings in the TIAA Traditional Account (TIAA; Issuer). The TIAA Traditional Individual Fixed Annuity Contracts are individual guaranteed fixed annuity investment contracts issued by TIAA. Within the TIAA Traditional Individual Fixed Annuity Contracts are six types of contracts available to participants: the Retirement Annuity (RA), the Group Retirement Annuity (GRA), the Retirement Choice (RC), the Supplemental Retirement Annuity (SRA), the Group Supplement Retirement Annuity (GSRA), and the Retirement Choice Plus (RCP). Each of these contracts has unique provisions and qualities. There are certain liquidity restrictions on the RA, GRA, and RC contracts. Participants with RA, GRA, and RC contracts have certain restrictions over the availability of lump-sum withdrawals from the contracts as well as over the number of installments in which participant-initiated transfers and participant-initiated withdrawals are made. Based on these provisions, the RA, GRA, and RC contracts are considered to be non-fully benefit-responsive. As there are no comparable restrictions over the SRA, GSRA and RCP contracts, those contracts are considered fully benefit-responsive. Participants in the Plan hold investments in both non-fully benefit-responsive and fully benefit-responsive contracts SRA, GSRA, RA, and RC through the TIAA Traditional Account.

For both the fully benefit-responsive and the non-fully-benefit responsive contracts within the TIAA Traditional Account, TIAA maintains the contributions in its general account. TIAA's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the Issuer or otherwise. The contract value of the guaranteed investment contract amounted to \$32,788,082 and \$32,154,074 as of December 31, 2024 and 2023, respectively.

All investment contracts through the TIAA Traditional Account are directly between TIAA and the participants. Benefit payments from the contracts are paid as an annuity or a lump-sum, as defined in the contracts and as elected by the participant upon meeting the eligibility requirements. There are no conditions specified in any of the contracts under which participant withdrawals and transfers would be restricted or made at a value other than contract value or the annuity or lump-sum benefit, as defined in the contracts. The contracts do not provide any provisions that would allow the Issuer to terminate the contracts between the Issuer and the participants.

The crediting interest rates of the fully benefit-responsive contracts may vary from participant to participant. The crediting rates are based on an agreed-upon formula with the Issuer, as defined in the contract agreement. The guaranteed annual interest rate is 3% for all premiums remitted since 1979 under the RA, GRA, SRA and GSRA contracts and is between 1% and 3% for the RC and RCP contracts. Such interest rates are reviewed on a periodic basis and may from time to time have a new rate substituted for the one in the current certificate. A new rate will apply only to benefits arising from any premiums, additional amounts, and internal transfers applied to the Traditional Annuity while such rate schedule is in effect and will not affect any benefits purchased prior to the change, as defined in the contracts. The key factors that influence future interest crediting rates could include the following: the level of market interest rates; the amount and timing of participant contributions, transfers and withdrawals into/out of the contracts; and the duration of the underlying investments backing the contract.

The Plan's value of assets held in these fully benefit-responsive contracts are an accumulation of many individual contracts between participants and TIAA. These various contracts may have many different effective crediting rates.

**NOTE 6 - INCOME TAX STATUS**

A tax determination letter program is not yet available for 403(b) employee benefit plans through the Internal Revenue Service (IRS). The plan administrator and its legal counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. The IRS, the primary oversight body of the Plan, generally has the ability to examine income tax returns for up to three prior years. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 - RELATED-PARTY TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others.

Certain plan investments are managed by the Plan's custodians or other plan service providers, and therefore, the related investments' transactions qualify as party-in-interest transactions. Administrative expenses paid to third party service providers are also parties in interest transactions. Investment management fees charged to the Plan as a reduction of investment returns qualify as party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 8 - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through October 13, 2025, which is the date the financial statements were available to be issued.
