1. DESCRIPTION OF THE PLAN

The following description of the Accenture United States Group Insurance Plan (the "Plan") provides only general information. Participants should refer to the Plan documents for a complete description of the Plan's provisions.

The financial statements were available to be issued on September 29, 2025, with subsequent events being evaluated through this date.

General - The Plan provides life insurance benefits, dependent life insurance benefits, long-term disability benefits, and accidental death and dismemberment benefits for eligible "Participants" of Accenture LLP, an Illinois limited liability partnership ("Accenture") and certain of its affiliates that have adopted the Plan (the "Employers").

The Plan is administered by Accenture (the "Administrator") on behalf of the Employers. For reporting purposes, the Plan is considered a Multiple Employer Plan because it includes a non-controlled group participating employer, Avanade, Inc. Each participating employer is responsible for its own contributions and plan assets are commingled for investment purposes.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits

The Group Life Insurance coverage provides death benefits through insurance contracts to the following eligible classes of personnel:

1. Regular full-time and regular part-time employees on the United States or Puerto Rico payroll.
2. Eligible retired employees who were employees on the United States or Puerto Rico payroll.
3. Eligible Personnel who qualify under the state of Minnesota COBRA regulations.

The Dependent Life coverage provides dependent death benefits through insurance contracts to regular full-time and regular part-time employees on the United States or Puerto Rico payroll.

The Long-Term Disability Insurance coverage provides long-term disability benefits through insurance contracts to regular full-time and regular part-time employees on the United States or Puerto Rico payroll.

The Accidental Death & Dismemberment Insurance coverage provides accidental death and dismemberment benefits through insurance contracts to regular full-time and regular part-time employees on the United States or Puerto Rico payroll.

1. DESCRIPTION OF THE PLAN (Continued)

The Administrator determines eligibility requirements which are subject to change without the consent of the Participants.

Contributions - The Plan provides for Employer and Participant contributions as determined by the Employers. Contributions vary according to coverage selected, personnel classification, and salary level.

Investment in Accenture United States Benefit Trust - Employer and Participant contributions are funded through Accenture United States Benefit Trust (the "Master Trust") as premiums for insurance contracts are paid. Investments are stated at fair market value as determined by the trustee (Northern Trust Company) by reference to published market prices. The assets held in the Master Trust are invested in cash and cash equivalents.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements of the Plan are prepared on the accrual basis.

Payment of Benefits - Premiums paid by either Accenture or the Trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits and benefit obligations.

Administrative Expenses - The Plan's expenses are paid by either the Trust or Accenture, as provided by the plan documents. Certain expenses incurred in connection with the general administration of the plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the use of management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. CLAIMS PAID

Any gains or losses incurred in the insurance coverage are the property of the insurance company.

4. BENEFIT OBLIGATION

The benefit obligation represents premiums due, but not paid. There were none at December 31, 2024 and 2023.

5. PLAN TERMINATION

While Accenture has not expressed any intention to do so, Accenture has the right under the Plan to unilaterally modify or terminate the Plan, or any benefit provided thereunder, subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants.

6. INCOME TAX STATUS

The Master Trust (which is designed to meet the requirements of Section 501(c)(9) of the Internal Revenue Code) funding certain benefits of the Plan received an exemption letter from the IRS dated May 22, 2002, stating that the Master Trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the Master Trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and the Master Trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the Master Trust. The Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the related Master Trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. INTEREST IN MASTER TRUST

The Plan's investments are in the Master Trust which was established for the investment assets of the Plan and several other Accenture sponsored health and welfare plans. Each plan has a divided interest in the net assets of the Master Trust as allocated in accordance with the plans' provisions. Assets are allocated among the plans by assigning to each plan those transactions (primarily contributions, benefit payments, and administrative expenses) which can be specifically identified. Investment income (loss) is allocated to the plans based upon their pro rata share in the allocated net assets of the Master Trust.

The Plan's interest in the net assets of the Master Trust totaled \$9,406 and \$6,268 at December 31, 2024 and 2023, respectively, which was less than 1% of the Master Trust net assets.

8. FAIR VALUE MEASUREMENTS

The Accounting Standards Codification (ASC) for Fair Value Measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the ASC are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.
