1. DESCRIPTION OF THE PLAN

The following description of the Accenture United States Group Health Plan, as amended and restated effective January 1, 2017 (the "Plan") provides only general information. Participants should refer to the Plan documents for a complete description of the Plan's provisions.

The financial statements were available to be issued on October 15, 2025, with subsequent events being evaluated through this date.

General - The Plan is a welfare-wrap plan that provides the benefits set forth below for employees of Accenture LLP, an Illinois limited liability partnership, and certain of its affiliates that have adopted the Plan (the "Employers"):

- Health care benefits under the Participating Medical Plan;
- Dental benefits under the Participating Dental Plan;
- Vision benefits under the Participating Vision Plan; and
- Cafeteria plan benefits under a Participating Flexible Benefits Plan, which consists of the following components: a Pre-tax Premium Option; a Health Care Flexible Spending Account Option; and a Dependent Care Flexible Spending Account Option.

The Plan is administered by Accenture (the "Administrator") on behalf of the Employers. For reporting purposes, the Plan is considered a Multiple Employer Plan because it includes a noncontrolled group participating employer, Avana, Inc. Each participating employer is responsible for its own contributions and plan assets are commingled for investment purposes.

The Plan (other than the Pre-tax Premium Option and the Dependent Care Flexible Spending Account Option) is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and the Consolidated Omnibus Budget Reconciliation Act and related Federal legislation known collectively as COBRA.

Benefits - The Plan generally provides the benefits described above to the following eligible classes of personnel (the "Participants"), subject to certain limitations as described in the Plan:

1. Regular full-time and regular part-time employees of Employers (other than Accenture Flex LLC (formerly, Agility Services LLC)) on the United States or Puerto Rico payroll and eligible dependents. Effective May 1, 2017, employees of Accenture Flex LLC who are regularly scheduled to work at least 20 hours per week are eligible for the Plan. Effective January 1, 2021, regular full-time and regular part-time employees of Employers (including Accenture Flex LLC) on the United States or Puerto Rico payroll and eligible dependents are eligible for the Plan.
2. Eligible personnel and their dependents that qualify under COBRA regulations.
3. Eligible dependents of deceased personnel who were on the United States or Puerto Rico payroll.
4. Eligible inpatient personnel and eligible dependents.

1. DESCRIPTION OF THE PLAN (Continued)

The Administrator determines eligibility requirements which are subject to change without the consent of the Participants.

Contributions - The Plan provides for Employer and Participant contributions as determined by the Employers. Contributions vary according to coverage selected and personnel classification.

Investment in the Accenture United States Benefit Trust - The investment in the Accenture United States Benefit Trust (the "Master Trust") represents the funded contributions to pay future medical, dental, and flexible benefit claims. Investments are stated at fair market value as determined by the trustee (Northern Trust Company) by reference to published market prices. The assets held in the Master Trust are invested in cash and cash equivalents.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements of the Plan are prepared on the accrual basis.

Payment of Benefits - Premiums paid by either Accenture or the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits and benefit obligations. Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as claims payable.

Administrative Expenses - The Plan's expenses are paid by either the Trust or Accenture, as provided by the plan documents. Certain expenses incurred in connection with the general administration of the plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the use of management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. BENEFIT OBLIGATIONS

The obligation and related reserve represent the amount of claims incurred, but not submitted, as of December 31, 2024. Claims can be submitted for payment up to twelve months following the date of service for medical and dental claims. Through May 31, 2025, Plan Year 2024 claims of \$880,171,755 have been submitted and paid.

Reimbursement Account Claims Reserve - The reserve represents funded contributions to pay claims incurred, but not submitted, as of December 31, 2024. As of July 31, 2025, plan year 2024 claims of \$20,037,663 have been submitted and paid.

4. PLAN TERMINATION

While Accenture has not expressed any intention to do so, Accenture has the right under the Plan to unilaterally modify or terminate the Plan, or any benefits provided thereunder, subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for, or on account of, the participants.

5. FORFEITURES

The Plan includes a Flexible Spending Account Option, which allows a participant to carry over, to the subsequent year, up to \$610 of unused funds. For participants who were active or on leave with Accenture as of December 31, 2024, unused 2024 funds automatically carried over into a 2025 FSA account. Unused amounts that cannot be carried over are forfeited and can be used to offset Plan expenses. During 2024, approximately \$350,000 was used to reduce Plan expenses. As of December 31, 2024, the amount remaining approximates \$555,000.

6. INCOME TAX STATUS

The Master Trust funding certain benefits of the Plan received an exemption letter from the IRS dated May 22, 2002, stating that the Master Trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the Master Trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and the Master Trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the Master Trust. The Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related Master Trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. INTEREST IN MASTER TRUST

The Plan's investments are in the Master Trust which was established for the investment assets of the Plan and several other Accenture-Sponsored health and welfare plans. Each plan has a divided interest in the net assets of the Master Trust as allocated in accordance with the plans' provisions. Assets are allocated among the plans by assigning to each plan those transactions (primarily contributions, benefit payments, and administrative expenses) which can be specifically identified. Investment income (loss) is allocated to the plans based upon their pro rata share in the allocated net assets of the Master Trust.

The Plan's interest in the net assets of the Master Trust totaled approximately \$104,091,000 and \$101,521,000 at December 31, 2024 and 2023, which was approximately 85% and 88% of the Master Trust's assets, respectively.

8. FAIR VALUE MEASUREMENTS

The Accounting Standards Codification (ASC) for Fair Value Measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the ASC are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Cash and Cash Equivalents: Valued daily at quoted market prices by Trustee.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.
