### **Opinion**

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 2, and for determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances.

Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Note 1. Description of the Plan**

The following description of the OneAmerica Agents' Association Welfare Benefits Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

**General**

The Plan was established April 1, 2019 as an employee welfare benefits plan for certain members of the OneAmerica Agents' Association, Inc. (Association or Sponsor). The Plan is intended to be an association health plan. In connection with the Plan, the Association established the OneAmerica Agents' Association Welfare Benefits Trust (Trust). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Board of Trustees consists of one OneAmerica Trustee and two General Agent Trustees. Capstone Administrators, LLC (Capstone) serves as the third-party administrator. During February 2024, Businessolver acquired Capstone, and has continued to serve as the third-party administrator.

**Benefits**

The Plan provides health (medical, dental, vision), life, disability, or other related benefits covering certain members of the Association and their employees, eligible dependents and designated beneficiaries. The Plan also provides continuation of certain benefits upon termination of employment through the *Consolidated Omnibus Budget Reconciliation Act* (COBRA). All benefits provided through the Plan are provided on a fully-insured basis.

**Contributions**

Participating members shall contribute premiums and costs to the Trust in amounts determined by the insurers for their respective benefit elections. Participants who elect coverage under one or more benefit options shall share in the premiums and costs, as determined by their employer. All contributions are due to the Trust on the 10<sup>th</sup> of each month. Other participant and employer contributions represent contributions from General Agents that have not provided an allocation of funds between those two categories of contributions.

**Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

**Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The Plan maintains its accounts on the basis of cash receipts and disbursements, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Consequently, certain revenue and the related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred.

**Use of Estimates**

The preparation of financial statements in conformity with cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

***Plan Tax Status***

The Trust, which holds the assets of the Plan, is a grantor trust subject to the regulations of Sections 671-677 of the Internal Revenue Code of 1986, as amended. Under these regulations, the grantor (the Association) is treated as the owner of the Trust for income tax purposes, and the taxable income of the Trust, including the deemed unrelated income of the Trust, is included in the taxable income of the grantor.

***Administrative Expenses***

The Plan is administered and managed by the Benefit Committee. The Benefit Committee has employed Businessolver to perform certain administrative duties for the Plan. Administrative expenses may be paid by the Association or the Plan, at the Association's discretion.

**Note 3. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons. The Sponsor and participating employers provide certain administrative services at no cost to the Plan.

The Plan incurs expenses related to general administration and recordkeeping. Life and disability benefits are fully insured by OneAmerica. Other benefits are fully insured by other providers. For the years ended March 31, 2025 and 2024, the Plan paid premiums and expenses as follows:
