We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with US GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued or are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of US GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplementary Information Required by ERISA

The supplementary information listed in the table of contents as of and for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplementary information, other than the information in the supplementary information that agrees to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplementary information related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1: Description of the Plan

The following description of The Variable Annuity Life Insurance Company Agents' and Managers' Retirement Plan (the "Plan") provides only general information. The Plan document provides a more complete description of the Plan's provisions.

General

The Plan, which is subject to certain provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), is a defined contribution plan which, prior to January 1, 2001, was offered to certain agents and managers, as defined in the Plan document, of The Variable Annuity Life Insurance Company ("VALIC") and VALIC Financial Advisors Inc., a wholly owned subsidiary of VALIC, who had completed at least thirty days of service. VALIC is a direct, wholly owned subsidiary of American General Life Insurance Company ("AGL") whose ultimate parent is Corebridge Financial, Inc. ("Corebridge Parent").

Effective January 1, 2001, the employment status of the individuals who were eligible to participate in the plan changed from independent contracting, statutory employees to common-law employees. As a result, they became eligible to participate in another plan sponsored by the Company and this Plan was frozen, meaning no new participant contributions were permitted to be made and no new employees were permitted to enroll in the Plan. As a result, participants become 100% vested in any previously made employer contributions. Effective December 24, 2009, the plan was amended to include provisions for the Pension Protection Act and Heart Act. Other provisions of the Plan remained unchanged. The provisions did not have a material impact on the Plan.

Contributions

Effective January 1, 2001, contributions are no longer permitted by the Plan. VALIC will make contributions as needed to fund benefits related to guaranteed minimum death benefits. No contributions were necessary for the year ended December 31, 2024.

With the consent of the Administrator, amounts may be transferred into this Plan provided the plan from which such funds are transferred permits the transfer to be made and the transfer will not jeopardize the tax-exempt status of the Plan or Trust or create adverse tax consequences for the Employer. Prior to accepting any transfers to which this Section applies, the Administrator may require an opinion of counsel that the amounts to be transferred meet the requirements of this section. The amounts transferred shall be set up in a separate account therein referred to as a "Participant's Transfer Account." Furthermore, for vesting purposes, the Participant's Transfer Account shall be treated as a separate "Participant's Account." During 2024 there were no amounts transferred into the Plan.

Participant Accounts

Participant accounts are credited with an allocation of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus the earnings thereon. Effective January 1, 2001 the participants became immediately 100% vested in VALIC's contributions made prior to January 1, 2001.

Policy Loans

Gross loan balances outstanding from VALIC to the Plan's participants were \$0 and \$0 as of December 31, 2024 and 2023 respectively. Policy loans are no longer allowed to participants of the Plan. All outstanding loan balances are in default. VALIC forecloses the defaulted loans when all restrictions are removed.

As such, approximately \$0 and \$0 of annuity account values as of December 31, 2024 and 2023 respectively, serves as collateral for the related loans, which are included in Loan Collateral Fund investments in the Plan's Statements of Net Assets Available for Benefits.

Distributions

Benefits are generally distributed upon separation of service due to death, disability, termination of employment or the attainment of early or normal retirement age. The vested portion of the account balance of a participant who terminates for some other reason is generally retained in the plan until retirement or the Participant requests distributions of the account. Benefits may be distributed directly to the participant if the vested account balance is less than \$1,000. Benefits may be rolled over to an Individual Retirement Account if the vested account balance is between \$1,000 and \$5,000. Benefits will be paid in the form of a lump sum or in various types of annuities.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments and Investment Income

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividend income is recorded on the date of record. Interest income is recorded when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net depreciation of fair value of investments.

Subsequent Events

The Company has evaluated subsequent events through the date these financial statements were issued and there were no subsequent events of note related to the Plan.

Note 3: Summary of Financial Information Certified by the Custodian

All investment information disclosed in the accompanying financial statements and supplementary information, including investments held at December 31, 2024 and 2023 and net depreciation in fair value of investments and investment income for the year ended December 31, 2024 was obtained or derived from information provided to Plan management and certified as complete and accurate by VALIC, the custodian of the Plan.

The Plan's investments consist of a deposit administration group annuity contract ("The Group Annuity Contract") issued by VALIC on a no-load basis. Within the Group Annuity Contract, participants have sixty-seven investment options: a Group Fixed Annuity Option and sixty-six investment sub-accounts within the Group Variable Annuity Option. The Plan's Group Variable Annuity Option is invested in a separate account and is stated at fair value primarily based on the net asset value of the underlying mutual fund.

As described in Accounting Standards Codification (ASC) 962, Plan Accounting-Defined Contribution Pension Plans, as updated by ASU 2015-12, investment contracts held by a defined contribution plan are required to be reported at contract value. The Plan's Group Fixed Annuity Option is invested in VALIC's general portfolio and is valued at contract value. Contract value represents contributions plus interest less withdrawals and expenses and there are no restrictions on when moneys can be withdrawn.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-off of a subsidiary) that cause significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption

under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 4: Fair Value Measurements

FASB *Accounting Standards Codification* ("ASC") 820 establishes a fair value hierarchy that distinguishes between assumptions based on market data from independent sources ("observable inputs") and a reporting entity's internal assumptions based upon the best information available when external market data is limited or unavailable ("unobservable inputs"). The fair value hierarchy in the guidance prioritizes inputs within three levels. Quoted prices in active markets have the highest priority ("Level 1") followed by observable inputs other than quoted prices ("Level 2") and unobservable inputs having the lowest priority ("Level 3"). The three levels of the fair value hierarchy under the guidance are as follows:

Level 1

Fair value measurements that are quoted prices (unadjusted) in active markets that the Company has the ability to access for identical assets or liabilities. Market price data generally is obtained from exchange or dealer markets. The Company does not adjust the quoted price for such instruments.

Level 2

Fair value measurements based on inputs other than quoted prices included in Level 1, that are observable for the asset or liability, either directly or indirectly. Level 2 inputs include quoted prices for similar assets and liabilities in active markets, and inputs other than quoted prices that are observable for the asset or liability, such as interest rates and yield curves that are observable at commonly quoted intervals.

Level 3

Fair value measurements based on valuation techniques that use significant inputs that are unobservable. Both observable and unobservable inputs may be used to determine the fair values of positions classified in Level 3. These measurements include circumstances in which there is little, if any, market activity for the asset or liability. Therefore, the Company must make certain assumptions as to the inputs a hypothetical market participant would use to value that asset or liability.

Valuation methodologies used for major investment types measured at fair value include:

Group Annuity Contracts, Separate Accounts: Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value.

Note 5: Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments are units of variable annuity funds managed by VALIC, the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

Note 6: Plan Termination

Although it has not expressed any intent to do so, VALIC has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

Note 7: Federal Income Taxes

The Plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the "Code") and, therefore, is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification.

GAAP requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.
