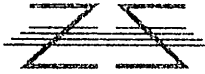

Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nederlander Productions 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Description of Plan

The following description of the Nederlander Productions 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering eligible employees, as defined in the Plan, of Nederlander Productions or any affiliate who has adopted the plan (collectively referred to as the "Company") who are at least 21 years of age and have completed three consecutive full calendar months of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was effective January 1, 2007. The Plan was amended and restated with an effective date of January 1, 2022, to comply with IRS requirements.

Contributions:

Under the terms of the Plan, participants may contribute up to 75% of pre-tax compensation or after-tax compensation (as a Roth annual deferral), as defined in the Plan, up to the limit in effect for the year (\$23,000 and \$22,500 in 2024 and 2023, respectively) as defined by the Internal Revenue Code ("IRC"). Participants aged 50 or older may make an additional "catch-up" contribution (up to \$7,500 in 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). For the year ended December 31, 2024, there were rollover contributions to the plan of \$16,922.

The Company may make discretionary profit-sharing and/or non-elective contributions to the Plan. Company profit-sharing contributions are allocated to participants who have completed 1,000 hours of service during the Plan year and are employed by the Company on the last day of the Plan year. For the year ended December 31, 2024, the Company made a discretionary profit-sharing contribution of \$151,053.

Participant accounts:

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and an allocation of Company discretionary contributions and Plan earnings and charged with withdrawals and allocation of Plan losses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options:

Participants direct their contributions into investments offered by the Plan which include money market accounts, mutual funds, pooled separate accounts and an unallocated insurance contract. Contributions are invested in each participant's account according to participant's selected allocation. Participants may change or transfer their investment options at any time.

Vesting:

Participants are immediately 100% vested in their voluntary contributions, rollover contributions and related earnings thereon. Vesting in the Company's profit-sharing contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. The vesting schedule is as follows:

Payment of benefits:

On termination of service from the Company and due to death, disability or normal retirement at age 65, a participant may elect to receive a lump sum amount equal to the value of the vested interest in his or her account or a monthly annuity. Hardship withdrawals are permitted.

Forfeited accounts:

Terminated participants' non-vested account balances shall be used to restore forfeitures, reduce Company contributions (or reallocate Company contributions), or to pay Plan expenses. As of December 31, 2024, there were 11 terminated participants still active in the Plan. These participants had a cumulative vested balance of \$490,575. The Plan had a forfeiture balance for the year ended December 31, 2024, of \$2,268.

Administrative expenses:

The Company absorbs most costs of the Plan (legal fees, audit fees, third party administration fees), however, the remaining costs are not deemed material to the financial statements presented. Investment fees and charges are absorbed by the Plan.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting:

The accompanying financial statements have been prepared using the accrual method of accounting.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of plan assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurement.

Purchase and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits:

Benefits to participants are recorded when paid.

Subsequent events:

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 10, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan administrator measures certain financial assets and liabilities at fair value in accordance with Accounting Standards Codification 820, Fair Value Measurement, which defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between willing market participants at the measurement date. The Plan administrator employs the market approach to measure fair value. The market approach uses prices or relevant information generated by market transactions involving identical or comparable assets or liabilities. In measuring fair value, the Plan administrator maximizes the use of quoted prices and observable inputs. A description of the fair value hierarchy is as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2 Inputs to the valuation methodology are quoted market prices for similar assets and liabilities in active markets, quoted prices in markets that are not active or inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the instrument.
- Level 3 Inputs to the valuation methodology are unobservable inputs based upon management's best estimates of inputs market participants could use in pricing the asset or liability at the measurement date, including the assumption of risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Group annuity contracts:

Group annuity contracts are stated at fair value by the liquidation value which is the market value of the assets in the separate account. The separate account is an investment option with a general investment account guarantee that provides a stated rate of return.

Mutual funds:

Mutual funds are valued at the quoted closing price in active markets in which the mutual funds are traded.

Note 4 – Plan Termination

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and Plan assets will be distributed based upon the participants' account balances at that time.

Note 5 – Federal Income Tax Status

The Plan is based upon a Volume Submitter Profit Sharing 401(k) Plan that received tax exempt status from the Internal Revenue Service on January 11, 2002. The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore, believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require that plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Plan administration believes it is no longer subject to income tax examinations for years prior to 2021.

Note 6 – Risk and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that change in the values of investments will occur in the near term and that such changes could materially affect amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 7 – Information Certified by Custodian (Unaudited)

The Plan administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under this provision of ERISA, investment information and related activity certified as complete and accurate by Voya Retirement Insurance and Annuity Company, a qualified institution, need not be subjected to an independent audit. The Plan administrator has obtained a certification from Voya Retirement Insurance and Annuity Company, as custodian of the Plan, that the following information included in the Plan's financial statements and supplemental schedule is complete and accurate:

- Investments as of December 31, 2024, and 2023
- Plan transactions related to investment income, securities transactions for the year ended December 31, 2024

Accordingly, at the request of the Plan administrator, the Plan's independent certified public accountants performed no procedures on investment information and related activity, other than to agree the information to the trust statements certified by Voya Retirement Insurance and Annuity Company and provided to them by the Plan administrator.

Note 8 – Party-in-Interest Transactions

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company, the custodian and a qualified institution of the Plan. Therefore, these investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management which are absorbed by the plan totaled \$37,485 for year ended December 31, 2024. The plan also paid administrative expenses to parties-in-interest totaling \$5,367 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 9 – Reconciliation of Financial Statements to Schedule H Form 5500

There are no adjustments to reconcile the investment balances and the related investment income and loss per the financial statements to form 5500 as of and for the year ended December 31, 2024.
